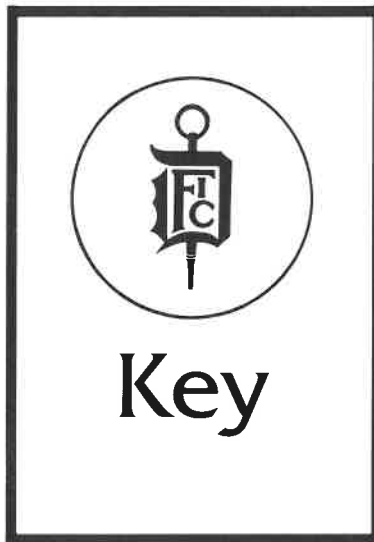

On the home front, final preparations have been made for the joint Section Continuing Education Conference to be held at Banff and Lake Louise and Jasper, Canada. Remember, it's "first come, first served" basis. You'll find details in the brochure that was mailed to you earlier.

We have to plan our hotel space at least three or four years ahead for our ICD functions. As of now, we are planning a Mini-convention (a training session for Officers, Regents, Vice Regents and Deputy Regents) in conjunction with our 1988 Continuing Education Conference. We are negotiating for hotel accommodations and meeting rooms in the Epcot area adjacent to Disney World in Orlando, Florida. There is a possibility that the American Association of Dental Editors will also hold their meeting in conjunction with ours. If all of this comes to pass, we will have one large meeting! I promise you excellent facilities as well as a wonderful place for you and your family to spend some time together.

In the future (May of 1988) the Executive Council of the College will meet in Sydney, Australia. I have been asked to plan taking a group of Fellows to meet with the Australasian Fellows. I would be interested in your input in planning such a visitation. Would stopping in Papeete or Fiji and New Zealand interest you?

Again on the home front, the American Dental Association is once more trying to move our convocation and banquet dates. I am opposed to changing our functions from Saturday to Friday. We get the same rationalization that changed our previous days from Sunday to Saturday. We have tried to prevent fractionalism but these latest tactics do much to encourage us to take a second look at holding our annual meeting elsewhere. It's time for the ADA to recognize that its Colleges are truly magnets that bring added prestige and registration to its annual meeting.

President USA Section



William E. Hawkins

As we enter the 59th year since the International College of Dentists was formed by Dr. Ottofy and Dr. Okumura on July 9, 1928, and incorporated under the laws of the District of Columbia, the membership is over 7,000. The USA Section has over 3,600 members and sponsors programs of Educational Conferences, provides financial aid to dental students, presents recognition awards to outstanding senior dental students throughout the country, honors dental editors through the journalism awards presentations, maintains an archive of videotapes of dental leaders of the past and present, aids recent graduates and senior dental students with a big brother program in locating their practices in a community, and many other projects.

The ideals of the College are to cultivate and foster cordial relations among those engaging in the practice of dentistry and medicine in all parts of the world. The USA Section has as one of its projects the financial support of the *Journal of Dental Research*, the official publication of the International Association for Dental Research, and the Divisional Abstracts issue carries our Key on its cover.

To further the efforts of the Section to build a solid base for the educational conferences, the International College of Dentists USA Section Foundation became a reality on January 22, 1986. The Foundation has already begun to receive donations and held its first annual meeting in Miami on October 17, 1986 and elected Fellow Thomas E. Emmering as its first president and Fellow Lloyd J. Phillips as vice president with Fellow George D. Selfridge as secretary-treasurer. Fellows Herbert K. Yee, Richard C. Rice, and Donald O. Erickson are the trustees.

Once again let me remind you that you are a member of a world-wide organization and each Section is sponsoring similar projects in their Sections. It is especially important at this time that we reconfirm our dedication to fostering the growth and diffusion of dental knowledge and establishing and maintaining a high standard of competency and character for dental practitioners.

As the nature of all health delivery is undergoing extensive change, our goal as members of the college is to sustain the dignity of our profession in its relationship with the patient and attempt to secure a higher appreciation of the aims of the dental profession. We will need to help and guide the profession during this revolution in the delivery systems of health care. We must educate patients, employers, third-party insurers and the state and federal health agencies that dental health is a major part of health care and should not be treated as a loss leader for medical insurance programs or HMO organizations.

To accomplish this it will be necessary for each of us to familiarize ourselves with alternative methods of health delivery so we may enter into the negotiations and become a viable force in shaping dentistry's future. If we ignore these forces in the health fields, they will be able to completely dominate the professions. Even though it may seem useless at times, each time we offer our input it will be worth the effort. In time we will be able to accomplish solutions that will be beneficial to all parties.

As in the past, the Fellows of the College are a link of Fellowship around the world to tie nations together on a non-political basis. When I have traveled throughout the world, I found deep feelings of true friendship from Europe to China and to the tip of South America when the Fellows of College gather together. This is a bond of professional knowledge combined with the goals and purpose of the College. We are the guardians of the College past, present and future. Let us remember that each of us who becomes a Fellow in the International College of Dentists, no matter what part of the world we live in, is selected for the honor they do the College.

Each Fellow is fully aware of the honor implicit in their College Key. We come together not as strangers into this organization and it is my wish that we communicate freely with each other now and in the future.

The USA Section is dynamic and moving forward in many areas because of the individuals who are our members. I would like, during my term of office, to hear from each of you on what your ideas and goals are for the Section, College and dentistry. Only with your input can the leadership of the Section and College know the desires of the membership and act upon them. I wish you well in all things.

USA Section Board of Regents Meeting



ACTIONS OF THE BOARD

The Board of Regents met in Miami October 17, 1986. President Peters conducted the meeting which was attended by the officers, representatives from each Regent District, several officers from the College and guests.

Highlights of the meeting included the Registrar's report. Vice President Sapp reported on the final evaluation of the Deputy Regents' Survey conducted in 1985. He stressed the need for greater involvement and communication with the Deputy Regent. Treasurer John Reifke and Finance Chairman William Hopkins reported that the Section was in excellent financial condition.

There were reports from each Regency summarizing the past years activities and including special concerns and suggestions. All Regencies were represented.

Chairman Hopkins reported on the Section's pioneering and invaluable audiovisual project. This project will record many of the profession's outstanding dentists. It is currently the only project of its kind and of immeasurable historical value.

The Board decided to appoint Past President Harold Eberhardt as USA Section Archivist/Historian to gather and preserve the increasing historical materials of the Section. It was felt that the job was too demanding for the Registrar alone, even though the Registrar is the Historian under the Section By-laws. Continuing Education Chairman George Selfridge reported on our extremely successful Conference IV, held in Williamsburg, Va and the upcoming Conference V which will be held in Banff, Jasper and Lake Louise in cooperation with the Canadian Section in July 1987.

ICD Foundation President Thomas Emmering reported on the newly formed foundation. The Foundation is technically a completely separate entity that has Continuing Education as its primary purpose. Every member of the ICD is also a member of the Foundation. The Foundation is able and anxious to accept your tax-deductible donations.

In other actions, USA Section Past President, Executive Councilman and incoming College Vice President, Paul H. Loflin, was elected to the status of Master. The Board authorized a booklet of the history and bylaws of the section. The budget was approved and the Board recommended that each constituent contribute \$100 to the new ICD Foundation. The new slate of 1987 officers was presented and elected and will be headed by President William E. Hawkins. The meeting was adjourned.

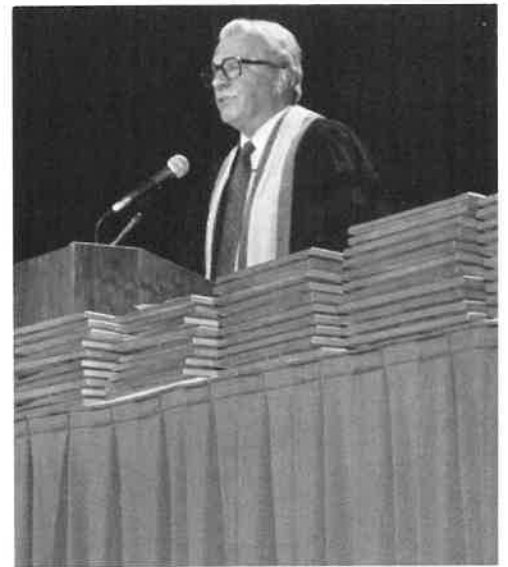

A Good Foundation

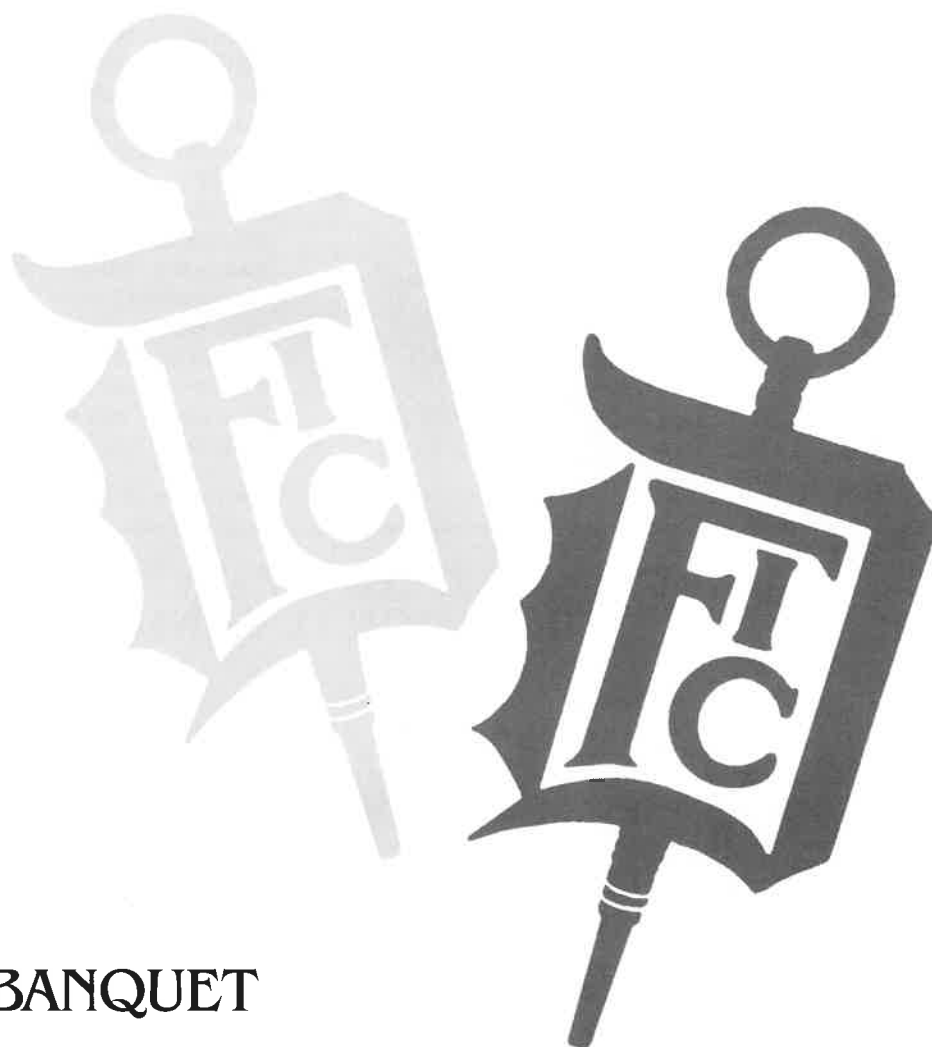
The college now has its own foundation. The International College of Dentists USA Section Foundation, Inc., became a corporation organized under the laws of the State of Florida on January 22, 1986.

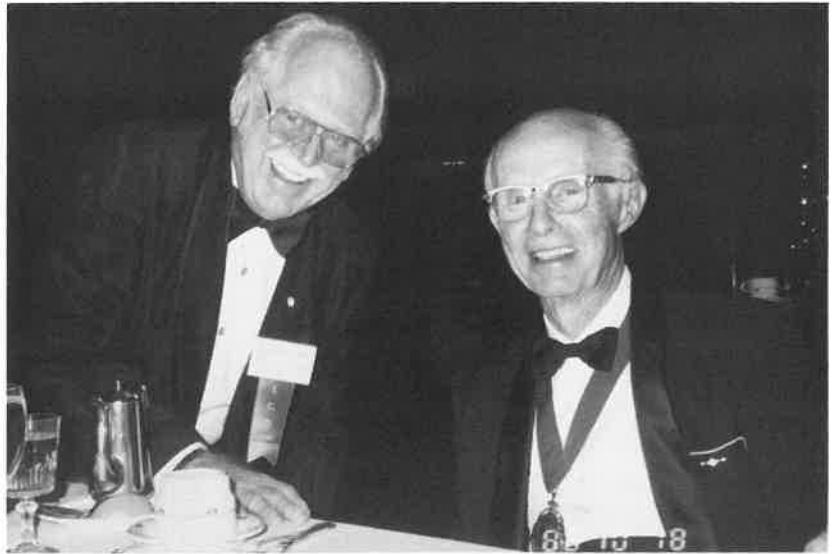

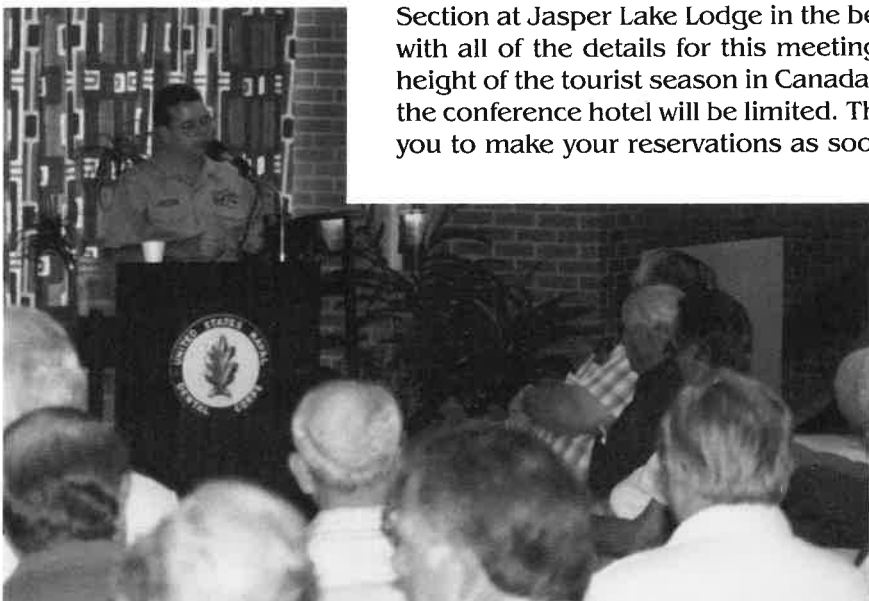
ICD Educational Conferences

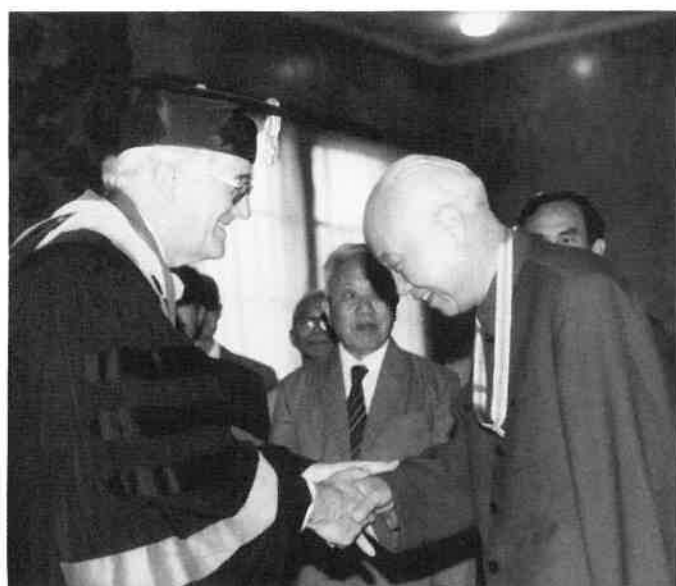
