“Big bang for the buck”

Our projects had their start in 1961 when our USA Section had accumulated sufficient reserve funds to enable us to embark on USA Section projects proposed by our visionary leaders. Proposed projects to benefit the Section's membership, the College, the profession and the dental health of all people were studied to determine their purpose and financial feasibility.

From a modest three projects our projects have grown to 12 viable and meaningful projects. You, as a member, are a part of the projects and are urged to support and participate where possible.

CONTINUING EDUCATION & THE USA SECTION FOUNDATION

Continuing Education is the primary outgrowth of the Foundation. The Foundation was established in 1989 to provide resources for educational and professional needs of ICD. The Foundation funds are supported by gifts from members, Section districts and memorials. The education conference, our Foundation's major project, is tuition free to all members. Other projects may be developed in the future. The 1993 Conference will be in Buffalo, New York, July 22-25.

SENIOR DENTAL STUDENT AWARD

Our Regents and Deputy Regents award recognizes the senior student who has shown exemplary student achievement and academic and professional

development during the years as a student of dentistry. Chosen by their faculty, the student is given a plaque from the College.

CAREER OPTIONS IN DENTISTRY

Co-sponsored by the Council on Faculties American Association of Dental Schools this seminar conveys the message of a career in dentistry and provides an opportunity for all the nation's junior and senior students to become acquainted with the various career options such as advanced training research, the military, academics, clinical practice, Public Health and hospital settings available after graduation. These seminars, held every two years in different localities throughout the country, supplement and compliment the ADA program. This has been a very successful Seminar with over 300 students attending the most recent seminar in Chicago, IL. The 1992 Seminar will be held in Texas. Each district is encouraged to send one or two students from each of the dental schools. Their transportation, lodging and meals are paid by the College.

PROJECT ACT (ASSISTANCE COUNSELING IN TRANSITION)

This College project has three acts. In Act I (the student) ACT committees are formed for each dental school in the district. The project is explained to the school, a list of senior students is obtained and letters of project information is

given to each student. ICD members in each district are asked to sponsor and host one student to a local society meeting. An attempt is made to obtain the student's concerns and to offer counselling. Act II (the transition) - upon obtaining the plans and future location of senior students, Fellows in that locale are contacted and urged to welcome the new dentist by inviting the graduate (and wife) to a get-acquainted dinner or function. Act III (the district) - offer and communicate your friendship and be helpful when called upon. Discuss the benefits of organized dentistry and encourage them to become active in the dental society. Refer patients when possible and remain interested and involved with the new dentist. The projects success depends on a “one on one” basis.

INTERNATIONAL STUDENT EXCHANGE

This project was initiated in 1990 to improve and increase international relations at the student level by providing a professional and cultural exchange between dental schools in the USA and in other countries. The objective is to experience and study dental education and dental delivery systems to better appreciate the dental culture internationally. The program provides an excellent opportunity for a USA junior dental student to travel and spend three weeks in a pre-selected foreign dental teaching facility. A student from the foreign dental school

Every Fellow should be proud of our accomplishments

I bring greetings to all ICD Fellows in the United States. It is an honor and privilege to serve as your President for 1992. Since I am writing to you in August, the year is at midpoint and I have been involved with the membership through a number of meetings throughout this great country.

I represented the USA Section by attending a workshop of the Pennsylvania Dental Association in Hershey, PA last November, then I went to the Greater New York Dental Meeting and met with the Fellows of that Constituency in early December. I represented the College at the meeting of the American Association of Dental Schools in Dallas in December and followed that with the Yankee Dental Congress and a meeting of the Fellows of the 1st District in Boston in January. I spoke to the 8th District Fellows in Chicago at the Mid Winter Meeting and was the speaker at the Hinman Meeting in March of the combined American College, Pierre Fauchard and International College groups. I met with the Michigan Fellows in April in Detroit and the Indiana Fellows in May in Indianapolis. I attended and represented the USA Section as President and International Councilman to the International Council Meeting in Vilamoura, Portugal in June and attended our USA Board of Regents Meeting in San Diego on July 8 along with a highly successful Continuing Education Course.

Everywhere I have gone the

hospitality, friendliness and graciousness of the Fellows has been wonderful. It couldn't be better. I have been talking about the aims and goals of the USA Section and attempting to answer the question of the prospective Fellow whom you are inviting into Fellowship—Why shouldn't I belong to the International College of Dentistry? Every member of our organization should be able to answer that question. Only by knowing what the USA Section does, what its projects are, are you able to tell anyone why they should belong.

Let me list some of our projects:

9. International Student Exchange Program - 3rd year
10. International Clinicians Program - 20th year

Every Fellow should be proud of our accomplishments. I have been emphasizing the International Student Exchange Program because it involves the local members, especially those in close proximity to the dental schools.

Involvement locally gives meaning to membership and what you give is returned many fold. You should read the letters of those students involved and the value of the program is so obvious. This program should involve every dental school in the country and the Fellow in that area. Do it and be involved.

Guidelines for Screening Committees was another one of many goals. They were presented in draft form in July at San Diego. Every Regency and Constituency needs to operate their screening committees more efficiently and effectively so we no longer allow qualified dentists to "fall through the crack" and not be invited into Fellowship or discover them at age 75. The guidelines will be a method, if used, of preventing that.

We are doing better, the average age of the incoming class is 50.8 years. We increased the size from 200 to 270 for this year and in future years and that was a necessary step to allow more qualified dentists to become Fellows.

We have a dedicated staff in Rockville, MD. Dick and Florence do a magnificent job. The Board of Regents is made up of very capable and dedicated people. The Section is alive and well. I continue to work with the Board and be a leader in fine tuning the operation of a great organization of which I am very proud both to be a member and your President.

Dr. Lloyd J. Phillips—a proven leader

Dr. Lloyd J. Phillips was elevated to the office of President of the International College of Dentists, USA Section, at the annual meeting of the College in Seattle, WA, October 4, 1991.

Dr. Phillips has served in roles of leadership in dentistry on both state and national levels. He served the Indiana Dental Association as representative to the Indiana Health Council (President 1970-71); co-chaired and member of Blue Cross & Blue Shield Advisory Committee; the Association's Special Committee on Retirement Programs; member of Prepayment Committee; Endowment Committee; Ad Hoc Committee on Fragmentation; Chairman of the Central Office Steering Committee for 14 years; served as the Association's Secretary for 6 years; was delegate to the ADA House of Delegates for 10 years and lead through the offices of the IDA to serve as its President 1979-80.

He was a member of the ADA Reference Committee on Dental

Research and Therapeutics in 1969; Chaired the ADA Reference Committee on Miscellaneous Business in 1970; was a Trustee from the 7th Trustee District 1970-76; and a member and Chairman of the ADA's PEP Committee in 1979-81.

Dr. Phillips was a graduate of Indiana University with high honors in 1951 and received his dental degree from the Indiana University School of Dentistry with high honors in 1954, earning the Alpha Omega Award as #1 in scholastic standing in four years of dental school and served his school as Assistant Professor in Periodontics from 1955 to 1976. He co-authored several articles on thermal conductivity of dental cements while serving on the faculty.

He was on active duty with the U.S. Navy from 1942-46 and served in the USNR until 1955.

Dr. Phillips was named Distinguished Alumnus of the Year by the IU Dental Alumni Association in 1976; received the Sagamore of Wabash from Governor of Indiana Otis Bowen in 1977 and in that year the Mayor of Indianapolis declared a

"Lloyd J. Phillips Day."

He holds membership in Omicron Kappa Upsilon, the American Academy of Periodontology, the Academy of Operative Dentistry, American Prosthodontic Society, International Association for Dental Research, Pierre Fauchard Academy, American College of Dentists and Psi Omega Fraternity.

His service is not limited to dentistry. He is also a member and serves in the Rotary Club of Indiana, the Meridian Street United Methodist Church, the Indianapolis Chamber of Commerce, the Athletic Club, Masonic Lodge No. 105 AF & AM and the Indiana Division of the American Cancer Society.

Lloyd and wife, Barbara Jean, are parents of Paula, a dental hygienist; Timothy, a dentist and Cathy Sue.

A leader in his community and profession, Lloyd still finds time to indulge in his hobbies of squash, golf, bowling, genealogy and bridge (social and duplicate).

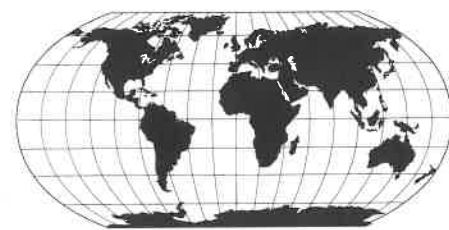

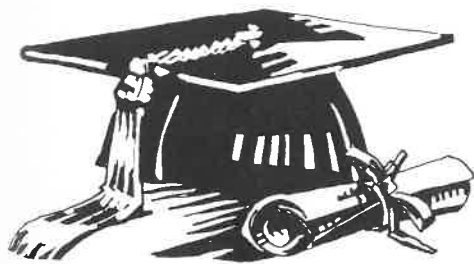
International Student Exchange is a showcase project



Educational sharing improves relationships between countries

The object of the International Student Exchange Program is to share knowledge, experience, environment and to observe the educational process in other parts of the world. The relationship between countries is improved when the College becomes involved in this project.

The working process is not complicated. It begins with the constituent selecting a three to five member committee of Fellows to organize, consult and assist with the exchange. The committee works with the Dean of the dental school to assist in providing a three week program of clinic and hospital visits, office visits, lectures, social events and recreation. The committee also assists in obtaining housing and providing out of pocket student expense. Publicity for the program is a desired element. Oversight would also include coordinating liability exclusions.



The Dean of the dental school bears the major responsibility of selecting the student with the proper criteria. The individuals chosen should be junior students ranking in the upper half of their class, willing and enthusiastic for active participation. He/she should possess an outgoing personality with poise, language proficiency, afford the time to travel and have the ability to be a good will ambassador for our country.

The Dean is also the one to contact the Dean of the foreign school to familiarize him with the program and to gain his participation. He also works with the Dean to obtain housing, assists him in scheduling and asks that Dean to provide liability exclusion prior to the visit. The student's Dean will provide a forum for him/her to make a post trip presentation.

The student must indicate a willingness to participate and must be able to provide partial expenses that are not covered by the program. An understanding of the school environs of other countries would be desirable. The host of the visiting student would assist the local committee and Dean. Fi-

nally, the student will make a written report of his experience to the Constituent and Projects Committees.

The USA Section's responsibilities are to provide approval of annual funding for the program, provide round-trip excursion coach air fare for the exchange student and \$150 expense money for each student, approve protocol and oversight, review the program annually for its worthiness, and assists in liability exclusion for the Section. The Section would also keep the International Council up to date on progress of the program and encourage all Sections to participate.

Finally, all available media should be used to publicize the interchange. Program exposure should be highlighted in Keynotes, KEY and Globe.

This is a very important project that contains many benefits and should be embraced by many constituents. If you are not participating, now is the time to become active in a show case program.

Your Foundation for the advancement of educational, scientific, and charitable dental programs succeeds with your generous support. Our grateful thanks—from your trustees.

Our Foundation has grown without major fund raising campaigns or the solicitation of large gifts and pledges. It has grown through the steady and generous contributions from its members.

In 1990 President Thomas Emmering appointed a Special Ad Hoc Committee made up of Lloyd Phillips, Herbert Yee, and Baxter Sapp, Chairman, to study the feasibility of conducting an in house fund drive to develop an adequate base of financial resources to support the purposes for which the Foundation was created. The Committee agreed that the \$10 contribution to the Foundation on the dues statement was not adequate for the Foundation needs and agreed that a fund drive to be appropriate. All members felt the idea of contributing the fee for one dental procedure form our Section's membership to be a sound objective. A survey of a small, cross section, random segment of our membership seemed appropriate and important. The results of this survey of 156 members were:

Do you approve of our Sections Continuing Education Program?

Yes - 86% No - 10% NR - 4%

Are you in favor of a fund drive to support worthy projects, scientific dental research, and continuing education for graduate dentists?

Yes - 76% No - 14% NR - 9%

Do you support the concept of contributing the fee from one dental procedure of your choice to the Foundation and do you think it to be an appropriate idea?

Yes - 71% No - 11% NR - 9%

This survey gave the Trustees confidence in proposing a request to our Life Members who are long time members, retired, and do not pay dues. There were two mailings to 1044 Life members from August to November 1991 and as of January 14, 1992 140 of those Life Members had contributed \$9,919. Their response was most important to the Foundation posting a 21% increase in its assets for 1991. The Trustees are most grateful for their most generous response.

Our most capable Foundation Secretary, Don Johnson, reported financial assets of \$95,000 in April and provided a benefactor who would give \$1,000 if our assets reached \$99,000 by July 1st. This became the "140 DOLLAR CHALLENGE" to the officers and trustees of the Foundation and to the officers and Regents of our Section. As of July 1st the Foundation Assets had reached over \$100,000.

President Lloyd Phillips has adopted as his theme this year, "The College Reaching its Potential." His was the first 140 received for the "140 Dollar Challenge" and he has shown outstanding dedication and commitment to the purposes of the Foundation as have the other officers and Regents of our Section. It is through your support our members that the Foundation is reaching its potential in its service

to our profession. In July our 10th FREE Continuing Education Program was held in San Diego which was totally supported for the first time by the Foundation.

It is my sincere hope that this report will generate a concern and interest in your Foundation activities that I might hear from you and that you will find time to attend the Annual Foundation meeting at 11:00 a.m., Orlando, FL, the Hilton Hotel, October 16th, the Grand Ballroom. There will be a report on the activities of the past year and an opportunity to address and meet your Trustees.

The Trustees and officers wish to thank the central office staff for their efforts in making our job so easy.

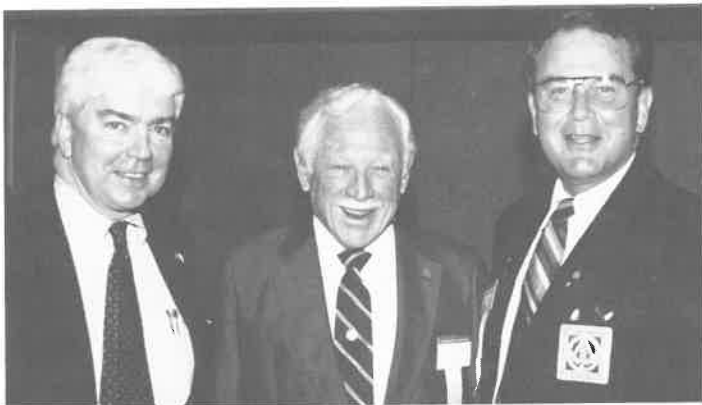

W. Keith Morgan, Sr., enjoyed a successful year as president of the NC Dental Society.

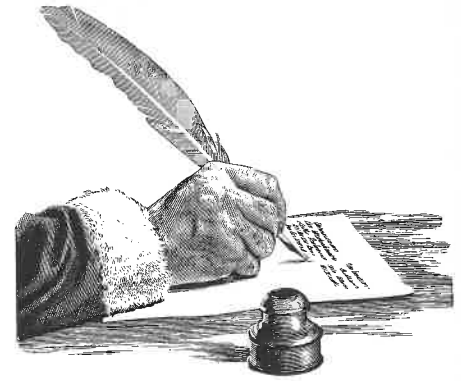

would then return the visit to the USA. This has been a very popular project. Additional opportunities are available.

INTERNATIONAL CLINICIANS PROGRAM

Academic interchange is the purpose of this project. The objective is to exchange scholarly lecturers to share professional knowledge between the USA and other countries. The host country supplies the cost of housing, meals, etc., while the clinician is there. Although in its 20th year this project is underutilized and under-financed. The most recent program involvement was Dr. Jose Medina to Argentina.

PROJECT OUTREACH

The original outreach distributed over 5000 educational materials to the libraries of the dental colleges in the Philippines. The program promotes the collection of books, periodicals and journals at a central repository until there is a sufficient quantity to ship to a specific area. Requests from Sections or countries are reviewed and the final distribution in that area is verified before shipping. This project is under constant review.

LEADERS IN DENTISTRY

The International College of Dentists present a VHS video taped series by outstanding leaders in dentistry reviewing their accomplishments and presenting their views on the dental profession.

Clinicians, practitioners, researchers, and educators who have contributed significantly to the profession of dentistry are recognized in these videotapes. Important

events in their lives provide human interest aspects with historical value. The videotapes include why they chose dentistry as a career, the factors that influenced the character and timing of their contributions, their views of dentistry's past and future from their own historical perspective.

Outstanding Leaders in Dentistry videotapes are intended for use by professional associations, dental schools, libraries, and those who have a personal interest in the profession of dentistry.

This historical record can compliment dental school and continuing educational courses or be used as presentations at professional meetings. Some of the 20 subjects interviewed are no longer with us. Tapes are available for purchase for schools, constituents, educational programs or presentation at professional meetings.

DENTAL JOURNALISM AWARDS

Held annually this program recognizes and awards outstanding dental journalism by editors in and out of the dental profession.

In its 21st year these awards encourage improvement in content, coverage, format and quality. The four categories in the awards are: Golden Scroll for showing the most improvement during the year in content and format; Golden Pen for the most outstanding article or feature; Golden Pencil for the most creative and effective use of illustrations or other graphic arts; and Special Citation for presenting an unusual treatment. There are two divisions in each category for large and small to medium budgets and honorable mentions in each category. Golden Publication is the award for the best overall dental publication. All aspects of the

other categories will be considered in judging for this award.

DENTAL JOURNALISM SEMINAR

The College jointly sponsors with the ADA and the AADE this seminar that provides an insight for participants in writing, editing, management, computer publishing and other phases of journalism. The Seminar is a motivating force for improved dental publications.

KEY

For over 50 years the KEY has been the annual publication of the ICD USA Section. The journal/magazine presents a variety of offerings on future continuing education programs, announcements of coming convocations, messages from our leaders, feature articles, a report of the preceding convocation, listing of new members, reports of prior educational conferences, district reports and other information.
