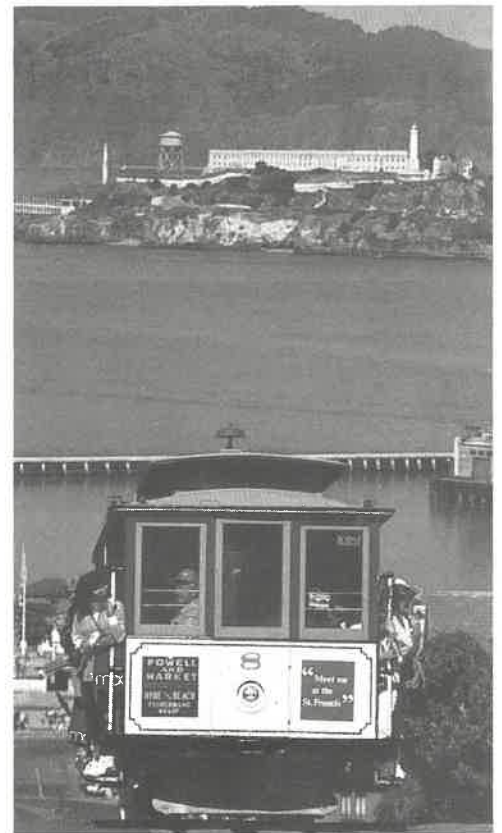

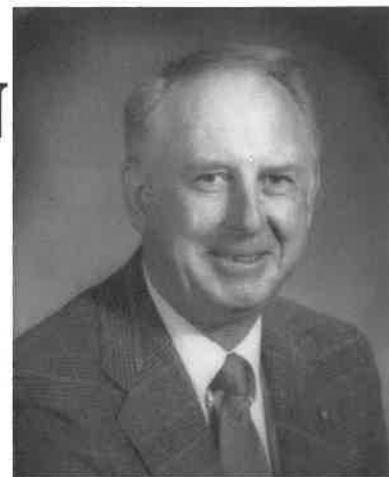

Dr. Lon D. Carroll was elevated to the office of President of the International College of Dentists, USA Section, at the annual meeting of the College in Orlando, FL October 1992.

Dr. Carroll has served in roles of leadership in dentistry on both the local and international levels. He was a delegate to the Oregon Dental Association 1962-84, Board of Trustees, 1970-78, Member Dental Care Council, 1971-74, Chairman Dental Health Education Committee, 1971-72, President Multnomah County Dental Society 1974-75, Chairman Peer Review Committee, 1974-75, Member Board of Directors Oregon Unit Academy of General Dentistry and its Editor 1982-84, Member Board of Directors Oregon Dental Service 1975-82, Chairman Annual Giving Fund Alumni Association University of Oregon Dental School and President of the Alumni Association 1978-79, President Council of Graduate Chapters Delta Sigma Delta 1975-76, Oregon Representative Delta Sigma

Delta 1967-82, Member Executive Committee Oregon Dental Association 1978-81, Editor Oregon Dental Association 1978-81, Liaison Oregon Dental Hygienists Association from the Oregon Dental Association 1981-84.

He served as Deputy Regent Oregon Unit of the International College 1978-81, Vice Regent in 1982-87 and Regent 11th District 1987-90. He was Supreme Grand Master of Delta Sigma Delta International Dental Fraternity 1983-84, Supreme Historian (Editor) Delta Sigma Delta 1983-84, was named "Oregon General Dentists of the Year 1985" by the Oregon Academy of General Dentistry, Chairman Oregon Section Pierre Fauchard Academy 1988-93.

Dr. Carroll attended Eastern Oregon State College for his pre-dental education and received his dental degree from the University of Oregon Dental School in 1961. Served as part-time Assistant Professor Crown & Bridge Department, University of Oregon Dental School 1961-63.

He was on active duty with the United States Air Force 1954-57 and served in the US Naval Reserve from 1967-89, retiring as Captain in 1989.

He is a Fellow of the American College of Dentists, Pierre Fauchard Academy and holds both Fellowship and his Mastership in the Academy of General Dentistry. Member of the Academy of Dentistry for Children, Delta Sigma Delta. He is also listed in "Who's Who in the West."

He has also served as President of the Wildlife Development Association of Oregon 1982-92, Member Gresham Elks Lodge 1805, Chairman United Good Neighbors Association, has coached Babe Ruth Baseball and Girls Little League Softball and served as Assistant Scoutmaster.

Lon and his wife Linda are parents of Denise, Brian, Suzanne and Stacie and have eight grandchildren. He avidly pursues his hobbies of hunting, fishing and golf.

RICHARD C. RICE IS 1994 PRESIDENT OF THE INTERNATIONAL COLLEGE OF DENTISTS

A dedicated Fellow is to lead us

Dentistry played an early role in the life of Richard C. Rice. Dentistry still plays a vital role in the life of this energetic, dedicated man of proven leadership. Commitment has been an important trait in the life-time of this dental leader. This trait is most evident in his association with the International College.

For Dick, dentistry was an ever present influence coming from his father. His father, Richard M. Rice was the owner of Rice Dental Laboratory in the Northeast area of Ohio. Several practicing dentists, specifically one who was a past ICD Vice Regent of District 7, also contributed to this influence. In turn, Dick has had a great influence on three young people joining our profession as dentists and five to become dental hygienists.

A life-long resident of Cleveland,

Dick graduated from Cleveland's Shaw High in 1940 and then attended Allegheny College in Pennsylvania for two years. He was on the swimming team while there and was a member of Phi Kappa Psi Fraternity. Like many Fellows, WWII interrupted his quest for an education.

Dick served in the U.S. Navy in the Pacific and Caribbean theaters of action and, after four years of service, was discharged as a Pharmacist Mate First Class.

Following his discharge, Dick resumed his efforts in education by enrolling in Adelbert College where he earned his Bachelor of Science degree. Seeing his goal in sight he entered Case Western Reserve Dental School. He joined Psi Omega Fraternity and perhaps for the first time, his leadership ability became apparent by serving as president of the undergraduate chapter.

He has continued his leadership role with his fraternity up to the present by serving as treasurer of the Psi Omega House Company and as an active member in the "51" and Heights Study Clubs. His dream became a reality when he stepped forward and received his dental degree in 1951.

This was only the beginning. The facets of his character, a strong work ethic, goals orientation, a "take charge" attitude and productive contributions comprise the basis of solid leadership ability. He has a "bull-dog" tenacity to get things done. Dick has displayed his leadership in both professional affiliations and in dental education with an attitude that membership in an organization means that the organization's

welfare comes first.

He is an active and vital member of the Cleveland Dental Society, having served as President in 1971, for an extended term on the Board of Directors, and as Chairman of numerous committees, including Children's Dental Health Day, the Council on Dental Health Education, and the Public Information Committee. Additional service to the Society was through the Dental Economics and Suburban Dental Health Committees, and as a delegate to the Ohio Dental Association.

In 1953, along with Dr. Paul Aufderheide (a Past-President of the USA Section), he helped found the Dental Clinic at Highland View Hospital, where he has served on the staff for over 28 years. He also has served on the staff of the Metropolitan General Hospital. The present staff of nine general practitioners, seven full-time and six part-time faculty has three who are consultants for the ADA.

Dick's commitment to dental education has been proven in professional, collegiate and public settings. He taught Dental Anatomy at the dental school and was an Assistant Clinical Professor of Periodontics. In addition, his zeal to educate the public in dentistry led to the third and sixth grade dental educational four part series on television, which he conceived and

produced in conjunction with WVIZ. This series was used for many years in all the Cleveland Elementary Schools.

Among Dick's many honors are the Distinguished Service Award of the Cleveland Dental Society in 1980, the Ohio Dental Association's Achievement Award in 1982 and the CWRU Dental School Dental Alumnus Award in 1986. He has been a very effective fund raiser for that school. The ODA has named

Dick the recipient of its Distinguished Dentist Award for 1993 to be presented during its annual session in Spetember.

Dick's best role of leadership to us has been his very significant contribution to the ICD. He has served the USA Section for many years as Vice Regent and Regent of District Seven, chairman

of the Finance Committee and as a member of the Membership Evaluation Committee. An important, for him, has been the Foreign Student Exchange Project. It has been said, "Dick was really the guiding influence in the development of this project. Now in its fourth year, without his perserverance the project would not have succeeded." In 1983 he served as president of the USA Section. Since that time he has served as International Councilman and will become our International president in San Francisco.

His involvement in organization leadership doesn't stop with dentistry. Hi is Life Elder in the Euclid Avenue Christian Church where he is past chair of the Elder Committee and the Diaconate. He and Lois have taught ir. Sunday School and have served on many committees. Dick is also a member of Kindermere Masonic Lodge and active in the YMCA Fund Drive.

Before knee replacement Dick enjoyed playing tennis and was a member of the Cleveland Skating Club. Another sport he enjoyed before the operation, and can continue, is the sport played in the winter season - Curling. He and Lois are really not amateurs having been Bonspiel Champions.

Gardening is, perhaps, his favorite hobby. Having nearly an acre to tend is almost a farm. Tending this medium size vegetable and berry (raspberry and blueberry) garden plus a perennial flower garden consumes much of Dick's and Lois's time. Their love of gardening extends beyond his property where he cleared some adjacent YMCA land and made a garden of it with rhododendrons and other shrubs and flowers.

A unique side of Dick is his great love for cats and will go to great lengths to be kind to cats! A story a friend tells is that some strays made their home in Dick's tool shed. He cared enough for these strays that during the winter months when Lois and Dick visited Florida, Dick hired someone to continue to care for the cats.

MASTER OF THE COLLEGE TO BE CONFERRED ON ROBERT S. STUBBS

A tribute given for devotion to duty

No one member of USA Section of ICD can surpass, or even equal, the dedication and effort of Robert S. Stubbs to the International College of Dentists. Since 1975 Bob Stubbs has faithfully discharged his duties as Chairman of the Convocation and Banquet Committee.

Bob Stubbs is a tireless, committee worker that spends hours, days in advance planning for the BIG day. This involves extensive communication with the local arrangements person, on site visitations to view the facilities, meetings with hotel and banquet persons along with coordinating things with Richard Shaffer in the Central Office leading to busy days and months ahead of the convocation and banquet. A stickler for details, Bob makes things work; there has never been a "hitch" or trouble in his 18 years of service.

Arriving three days in advance of the Convocation the committee, chaired by Bob Stubbs, makes a final check of the convocation site and facilities, unpack and prepares the robes and ready everything for the convocation, induction and banquet. The day following is spent re-packing for shipment and storage.

Bob's college days were interrupted

by WWII when he volunteered for aviation cadet training in the U.S. Army Air Corps. He served as pilot with the 9th Air Force in England and France flying 65 combat missions and receiving the Air Medal with two silver and two bronze clusters and the Purple Heart. He returned from combat and was assigned to Dodge City, KS as an instructor in Martin B26 Marauders.

Following discharge, he returned to the University of Georgia and on to Emory University School of Dentistry to receive his dental degree. He then joined his brother in his dental practice in Miami, FL.

Bob has served as president of the Greater Miami Dental Society and as delegate to the Florida House of Delegates for several years. He serves on the Advisory Committee to the Dental Hygiene School of the Dade County Community College and is an active participant in the Dade County Dental Research Clinic at the Lindsey Hopkins Vocational School. He has served as Deputy Regent and Treasurer of the Florida Chapter of ICD.

Bob and Nancy have a son, Robert, Jr.; a daughter, Dorothy, and are proud grandparents of two grandchildren. When they are not involved in their

many responsibilities they relax with deep sea fishing.

Bob also enjoys wood working and coin collecting. Since Hurricane Andrew he has spent much of his available time in doing repair work to his home that was damaged extensively by the colossal winds.

The College is deeply indebted to Robert S. Stubbs for his total dedication to his role for the College. We are extremely grateful for his service and it will be an honor to confer on him the Master of the College at our Convocation in San Francisco.

HUMANITARIAN ASSISTANCE SENT TO ARMENIA

ICD-USA Foundation - Panoramic Corporation -
World Vision combine efforts to help Armenia

The generosity of Panoramic Corporation with the cooperation and assistance of the USA Section Foundation and the World Vision Relief and Development, Inc. has sent panoramic x-ray equipment to the country of Armenia.

This PC 1000 x-ray equipment, valued at \$100,000 was donated through the generosity of the Panoramic Corporation of Fort Wayne, Indiana, to assist in the dental equipment needs of Armenia. This gift was accomplished through the assistance of World Vision Relief and Development of Monrovia, California, and the USA Section Foundation.

ICD Fellow Robert Stetzel, Fort Wayne, IN, has an innovative and creative son, Eric, who is the founder and president of one of the nation's top producer and seller of panoramic x-ray machines, Panoramic Corporation. Eric generously offered panoramic machines to be shipped overseas to assist in

bringing the state of the art technology to a needy country.

About 15 months ago Fellow Robert Stetzel made known this offer to the USA Section President Lloyd Phillips and suggested that he thought this would be a wonderful project for the ICD to assist in sending this equipment overseas to our international colleagues. This conversation was all that was needed for Lloyd to become involved in this very worthwhile project.

The Panoramic Corporation was seeded when high school student Eric would tinker with the x-ray machine in his father's office. After earning a business degree from Hillsdale College, he started a dental equipment servicing company, First Century. This original venture began by renting x-ray machines to dentists. Eric developed this start into Panoramic Corporation which produces and sells panoramic machines. These machines contain more than 90% American made components primarily made in the midwest.

Through coordination of the ICD Central Office and the superb assistance of World Vision and Development, Inc. who recommended Armenia. Transportation was provided by the United Armenian Fund. This equipment will be part of a comprehensive plan for community or even an entire country's development. World Vision is a non-profit relief and development agency serving 32 million people each year in 91 countries.

The idea of a Fellow (Robert

FOREIGN STUDENT EXCHANGE GETS ANOTHER SPONSOR

One Fellow's interest results in Indiana's first exchange

Fellow Karl Gossweiler, of Indianapolis, IN, knew of the ICD-USA Section project Foreign Exchange Student Program. His interest grew until he felt that Indiana needed to be involved in this program. This is a fine example of how individual initiative can bring results to our projects.

Upon learning of this project Karl decided to implement an exchange. He decided to start an exchange with Berlin, the capital of Germany. A list of ICD members in Berlin was obtained and Fellow Dieter Ontrup was selected to be the contact person. Dr. Ontrup received the details of the exchange from Karl and readily agreed to help the exchange.

D. Ontrup, in turn, presented Karl's proposal to a faculty professor in Endodontics and pedodontics at the Free University of Berlin, Dr. Siegfried Wandelt.

After several telephone conversations between Karl and Dr. Wandelt it was decided that the best choice for the exchange was Dr. Wandelt's English speaking daughter, Thelka Wandelt.

Correspondence then began between Indiana University and the Free University of Berlin. Each agreed to the four to six week program and provided the "go-ahead" to arrange for transportation, housing, schedule, insurance and other necessities of the exchange.

Indiana University Dean H. Williams Gilmore and Assistant Dean

Hala Henderson became very active with Karl in designing the program, extra-curricula activities and other details.

Thelka Wandelt was met in Chicago on February, 1993 by the Gossweilers because they felt that it would reduce the cultural shock and stress by meeting her in person. She began her official four week study two days later.

To make efficient use of the brief time span available an hourly schedule had been formulated. After a short time it became evident that this would not serve the intended purpose. With the devoted help of Dean Henderson a new approach was implemented. This revision provided clinical observation in the different specialities to give Ms. Wandelt a better insight into the various teaching methods and procedures as well as their advantages and disadvantages.

Her report (summarized) to Karl Gossweiler said:

- Many differences noted (US-GER) seemed to be the result of different social systems.
- Graduation in US permits immediate practice Germany requires a 2 year assistantship.
- Title of Dr. permitted only after a thesis completion, during or after school.
- Only three specialties exist in Germany - orthodontics, oral surgery and maxillofacial surgery. All other

specialized treatments are performed by general practitioners.

- Caries still a major problem in Germany—fluoridation is not allowed.
- Infection control procedures more elaborate in US
- The instructor/student relationship more relaxed and informal.

Some of the highlights of her visit were observing Dr. Anoop Sondhi's orthodontic practice and Dr. Dale Lentz's oral surgery practice; attendance at the Hinman Dental meeting with the Gossweilers, dinner with USA Section President Lloyd and Mrs. Phillips and a vacation week in Vail, CO with Dr. and Mrs. George Vail.

Her summation was: the genuine interest and her well being and comfort of her hosts made her feel at ease and gave her a good example of great American hospitality. It was a very rewarding and unforgettable experience. She was very enthusiastic about the program and hopes that the ICD continues to support a program that provides a better understanding professionally and personally between countries.

Karl Gossweiler's: "My overall evaluation of this student exchange is positive. I believe that a greater and better professional as well as personal

understanding can be achieved between the countries and its people by continuing this program.

There is one aspect in this exchange program that I firmly believe is very important to carry out. The ICD has recommended that the student be a junior. We must insist upon this. Although classifications of this nature do not exist in the German dental school system, we should specify that the student have two to three semesters of clinical experience. Anything less than this does not qualify the student to observe, detect and evaluate differences in dental procedures and treatment.

Miss Wandelt had completed only one clinical semester which was not sufficient to give her the insight she needed to evaluate the two systems competently."

Student Ben Yoder has been selected by Deans Gilmore and Henderson to travel to Germany and be the exchange student at the Free University in Berlin. His trip was scheduled for late June.

“The Good That We Do”

In 1978, a Seminar group of fifty fellows, their wives, and friends traveled to the Far East to celebrate the 50th Anniversary of the founding of the International College of Dentists. The exchange of scientific knowledge between the fellowship groups in Japan, Taiwan, Philippines and Hong Kong produced one of the most significant international projects in the history of the College. While in Manila, Fellow Ray Grove of Nebraska observed the lack of library resources in the dental schools there. Most of their library resources had been destroyed during World War II and had not been restored. On his return home, Dr. Grove developed a project with Nebraska Fellows to collect scientific dental books, journals, and periodicals to supply these Philippine Libraries. This project became known as OPERATION OUTREACH. Response to the Project from Fellows nationwide was so successful that the Project was moved to Washington University under the direction of Dean George Selfridge because of the need to identify a repository, to catalog, pack, and ship 10 tons of books. When the enormous shipping cost was realized, Fellow R. Adm. Julian Thomas and the U.S. Navy came to the rescue by shipping the books on west bound Navy ships from San Diego to Subic Bay. The creative imagination of one member of our College; the sharing by Fellows across our nation; the generosity of publishers like Mosby, Quintessence, and Ishi Yake Euro American Inc.; the determined

hard work of our leadership; the cooperation of the U.S. Navy; a total of \$10,000; these libraries were restored by our USA Section. The Project terminated in 1987 with the shipping of a large quantity of books to China by Fellow Herbert Yee.

We have conducted an annual Dental Journalism Seminar for the past 12 years and a Dental Journalism Awards Program for the past 22 years. These programs encourage and recognize outstanding dental journalists. For the past nine years we have been developing an Audio Visual Library of Leaders in Dentistry. A number of those leaders recorded have passed on and this program will become a valuable learning resource concerning the character and nature of those who achieved greatness in our profession. The Senior Dental Student Program is in its 26th year and the International Student Exchange Program is in its 3rd year. The Career Options in Dentistry, a conference coordinated by the Council of Faculties, AADS, is in its 7th year. This annual conference is to allow students to gain knowledge concerning the many career opportunities that exist in dentistry. Other projects exist.

The annual Continuing Education Conference is entering its 11th year. Conceived by Fellows George Selfridge and William Hawkins, it was organized to provide a tuition free learning experience on current dental subjects of interest to all fellows in an appealing location and to be enjoyed by all members of the family. The Foundation

provides the funds for this conference and holds them preferably where there is a dental school and to make them accessible to all Fellows. The University of Buffalo School of Dentistry hosted the 1993 conference on July 22. The dental school faculties that present the lecture program receive no honorarium, as the Foundation contributes to their respective departments.

Due to USA Section escalating operating cost seven years ago the Foundation was formed. Many projects are and will be funded by the USA Section. As the foundation grows it will be able to fund present and future projects. Your suggestions as to worthy projects are welcomed.

As dental students we learned that every restoration required a sound foundation to be successful. Our Foundation will enjoy success if each of us contributes annually the fee received from one restoration or service to support the Foundation.

From an idea that was born out of frustration experienced by a practicing prosthodontist in evaluating a patient's occlusion, **William Maness** and a handful of MIT engineers invented the T-Scan System. This new and efficient way to examine occlusal contacts consists of a thin sensor which is a force sensitive medium that can be read by a computer. The position, timing and force of the contacts can then be seen on a computer screen. This diagnostic system also has applications in medicine and industry. The F-Scan, a spin-off of the T-Scan, combines modern biomechanics and this computer technology to assist in the evaluation of foot and leg disorders. It is particularly useful in identifying potential areas of foot ulceration in persons with de-

creased sensation, such as diabetes and nerve disorders. The F-Scan is also being used to track the rehabilitation of spinal cord injury and stroke patients.

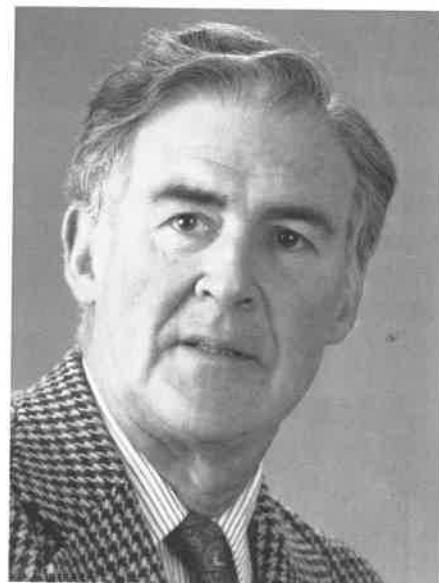

The USA Foundation grows and flourishes through the steady support of the USA Section Fellows. The Foundation, based on solid principles, seeks to put into action the purposes and goals set forth in 1985. Your contributions help these to be achieved.

The ICD, USA Section Foundation, Inc. grew out of a sincere desire of the officers and Board of Regents to establish a separate non-profit, philanthropic entity dedicated to educational, scientific and charitable purposes within the profession of dentistry.

To accomplish this desire, at the 1984 meeting of the Section a committee was appointed to draft the proposed foundation. This draft of the Foundation's Constitution and Bylaws was presented to the Board of Regents at the annual meeting in 1985. Those active on this committee were Tom Emmering, Lloyd Phillips, Don Allen and George Selfridge. The committee received encouragement and valuable input from Registrar Frank Kenward, Herb Yee and the Officers and Regents. With the sanction of the Board of Regents, the Constitution and Bylaws were refined, completed and filed as a non-profit corporation. In January 1986 the USA Section Foundation was incorporated in Florida.

The purpose of the ICD, USA Section Foundation, Inc. as stated in the Constitution is:

a. To encourage, aid and assist worthy projects and scientific dental research;

b. To encourage, aid and assist graduate dentists in their continuing education and the improvement of their scientific knowledge and skills in the profession of dentistry;

c. To encourage and assist dental students, graduate and post-doctoral dental students and pre-dental students;

d. To encourage and assist in the establishment and maintenance of professional libraries for the use of such dental students, graduate and post-doctoral dental students, pre-dental students and graduate dentists;

To abide by the Florida law requiring an in-state registered agent residing in the state, Frank Kenward was designated the first registered agent of the Foundation. The first officers were Tom Emmering, president; Lloyd Phillips, vice-president; and "Satch" Selfridge, secretary-treasurer.

With a grant from the USA Section a brochure was produced and distributed to the ICD Fellows. The first official contribution was from District 8 and the first individual to make a contribution was Lon Carroll. Very quickly other individuals and District contributions poured in. The pattern continues today. The USA Section contributes to the Foundation as memorials to deceased members. Today, voluntary contributions made

along with our annual dues averages well over 70% of our members. Our Foundation growth has been accomplished without major solicitations, fund raising campaigns or the seeking of large gifts and pledges. Our Foundation has grown and flourished through this steady support.

One primary project of the Foundation is the College's Continuing Education Program. Many Fellows have enjoyed the finest in Continuing Education through this program.

Another worthy project, through a grant from the USA Section, provides major support for the Careers in Dentistry programs for dental students conducted by the American Association of Dental Schools. Future projects will adhere to the principle that will offer direct benefits to participating USA Section Fellows and those involved in the dental profession at all levels.
