“Big bang for the buck”

Our projects had their start in 1961 when our USA Section had accumulated sufficient reserve funds to enable us to embark on USA Section projects proposed by our visionary leaders. Proposed projects to benefit the Section's membership, the College, the profession and the dental health of all people were studied to determine their purpose and financial feasibility.

From a modest three projects, our projects have grown to 12 viable and meaningful projects. You, as a member, are a part of the projects and are urged to support and participate where possible.

Dental Journalism Seminar

The College jointly sponsors with the ADA and the AADE this seminar that provides an insight for participants in writing, editing, management, computer publishing and other phases of journalism. The Seminar is a motivating force for improved dental publications.

Key

For over 50 years the KEY has been the annual publication of the ICD USA Section. The journal/magazine presents a variety of offerings on future continuing education programs, announcements of coming convocations, messages from our leaders, feature articles, a report of the preceding convocation, listing of new members, reports of prior educational conferences, district reports and other information.

Keynotes

Published by the Central Office in the Spring and Fall of each year concerning the current activities in our Section, this newsletter brings news updates, announcements and other information to our members.

Leaders In Dentistry

The International College of Dentists present a VHS video taped series by outstanding leaders in dentistry reviewing their accomplishments and presenting their views on the dental profession.

Clinicians, practitioners, researchers, and educators who have contributed significantly to the profession of dentistry are recognized in these videotapes. Important events in their lives provide human interest aspects with historical value. The videotapes include why they chose dentistry as a career, the factors that influenced the character and timing of their contributions, their views of dentistry's past and future from their own historical perspective.

Outstanding Leaders in Dentistry videotapes are intended for use by professional associations, dental schools, libraries, and those who have a personal interest in the profession of dentistry.

This historical record can compliment dental school and continuing educational courses or be used as presentations at professional meetings. Some of the 20 subjects interviewed are no longer with us. Tapes are available for purchase for

schools, constituents, educational programs or presentations at professional meetings.

Dental Journalism Awards

Held annually this program recognizes and awards outstanding dental journalism by editors in and out of the dental profession.

In its 25th year these awards encourage improvement in content, coverage, format and quality. The four categories in the awards are: Golden Scroll for showing the most improvement during the year in content and format; Golden Pen for the most outstanding article or feature; Golden Pencil for the most creative and effective use of illustrations or other graphic arts; and Special Citation for presenting an unusual treatment. There are two divisions in each category for large and small to medium budgets and honorable mentions in each category. Golden Publication is the award for the best overall dental publication. All aspects of the other categories will be considered in judging for this award.

Visiting Scholar Room

The newest USA Section project is the “Visiting Scholar's Room” located in The *Samuel D. Harris National Museum of Dentistry* in Baltimore, Maryland. This room was established in the Library of the Museum through a gift of \$50,000, and will be the repository of another project of the USA Section,

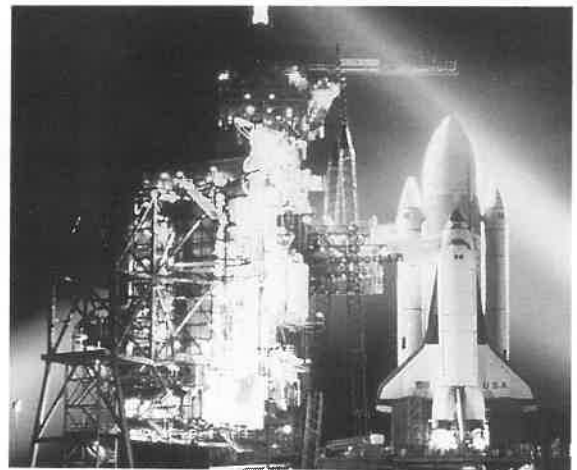

Herbert K. Yee rises to 1996 International College of Dentists Presidency

A man of varied accomplishments leads us

Herbert K. Yee, the 1996 president of our International College of Dentists, is not only dedicated to our College but is a man with a unique background and unusual, varied, talented achievements.

Born in China, Herbert arrived in the United States at the age of five. Following the path of earlier family members, his family settled in Sacramento, California, where he grew up. Herb's great-grandfather was the first of his family to leave Toishan, China, in 1850 to settle in the Sacramento Valley. Dr. Yee was the first to practice medicine and to establish Dr. Yee's Herb Store in the "Gold Rush" town of Fiddleton, CA.

After attending Pacific Union College and Stanford University he received his dental degree from the University of the Pacific and has practiced in Sacramento for 47 years.

He did not confine his activities to his practice but became active and contributed to many varied endeavors.

A large part of his energy and dedication was to the International College of Dentists. He has given many years of service as Counselor,

Deputy Regent and Regent of District 13 of the USA Section. He has served on many committees of the Section and was its president in 1985.

Herbert has been a guest lecturer to numerous societies and to U.S. and foreign dental schools. Through his foreign contacts he has brought closer ties to the ICD in the orient and other countries. He brought China into the College in 1986 and is presently working on bringing Vietnam into our College. Herb recently visited Hong Kong, Singapore and Taiwan. He made the keynote address in Hong Kong and also spoke to the Bombay convocation and induction of new members.

A member of *Omicron Kappa Upsilon*, his allegiance to his alma mater, the University of the Pacific

School of Dentistry, has been strong. The Alumni Association gained his ability and dedication immediately following graduation. In time he served this organization as president.

One of the school's most illustrious graduates, it has benefited greatly from his creation of the UOP Scholarship Fund for deserving dental students. The school presented him its *Distinguished Service Award* in 1985. He was awarded the UOP (total University) *Alumnus of the Year* in 1991. Herbert was acclaimed "A Man For All Seasons" when he was named to the UOP's Board of Regents.

Education has been a prime focus of his efforts. Under Governor Ronald Reagan, Herb served on the Post-secondary Education Commission and was elected to the *Hall of Fame* of the California School Board Foundation (5000 high schools in 1991).

Education Commission and was elected to the *Hall of Fame* of the California School Board Foundation (5000 high schools in 1991).

Herbert has also been appointed the Acting Secretary of State for California.

Herb has served on the California Board of Dental Examiners under two governors, Pat Brown and Ronald Reagan, and was its president in 1969.

For the ADA, Herbert served on its Council on Dental Education to become vice-chairman as well as serving as chair of the Dental School Accreditation Committee.

The American Association of Dental Examiners has honored him as "*Dentist Citizen of the Year*," and the Pierre Fouchard Academy has presented Herb its "*Distinguished*

Service Award."

A unique effort of Herb's was that he returned to Toishan, PRC, where he was born, and built an elementary school. The KeeScui school, dedicated in 1981, presently has 400 students and 17 teachers.

Very few know of Herb's interest in history. He is the only Asian member of the Sacramento Pioneer Association whose criteria states that the family arrived in Sacramento before 1850. Because of his leadership, Herb was presented the traditional gavel and symbolic cane that has been presented to all presidents since 1875.

Dedication to family is also a very positive aspect of Herbert

Yee's life. His and Inez' 50 years of marriage has given them four sons and seven grandchildren. Three sons are dentists, and one a physician. Family goes further than his immediate one'. Herb served three years as Grand President of the 30,000 member Yee Family Association of America. Other outside interests also receive his energy. He has been chairman of the Board of many banks

and a director of 12 banks.

He is past chair of the County's Cancer Society; charter member and past president of his local Lions chapter, then a District Governor of the Lions; chairman of the Board of the Camellia Festival; and a member of the Advisory Board of the California Railroad Museum.

With all this activity it is a wonder that he finds time for his hobbies which include black bass fishing, swimming, antique cars, and golfing with Inez.

A tireless committee worker, along with his wife, Carol, he arrives three days early with the other committee members to begin the preparation for the great day – our Convocation.

Working through the Convocation to see that everything runs smoothly he continues after the end of our celebration gathering our accessories and packing everything for the return trip for storage. The days of preparation and work pay off with a flawless Convocation.

Jack showed his leadership early as president of his senior class at his Flint, Michigan high school. This ability continued to areas of

leadership in college, including the Marquette University Union Board. He received his Ph.D. from Marquette after transferring from the University of Michigan and later was awarded his dental degree from Marquette.

Hard work is a common factor in Jack's life. All kinds of jobs, including working in the wheat fields, part time jobs, working in a clothing store, and finally a three year stint as co-manager of the lunch room at the dental school. His military obligation was fulfilled in the Typhus Control Unit of the U.S.P.H.S.

Seminar that remains in existence.

Jack has served our professional organization by working on many committees and serving as president of the Seattle King County Dental Society, as a delegate to the Washington State Dental Association's House of Delegates, as a member of the Executive Council, and as a delegate to the ADA's House.

His service to our college has been exemplary by being Regent of District 11, USA Section, and representing the ICD to Mexico, Japan, Philippines, Taiwan, and Hong Kong.

Not stopping with serving professionally he was a school district director, a merit badge counselor for the Boy Scouts, a Cub Scout leader, an Executive Council member of his Methodist Church, and has been involved in Little League and Babe Ruth baseball. 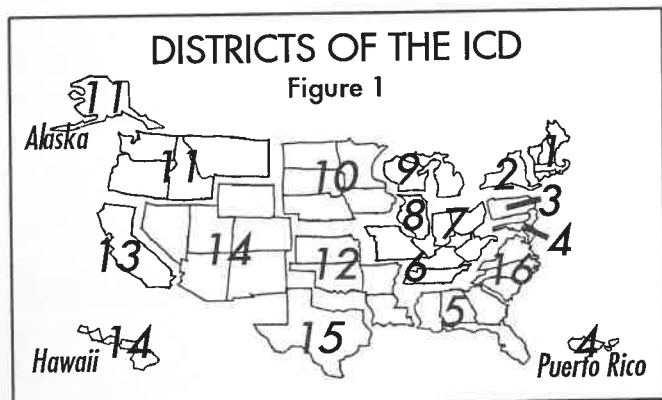
Your USA Section's Organization provides brief presentation

Following a 1920 farewell dinner in Tokyo, Japan, for Louis Ottofy, the International College of Dentists was organized.

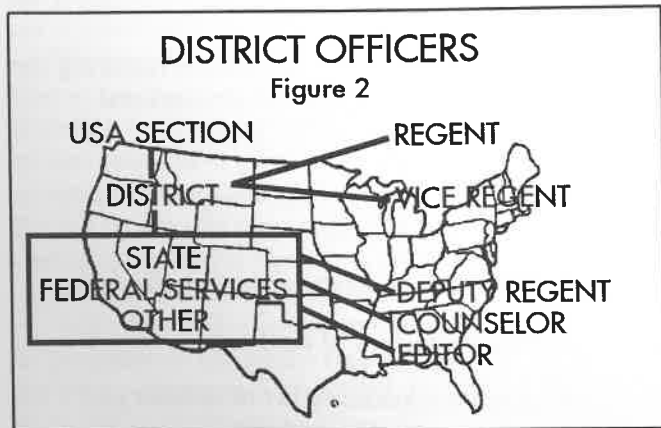
Today, the USA Section is the largest of the thirteen sections throughout the world and is organized in an efficient way which is effective in responding to the needs of the Section.

Cyberlinks to Careers in Dentistry Information

USA Section helps dental students explore career options on the Internet

If you enjoy exploring cyberspace you are not alone. You and more than 9.5 million other Internet users are browsing sites, in every corner of the globe via home and office computers. The number of users and sites are growing exponentially. It is little wonder the careers in dentistry Web site, a joint project of the



International College of Dentists - USA Section Foundation and the University of North Carolina School of Dentistry, is evolving into a premiere dental information resource.

Obtaining dental career information is now faster and easier than ever. A couple of quick clicks on the Careers in Dentistry Web site ([http:// www.dent.unc.edu/ careers/ cidtoc.htm](http://www.dent.unc.edu/careers/cidtoc.htm)) provides a wealth of information and a host of links to other dental schools, government agencies and professional organizations.

This project truly represents an information evolution. In 1984, as faculty, staff and students at the UNC School of Dentistry planned their first day-long careers conference, they also composed a comprehensive guide on dental careers. Designed as a ready reference to assist UNC students explore the myriad of career directions dentistry offers, it has become an indispensable reference for students and faculty. The guide, published as a companion piece to the 1984 careers conference, has been revised, updated and edited for each of the three subsequent careers conferences held in 1987, 1991, and 1994.

Twelve years after its first publication, the guide has been elevated to yet another level. With the impetus of the ICD-USA Section Foundation, *Careers in Dentistry* has been transformed from a local project to a national resource. The transformation has added dimensions that broaden its scope of information and expand its access beyond anyone's wildest dreams.

Today's Internet browser will discover information related to sixteen career areas, including:

Traditional Private Practice	Military Dentistry
Alternatives to Traditional Private Practice	U.S. Public Health Service
Dental Hygiene	Public Health
Dental Assisting	Veterans Affairs
Advanced Education Programs - Specialties	Hospital Dentistry
Advanced Education Programs - Non-Specialties	Dentistry for Institutionalized Patients
Academic Dentistry	Professional Dental Organizations
Research and Industry	International Dentistry

Each chapter focuses on information for a specific career choice and offers a job description, advantages and disadvantages, preparation/requirements, job opportunities, future trends, salary, contacts and references. In addition, where available, hyperlinks exist to other resources that allow the browser to jump to other sites that house information specific to the area of interest. For example, a browser interested in learning about a career in endodontics would go to the Advanced Education - Specialties chapter and select the section on endodontics. After scanning through all of the basic information the browser comes to a section that lists all of the endodontic programs in the US. The browser simply clicks on the region of choice and up pops all of the schools offering endodontic specialty training in that region. Those programs with Internet addresses are hyperlinked to the ICD careers site and the browser is almost instantly connected to that program's "Home Page". This direct connection allows questions to be targeted to the preferred program. Browsers can access important information such as on-line applications, application deadlines, and curriculum summaries.

"We have been working on revisions and edits since the first of the year," said Sharon K. Grayden, project director and Director of Institutional and Community Relations at the UNC School of Dentistry. With the edits complete, we have turned the information over to a Web page designer who will spark up the appearance and add many user friendly features Web browsers want and expect." Grayden also offers a caveat to all who visit the careers site. "This is dynamic information and will be constantly changing. A feedback mechanism has been built into the site to allow users to help us identify new sites and update the information. I encourage input and feedback from dental colleagues everywhere to help insure that this site is "the site" for dental career information." More than 8,000 browsers have visited the *Careers in Dentistry* Web site to date and hundreds more are expected once the revised version is fully functional. The ICD has a long history of involvement with career programs for dental students within our nation's dental schools and dental schools in other countries. Through the years, the ICD, in cooperation with the American Association of Dental Schools, has

Foreign Student Exchange continues to grow

Project is attractive to states and schools

LOUISIANA

Roseanne Reedy was the lucky Louisiana State University dental student to participate in the *International College of Dentists Foreign Student Exchange Project*. Roseanne expanded her education and broadened her horizons by attending *Guys Dental School* in London, England.

After a tour of the school and being assigned a student mentor, she and the mentor rotated through the various departments of the school, observing and assisting the students. She also did some minor oral surgery.

There are treatment differences in materials, instruments, and techniques but overall there are many similarities to those in US practices. Roseanne was impressed with the most modern equipment on the cutting edge of technology and the teaching techniques in operation theaters.

With 60 different, self-contained operatories, each had advanced instrumentation, computerized records, and an in-house assistant. She did find their curriculum very different from ours. The student enters dental school after high school looking at a five year student experience with a sixth year added to practice with an approved private practice dentist or in the school.

Although National Health Service dentistry is available to patients most dentists in London do not participate in the plan.

Located at the top floors of a 10 story building, the view from there is a spectacular view of London with its many historic sites. After visiting many of these places, she also visited Amsterdam, Paris, and many English villages.

Miss Reedy states that this experience would not have been available without the financial

support of ICD's project and the Louisiana chapter. She is extremely grateful for this experience.

MINNESOTA

Lisa Abadeer, from the University of Minnesota Dental School, was chosen to participate in the *Foreign Student Exchange Project* of the ICD. She says that her visit to Australia had a great impact on her life. As a result of this experience she hopes to spend some time every few years as a volunteer dentist in underserved areas.

Faced with a choice of several European schools, Lisa chose the *University of Melbourne School of Dental Science* because she did not feel comfortable in foreign languages. She found, however, that for many patients whom she served English was not their first language.

She was surprised by the similarities between the American and Australian cultures particularly in the areas of music, movies, and television shows. The Australians have maintained the personal touch in their culture.

In general the treatment techniques are very similar although the utilization of the glass ionomer and silver reinforced glass ionomers are much more prevalent. A unique difference in the curriculum is that the University of Minnesota emphasizes clinical training, the Australian students are more

focused and familiar with the literature.

Like England, Australian patients do not pay for their treatment. Hence, the level of care is often dictated by finances and not what is the ideal treatment. The dentistry practice by private practitioners is basically the same in both countries. During the course of dental education the student's practice is at the opposite end of the spectrum.

Many patients Lisa treated had never received regular dental care. She saw a great deal of calculus and teeth with different wear patterns from that seen in patients consuming a soft diet in processed foods.

She came back with a greater appreciation for things available at her school; smoothness of clinical operation, number and variety of instruments and burrs, the efficiency of sterilization, and many other things. One noted difference between the two countries is that Australian graduates may enter private practice immediately, whereas, in the states board exams are required.

Like others, Lisa found her time well spent. By meeting new people and making new friends, learning new things, and being in a different environment caused her to be stretched and grow personally.

Miss Abadeer is deeply indebted to the ICD project and Minnesota for their very valuable support.

MARYLAND

Once again, as in 1994, the USA Section of the ICD and the Baltimore College of Dental Surgery, University of Maryland participated in the International Student Exchange Program. A grant from the USA Section of the ICD for round trip fare and \$150 for each exchange student enabled

BCDS to link up with the dental schools in Cork, Ireland, and Dundee, Scotland.

This year two students from BCDS were selected. John Mullally '96 went to the dental school at Cork College in Ireland, and Ronald Taylor '96 attended the dental school at the University of Dundee in Scotland.

In a reciprocal exchange BCDS had the pleasure of hosting Ms. Susan Butler (Cork College) and Ms. Lisa Currie (University of Dundee). Both were in the final year of their respective dental programs.

This program could never exist without the efforts of ICD Regent, Dr. Harry Dressel; Deputy Regent for the Maryland Component, Dr. William Patteson; Dean Richard R. Ranney and the Secretary General and Registrar of the International College of Dentists, Dr. Richard Shaffer. Local arrangements were coordinated by Drs. Mark L. Wagner and Margaret Wilson at the University of Maryland and Dr. Robin O'Sullivan, Cork College and Dr. Chris Longbottom, University of Dundee. This program also wishes to acknowledge the support of Dr. Mary O'Rielly, who hosted Ms. Butler, Drs. Ann and Brian O'Connell who played host to our visitors at the National Institutes of

Health and the Dental Deans at Cork and Dundee and their faculties.

A selection process devised by each participating school chose the students to participate. In the case of BCDS, applications were submitted to the Office of Admissions and Student Affairs and an outside selection committee of ICD Fellows from the community selected the candidates. Ms. Butler and Currie were similarly selected by their dental colleges.

This year the student exchanges for Mr. Taylor, Mr. Mullally, and Ms. Butler occurred during July and August. Due to the differences in schedule with the University of Dundee, Ms. Currie visited BCDS in October. Ms. Butler was the house guest of Dr. and Mrs. Shamus O'Reilly. Mr. Mullally was hosted in Ireland by Ms. Butler while Mr. Taylor was the house guest of Ms. Currie in Dundee. Ms. Currie was hosted by Dr. and Mrs. Mark Wagner.

The students were given the opportunity to observe dental education, private practice dentistry, the health care system, and the cultures and people of the US, Ireland and Scotland. The students from Ireland and Scotland were able to attend all clinics at the University of Maryland as well as attend classes, seminars, conferences and clinical rotations at the University of Maryland Medical System (Hospital). They were exposed to the research facilities in both biological science and clinical sciences. Ms. Butler was particularly interested in pediatric care, Ms. Currie had an expressed interest in prosthodontics. A highlight for our visiting students was a trip to the NIH and NIDR. This experience was coordinated by Drs. Anne and Brian O'Connell who not only escorted Susan and Lisa through the NIH but also hosted

them in their home while they were in Bethesda. Of course sightseeing was important and trips to New York, and Washington were included in each of their itineraries. Dr. William Patteson arranged and hosted the private practice experience. Both he and Dr. Dan Devlin, his associate, and Dr. Albert Osbourne provided valuable insights into the current and up to date practice of dentistry in America. Ms. Butler had the added treat of attending, along with John Mullally and Ron Taylor, the ICD Leadership Conference and Luncheon as guests of the College. Ms. Currie was treated to several events including the Baltimore City Dental Society October dental meeting.

Ronald Taylor's host while at the University of Dundee was the local coordinator of the ICD exchange, Dr. Chris Longbottom. He observed all aspects of clinical care and was particularly interested in the cleft lip/palate clinic and his visits to

Ninewells Medical Hospital and Dundee Royal Infirmary. Mr. Taylor's sightseeing included; Edinburgh, St. Andrews, Glamis Castle, and Glasgow. Ronald has stated that his exchange experience gave him a real taste of dentistry in the UK and will affect the diversity of his approach to dentistry back at home.

John Mullally's exchange coordinator while visiting the University College of Dentistry, Cork, Ireland, was Dr. Robin O'Sullivan who arranged a diverse and interesting view of dentistry and dental education. He also had the opportunity of visiting private practices.

His visits to the University included the departments of anatomy and biochemistry. John observed that there were many similarities in the school as with the University of Maryland. These included, clinical set up use of auxiliaries, teaching approach and content of courses, dental materials, student life and lecture format. The

differences he noted were, amount of time spent with patient and relaxed environment, five year curriculum, average age of students younger than in US, use of European dental products and equipment, more instruction in implants, role of specialists that is, the general practitioners perform more of those procedures that are considered in the purview of specialists here in US. John had the added pleasure of having his wife Molly with him for part of the visit and their trip was highlighted by contacting family in Ireland and touring the Ring of Carry.

By all measures this 1995 International College of Dentists Student Exchange Program was a success. The students, John, Ron, Susan and Lisa will carry this experience with them throughout their career. The Universities of Maryland, Cork and Dundee have been enriched by the visits of these bright young people.

A Deputy Regent expresses his view of the Deputy Regent role

Georgia's Deputy Regent says the office is the heart beat of the ICD

I sincerely believe that the Deputy Regents are the heart beat of this organization. They are the unsung heroes who provide the building blocks for the growth and advancement of the College. And I hope that following this article, you will have a better appreciation for my observations. To do the job of Deputy Regent properly and as recommended by our factbook, requires much work and dedication.

Each Deputy Regent has a *FACTBOOK* and I want to highlight a few of its areas with my personal observations.

Editors are important in that they must be dependable, possess some writing skills, and be somewhat of a photographer. It is their duty to accumulate all news of the meetings and activities of the state, **information on individual members**, and forward that information to the editor of the section for publication in the "Key" or in other publications. I believe that the term of editor should parallel the term of the Deputy Regent.

One of the most important duties of the Deputy Regent is deciding who will be on the *screening committee*. The recommended number is 6, but that will depend on the size of your state and the cities in your state. The screening committee

must be carefully selected and thoroughly briefed on their duties and responsibilities. They must be the type of persons who understand who the College considers to be a worthy candidate. They must also constantly look for worthy applicants and suggest that they be sponsored.

The screeners and other members should make a special effort to seek worthy females and minorities for the College. As these groups become a more integral part of the dental scene, this diversity should be reflected in our college and the screening committee is in the position to direct that change. The worthiness of the candidate, however, should always remain the foremost consideration.

Let's now look at the flow chart for membership. The flow chart reveals that the entire process depends on the diligence of the Deputy Regent in that the initial request for consideration for membership begins with a letter of recommendation from the sponsor to the Deputy Regent. As the chart demonstrates, the Deputy Regent forwards this request to the screening committee and once the candidate is approved by the screening committee, the Deputy Regent forwards a Candidate Information Form to the sponsor with instructions. Once this is completed and the letters of recommendation are in place, the Deputy Regent forwards the

information to the state counselor for review. Receiving this back from the state counselor, the Deputy Regent then forwards the completed application to the Regent. The Deputy Regent should be absolutely certain that the candidate information form is properly and completely filled in.

Another important duty is to immediately forward any information to the Central Office and Regent on the death of a Fellow. You should be aware that a donation is given by the USA Section to the Foundation in memory of the deceased Fellow. Timeliness of notification is very important. Include the spouse's name, if known.

It is important that your chapter roster be updated yearly for a number of reasons. The Deputy Regent should contact the Central Office at the beginning of each year for the names and addresses of the new Fellows along with the names of the Fellows who have changed to a life of retired status, as well as those who died during the year.

The Deputy Regent should solicit members to sponsor worthy prospective candidates at every opportunity.

He should send a letter to the sponsor once the applicant is accepted, thanking him/her for sponsoring this worthy candidate. This will lead to more applicants

from that sponsor. Once the applicant is conferred Fellowship, a letter should be sent from the Deputy Regent congratulating them and advising them that now that they are a Fellow, it is their duty and responsibility to take the time to sponsor other worthy persons, just as someone did for them. As a Fellow it is their responsibility to seek out qualified persons to sponsor.

The Deputy Regent should encourage his fellow colleagues to participate and/or initiate worthy projects within their states.

Based on my service as a Deputy

Regent, I believe that if these duty reminders are fulfilled, it will be for the betterment of the position of Deputy Regent, but more importantly, for the betterment of the College.

I have outlined many of the duties of the Deputy Regent and have made specific recommendations that I believe will improve the office of Deputy Regent and more importantly the College. I urge you to read the entire section of the factbook as it relates to the position of Deputy Regent and hope that you now have more insight into what the position entails. If done properly, it is a lot of work and responsibility,

but it is also a great honor. It is an honor to serve the College in this important way. It is an honor to play an important part in gaining the well deserved recognition for the many we are able to recognize.

It is also frustrating and saddening to know that there are many other, worthwhile candidates for fellowship, that unfortunately, go unnoticed, because no one takes the time or effort to sponsor them.

It is a tremendous privilege to be in the position of Deputy Regent, to get to know and become involved with the "creme de la creme" in dentistry, and to help our College to grow.

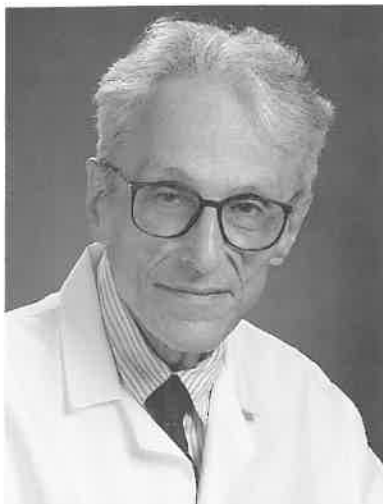
postgraduate residency in oral and maxillofacial surgery at Tufts.

A Fellow of the Academy of General Dentistry (AGD), he has served on the academy's Public Information Council and the Council

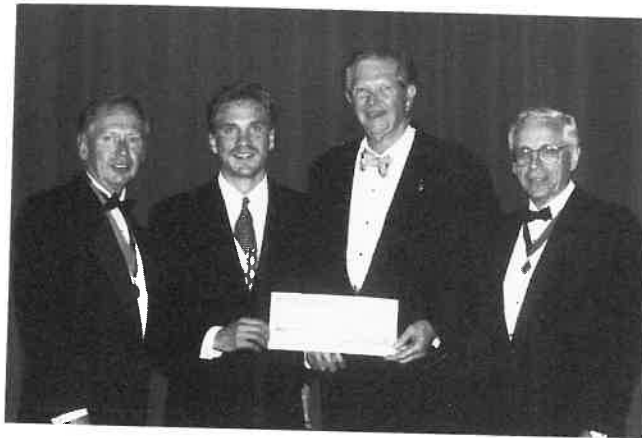

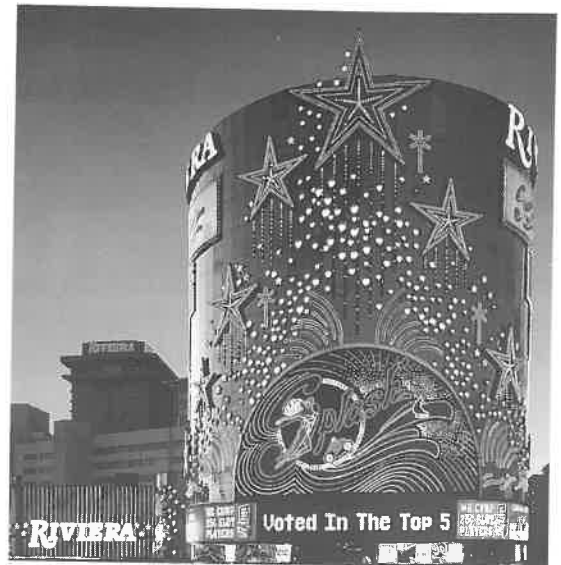
The procession begins.

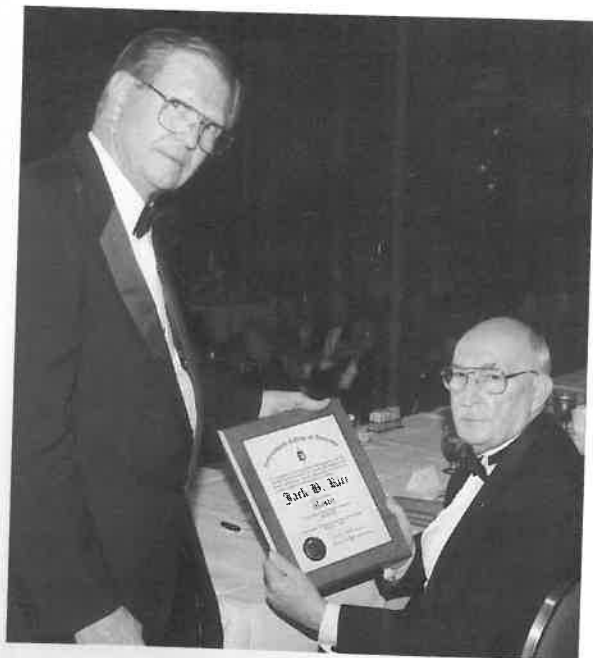

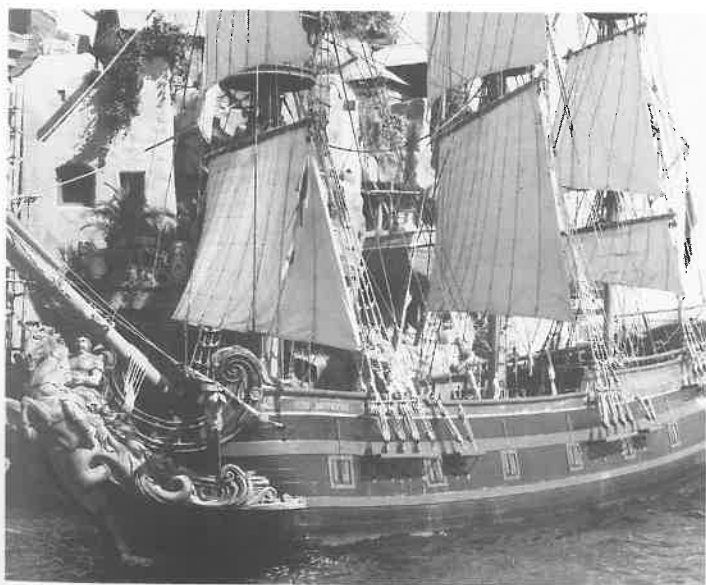
stirring address to our Convocation by one of our own, recently elected Congressman Charlie Norwood of Georgia.

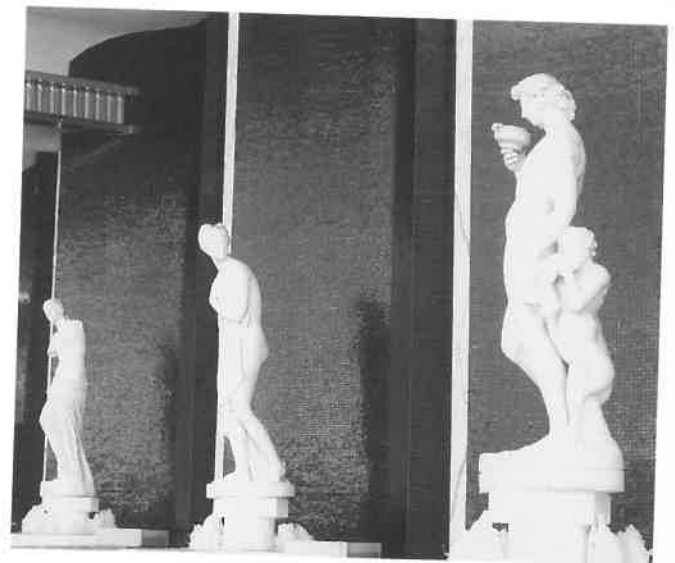

International Student Exchange

This project was initiated in 1990 to improve and increase international relations at the student level by providing a professional and cultural exchange between dental schools in the USA and in other countries. The objective is to experience and study dental education and dental delivery systems to better appreciate the dental culture internationally. The program provides an excellent opportunity for a USA junior dental student to travel and spend three weeks in a pre-selected foreign dental teaching facility. A student from the foreign dental school would then return the visit to the USA. This has been a very popular project. Additional opportunities are available.

International Clinicians Program

Academic interchange is the purpose of this project. The objective is to exchange scholarly lecturers to share professional knowledge between the USA and other countries. The host country supplies the cost of housing, meals,

etc., while the clinician is there. Although in its 20th year this project is under-utilized and under-financed.

Project ACT (Assistance Counseling In Transition)

This College project has three acts. In Act I (the student) ACT committees are formed for each dental school in the district. The project is explained to the school, a list of senior students is obtained and letters of project information is given to each student. ICD members in each district are asked to sponsor and host one student to a local society meeting. An attempt is made to obtain the student's concerns and to offer counseling. Act II (the transition) - upon obtaining the plans and future location of senior students, Fellows in that locale are contacted and urged to welcome the new dentist by inviting the graduate (and wife) to a get-acquainted dinner or function. Act III (the district) - offer and communicate your friendship and be helpful when called upon. Discuss the benefits of organized dentistry and encourage them to become active in the dental society. Refer patients when possible and remain interested and involved with the new dentist. The project's success depends on a "one on one" basis.

Senior Dental Student Award

Our Regents and Deputy Regents award recognizes the senior student who has shown exemplary student achievement and academic and professional development during the years as a student of dentistry. Chosen by their faculty, the student is given a plaque from the College.
