We celebrated the 15th Anniversary of CEC at Grand Traverse Resort on the Northern Shores of Lake Michigan on July 9-13, 1997. It was sold out. We hope to see you in July 23-25, 1998 in Toronto, Canada.

In a few weeks, I will represent U.S.A. Section at the

Annual Meeting of the Japan Section at Hakone, Japan. They are celebrating their 40th Anniversary of the establishment of the Japan Section.

Strong guidance attributes of Minoru Horiuchi devoted to our Section Presidency

The USA Section of our ICD has benefitted from Minoru Horiuchi's personal international presence with his close ties to Japan. He is known as an outstanding leader in our college both at home and in Japan.

Born in Japan, he received his DDS from Tokyo Dental College in 1995 and his DMD from Tufts School of Dental Medicine in 1960.

He began his private practice with his Father, who still practices, in Kyoto, Japan. His sister and brother are also dentists. Min served with the U.S. Army's 35th Station Hospital in Kyoto in 1950-'51. He came to the United States, received his citizenship in

1959 while in school here, and received his dental degree from Tufts.

Min has been on the staff of Forsythe Dental Infirmary, the Guggenheim Dental Clinic and the Harvard School of Dental Medicine. For many years he has been a visiting lecturer at the Tokyo Dental College in Tokyo, Japan.

He is known at home and in Japan for his dedication to dentistry and athletics. The Japanese Consul General in New York awarded him a Certificate of Appreciation and the Japanese Minister for Foreign Affairs presented him a Citation of Appreciation. Other honors are the Prince Chichibu Award from the Japanese

Amateur Athletic Federation, a Certificate of Appreciation at the Ohme-Hochi Marathon. Min is the Boston Marathon liaison for Japanese runners and serves on the Board of the Boston Athletic Association (manages the Marathon).

Min is very active in Rotary International, the Delta Sigma Delta Fraternity, the Newton Center Civic Affairs, and is very involved in many professional organizations.

An avid golfer, he also is a technical photographer and a video camera buff.

His guidance of professional and other organizations explains the effectiveness of his leadership as he leads the USA Section of the ICD.

Donald Compaan reports on Golden Tour of China

As the Vice President of the USA Section of ICD I was pleased to join ICD Past President Herbert Yee in his golden Route to China tour.

Returning to China in November, 1996 after twelve years, was an interesting and rewarding experience. As a member of the first official delegation of the American Dental Association to China after President Nixon had opened relations with this great country of the Orient, many changes were evident. The years of the cultural revolution under Mao Zedong from 1966-1976 produced much terror and chaos and starvation among the Chinese people. The educational system was viewed as elitist and was torn apart. Many imprisonments occurred for educators and other leaders. It was a time of Red Guards

and its oppression.

In 1984, when we were in Beijing, we were hosted well by the Chinese with the limited facilities (hotels, restaurants, hospitals, schools of higher education) that the Chinese had. There also was a feeling that we were being shown only what the government wanted us to see and our itinerary was fixed.

Returning, it was evident that many changes have happened under the quiet behind the scenes leadership of the elderly Chinese leader, Deng Xiaoping. There still is strong, central leadership over this nation of 1.2 billion people but the Red Guards and the Communes are gone. There is freedom to move about whereas, under Mao, a Chinese citizen had to have a permit from the government before the person could go from one place to

another. We were told that China, under Deng, has a socialistic government. They say they have taken the best aspects of socialism and capitalism and combined them for what works the best for China. Communism is presently viewed as the ultimate goal but, in the interim of achieving that system, China is presently embarked on a course to achieve trade, growth and a higher standard of living for its people.

China is still a land of great contrasts. There is great poverty among the masses while in the cities, great building and economic growth is occurring with great wealth resulting for many people. Construction cranes are everywhere in the cities. New hotels, new airport facilities, new airlines, many consumer goods are very evident. We traveled on three Boeing jets and one Russian jet. We traveled on some very modern busses and the fast train from Guangzhou (Canton) to Hong Kong. In many ways China can be considered a third world nation. In many other ways, it has an aggressive, bustling, energetic, trade-oriented, manufacturing economy. Exports are increasingly seen as the best

way for the Chinese economy to grow in the years ahead.

Everything in China is owned by the government – land, water, air and sky. Presently the government has a new system of leasing the land to the farmers. The farmer pays the government 15% of his profits and he keeps 85% of the profits. This has substantially increased food production. Under Mao's system of communism, farmers were all paid the same regardless of their productivity. It was determined by Deng Xiaoping that the communist system was a failure with the farmers and food production.

Twelve years ago, we met with the national leaders of dentistry in China at the University of Beijing School of Stomatology. Dr. Chu was Dean of the School at that time. The educational system was in disarray from the Mao policies. The School and hospital were in operation but it was a stressful time. Presently, Dr. Chu, 83 years old, is still a very active Dean Emeritus and took a prominent part in again welcoming and hosting us. Dr. Zwang is now Dean. He is in his fifties and is a very

capable leader. Dr. Fu is Assistant Dean and head of the graduate training in Orthodontics. I have known all three of these men for some years. Dr. Fu received his orthodontic training at Northwestern University in Chicago and studied many times at the library at the American Dental Association. He attended the A.D.A. meeting in Orlando in 1996. All of these men are knowledgeable about the United States and have high regard for our opportunities for education and training.

The University of Beijing is probably the show piece and highest level of delivery of dental care in China. We were given a tour of the facilities

there, primarily in the graduate training area. Equipment was modern. Siemens from Germany does a good business at the School. Dr. Fu runs a very good department based on his American training and his own concepts and insights into dental

care, sterilization procedures and inter-personal relationships with his faculty and students.

All aspects of training, equipment, sterilization and fabrication may not be equal to American standards but great progress has been made in the past twelve years.

The leadership of dentistry in China is closely allied with

the International College of Dentists and its Fellowship world-wide. Dr. Chu, Dean Emeritus, is presently the Regent of the College in China. He will be succeeded by Dean Zwang in 1997. The President of the International Section of the I.C.D., Dr. Herbert Yee, of Sacramento, California headed this visitation to China. As Vice President of the U.S.A. Section of the College, we presented a People to People approach to international dental relationships. Fellowship in the I.C.D. is one of the highest recognitions a dentist achieve in the eyes of the Chinese. Under Mao's regime, nothing happened to give recognition to leadership

and contributions given to society and so we have been working and encouraging a renewal, a re-vitalization of the I.C.D. in China. A convocation for new Fellows is planned for August, 1997 in Beijing.

Great changes are occurring all over the Orient. China is reflective of that. Many people, much productive capacity, many opportunities exist for business with American, European, Japanese and other nations. China appeared less openly militaristic and rigid-in-rule now than twelve years ago. Trade, business, tourism and more openness with other peoples seemed evident. To manage, feed, and provide

growth and development of education and all aspects of a society is a tremendous job for the leadership of this huge nation. To achieve those goals without being or becoming oppressive to its people with their inherent rights as persons, is a fine line to tread. China has a long history of 5,500-6,000 years under Emperors, Warriors, Dictators – always a strong central authority. It will be interesting to observe this nation evolve as it pursues a new approach to participating in the world with emphasis upon socialism and the more attractive aspects of capitalism. These are dynamic times in world history.

Foreign Student Exchange Program remains popular

Knowledge exchange is the chief benefit

OHIO

Case Western Reserve University Dental School student **Kim Menhinick**, from British Columbia, Canada, and **Maija Indriksons**, from Latvia, were participants in the International Student Exchange Project.

Each student spent three weeks at the others' school. Miss Menhinick's mother was born in Minsk, Belarus and her late father was from the Ukraine so this visit put her close to her family's roots.

Both young ladies originally planned a career in medicine. Kim changed because of her experience as a volunteer in the dental clinic for two years and Maija changed because of the predominance of women in the dental profession in Latvia.

Miss Menhinick's experience in Pega, Latvia was more hands-on, while Miss Indriksons's background of more didactic

experience led her to enjoy observing the clinic work at CWRU.

The International College of Dentists Secretary General Richard Shaffer hosted both students with a tour of Bethesda Naval Hospital. This year the ICD project paired other students with schools in Ireland, Scotland, and Germany.

MENHINICK

As the plane touched down on May the 8th in Copenhagen's airport I was not only ecstatic about the fact I was in Europe, but that I was only 45 minutes away from my destination, Riga Latvia. My journey began back in April when I came forward to express my desire to participate in the International College of Dentists Foreign Exchange program. This was an opportunity of a life time.

My first day in Riga I was picked up at the airport by Maija and Professor **Peter Apse**, and was given the opportunity to view a portion of the dental facilities. Professor Apse and the other faculty members have been very instrumental in trying to establish and maintain a standard that is comparable to the rest of Europe, and for that matter, the world.

Maija, being in her third year, showed me a great deal of what the third years were doing

both practically and didactilly. Her courses included: psychiatry, medical emergencies, pediatrics, prophylaxis, infectious diseases, prostodontics, endodontics, biomaterials. It was also in this year that Maija was exposed to the "phantom" (as she liked to refer to it), translated, this is the typodont. They learned to do simple operative procedures in their first semester of third year and by second semester are required to place four, of any kind, amalgam or composite restoration.

In Maija's first two years there is really no exposure to dentistry. As Maija has just come out of high school they are required to take courses such as general anatomy, histology, chemistry, physics, English, Latin, biochemistry, genetics, microbiology, dermatology, surgery, ear, nose and throat, and internal diseases. These courses are all taken with the medical students. By the end of her second year she has had

exposure to dental anatomy. Although the students do not do any of their own lab work they do take a one half year course on dental materials and see many of the techniques that a laboratory would use. The school also has its own in-house lab.

I attended a number of classes with Maija. The format and principles appeared the same as here in the U.S. according to Maija's translations. I also observed that much of the material the clinic uses is 3M. Prof. Apse explained to me that this is mainly due to 3M's gracious donations to the school. Maija's classmates were all very welcoming and I had the opportunity to go out with her group on a few of their social outings. The reason I have said "group" is because her class is divided into four work groups. This has been done purposely to allow for a more one on one teaching when it comes to certain labs or classes. This is a very interesting difference as it is the exact opposite here in North America.

Finally, in my last week I visited two private practices. Both practices were very beautiful and very modern. Prof. Apse explained to me that it's difficult to all of a sudden shock the public with very high prices because the public is not used to having to pay for their dental work. Dentistry was paid for by the government in the past. Dr. Goonzayna is seeing cases that are very difficult, simply because she is having to deal with work that has been done by dentists who do not want to update their techniques.

Maija's family was more than warm and welcoming to me while I was in Latvia and it gave me great satisfaction to show

her the same hospitality while here in U.S. Not only was Maija able to see many of the sites of Cleveland and the dental school (as was made possible by many of the ICD members in the Cleveland area), but she was also able to visit Washington, D.C. during the Fourth of July. Once again I must sincerely express my gratefulness to the International College of Dentists for allowing me to partake in such an exchange. The experience is one that not many are fortunate enough to experience. It is something that I will carry with me for the rest of my life, not to mention the fact that I now have a good friend abroad who also practices dentistry.

INDRIKSONE

First of all I would like to thank the International College of Dentists for giving me such a unique possibility to participate in the dental student exchange program. I had a chance to see how dentistry is taught and practiced in the USA, to learn a lot of new things and meet a lot of interesting people.

My visit to the U.S. followed shortly after Kim Menhinick's

visit with me. We tried to introduce Kim with our system of teaching and studying dentistry, with our program and student's attitudes, with our problems and with the changes that have lately happened in our Dental School. I would like to give a short description of our Dental School, as the system is quite different than that of the CWRU.

Our Dental School is a part of the Academy of Medicine of Latvia. We are students of the Academy in the Faculty of Stomatology. We enter the Academy of Medicine right after finishing high-school and study for 5 years to get a DDS degree the first two years we take almost the same subjects as the students of the Faculty of General Medicine. We begin our pre-clinic classes in dentistry in the second year and we begin to see patients in clinic in our third year.

I will try to give more details while comparing the dental education system in Latvia and the one I got acquainted with in the CWRU.

I arrived in Cleveland on June 19. **Richard Rice** and Mrs. Rice as well as Kim and her

boyfriend Alan Kuwabara, who also is studying in the same class of the Dental School, welcomed me very kindly.

Most of the time during my stay in Cleveland I was going together with Kim to the Dental School and observing the work of the students there. The first day I had a chance to meet all the students and some teachers and staff members. I was impressed how warm and friendly everybody was welcoming me, how interested students and doctors were to know things about my country and my Dental School. The students were very open, co-operative and caring and it helped me a lot during my stay in Cleveland. The students of the Dental School are older than we are, because, as I got to know, they have already graduated from college. Maybe this is one of the reasons why students have a different attitude towards the studies in the Dental School. They are more serious, more motivated, more interested to know things and devote much more time for their studies. As a result, the knowledge in different branches of dentistry is more profound and professional.

I got to know a lot of new things, especially in prosthodontics, restorative dentistry, pediatric dentistry and surgery. I also observed the work in the departments of endodontics and periodontology. The first thing that surprised me was that students have separate cubicles, where they admit their patients. In our school we are going from one department to another and always changing our work place. I think it is very comfortable to work on one unit. I didn't expect to see that students are doing so

much lab-work in prosthodontics on their own. We have technicians in the school, who are doing all the lab-work for the students. I learned many things I never knew about lab-work. The biggest and the most important difference I discovered, is that students in CWRU have much more practical knowledge and experience than we do.

Dr. Rice was so kind and took me to also see three private dental practices. **Dr. Shumaker**, **Dr. Alexander** and **Dr. Metro**

welcomed me to their clinics and introduced me with the style and organization of the work there. I appreciate very much the time they found to show me the new methods and materials they are using. As the most interesting things I could mention were three extractions of third molars in Dr. Metro's clinics, patient examination with intraoral camera at Dr. Shumakers practice and the temporary crown technique, what I saw at Dr. Alexander's practice.

I am very grateful to ICD and especially Dr. Rice for organizing this student exchange. And I also would like to thank the dean of the CWRU

Dental School for allowing me to join students in the clinics.

LOUISIANA

I have always dreamed of going to Europe. Thanks to the International College of Dentists, I received that chance this summer. The summer externship program at Guy's College in London proved to be one of the most incredible experiences of my life.

At Guy's Dental School, London, England my main objective was to learn about their school system and hospital based dentistry. It is amazing to see the striking differences, both in the way the school is run and the different clinical problems they face. At Guy's, the patients do not have to pay for their dental work. Each person is covered. This limits, however, the type of dentistry performed on each individual. Aesthetic dentistry is not as popular as it is in the United States. The primary purpose is to improve function and eliminate pain. The students' work is of excellent quality, but patients rarely get the opportunity for orthodontic or crown and bridge treatment for purely aesthetic reasons. The patients do have the opportunity to receive treatment from

private practitioners if they wish to pay for the service. The United States is moving toward a managed care system. Currently, this is affecting the medical community, but will soon involve the dental community as well. This type of system will be very similar to the Public Health Service in the United Kingdom.

The students do not have to pay for their dental training, and they begin at a much younger age than in the United States. Once the students know which pathway they will pursue, they center their education accordingly. Medical students and dental students start on the pre-med/pre-dent curriculum in what is the UK's equivalent of high school. This enables the student to go to dental school at the young age of 18 or 19. In return, the students must work for the Public Health Service for

one year following graduation from dental school.

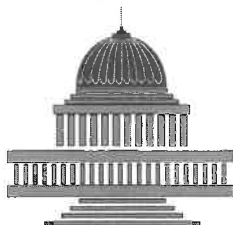
Because the dental school is hospital based, it gives the students an opportunity to see much more trauma than we see, unless of course we elect to do an oral surgery externship at the local charity hospital in our "extra" time.

The most amazing area of Guy's Hospital has to be the incredible Pathology Museum. In it there seems to be a specimen of every disease and anomaly that has ever existed. What an amazing place to learn and to actually see how disease presents itself clinically. I could have easily spent weeks in the museum alone.

The academic portion of the dental school student's career was incredible. We were on our externship while the students were studying for their final, which happen to be cumulative

over five years. We also must take a cumulative test, the boards; however, the boards are multiple choice opposed to the cumulative essays that the Guy's students must take. The dental students at Guy's had an excellent medical base, which is appropriate for the amount of compromised patients the students see in the hospital.

Each country we visited after England had its own personality. Most were extremely charming and I hope to return. It was exciting to compare and contrast the different areas. I met lifetime friends and colleagues that I would have never had the opportunity to meet. Not only was this a summertime externship, but also a continuous educational experience. I truly thank the International College of Dentists for this incredible summer.

The second largest class ever inducted

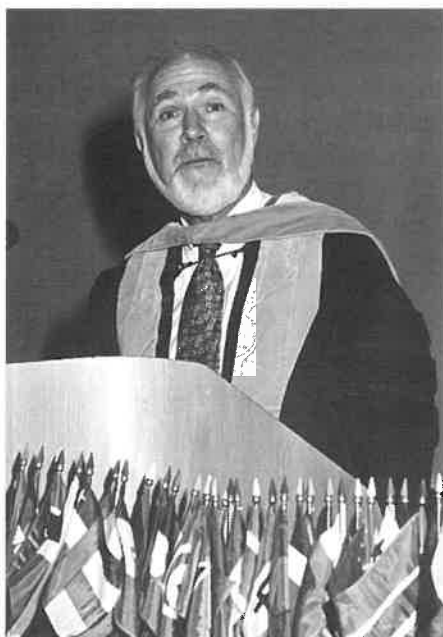

Anxiously we wait our call for induction.

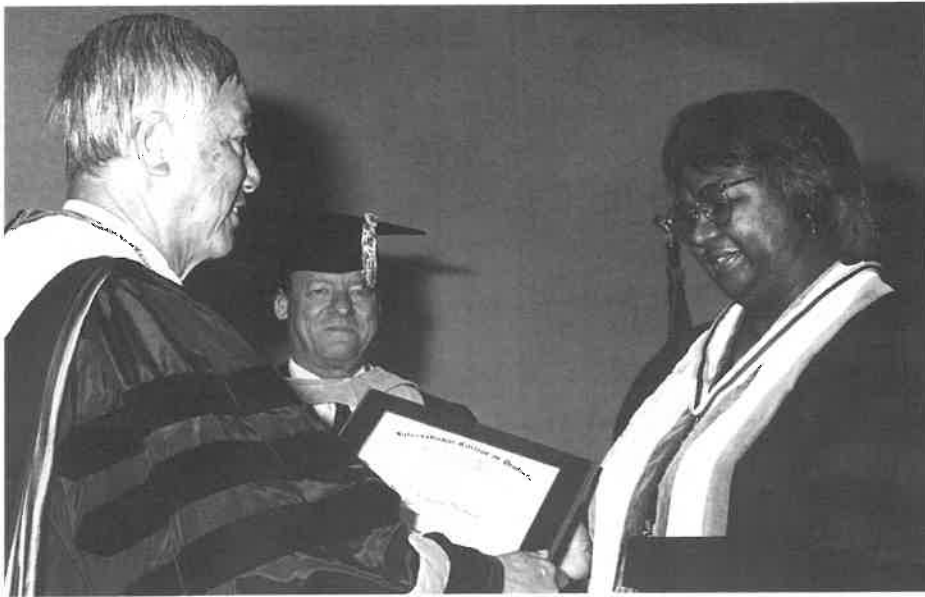

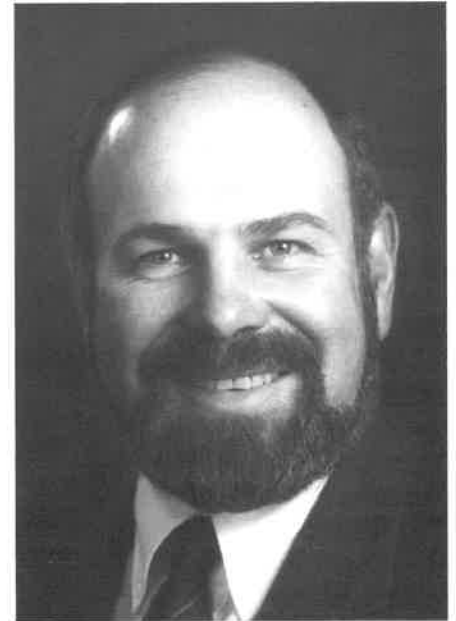

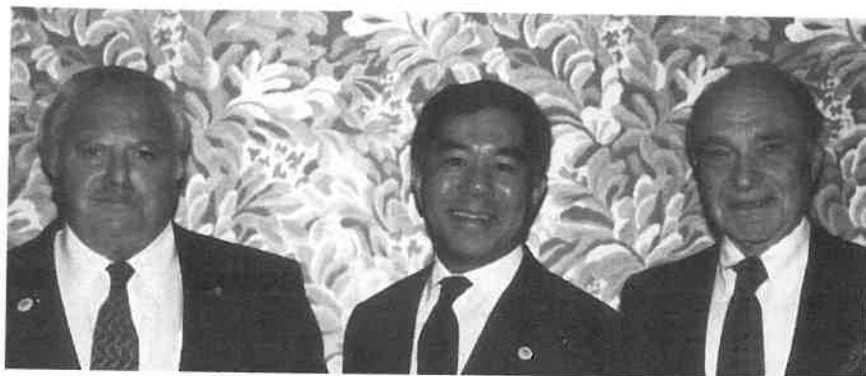

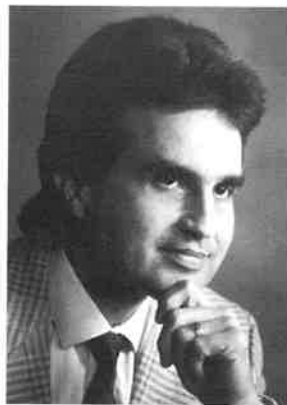

In 1972 he was the first university faculty member elected to the Institute of Medicine of the National Academy of Sciences.

Recipient of the 1992 *John W. Knutson Distinguished Service Award* of the American Public Health Association. Dummett was that association's 1996 Vice President for the United States.

California Secretary of State, Bill Jones, and California Archives Foundation President, Tom Stallard, jointly announced today the election of **Herbert K. Yee**, to the Foundation's Board of Directors.

The California Archives Foundation is a public-private partnership established in 1995 to oversee the construction, operation and maintenance of the Golden State Museum, a 25,000-square-foot, state-of-the-art facility, which will open in 1998 in the Secretary of State's building complex, located at 10th and O Streets in Sacramento.

Herbert Yee has practiced dentistry in Sacramento for nearly 48 years. Born in China, he arrived in the United States at the age of five. His family settled in the Sacramento area, following the path of his great-grandfather who arrived during the Gold Rush period and established an herbal store in Fiddletown. The store is now a museum in that small "Gold Country" town.

On May 12, 1997, Dallas endodontist **James L. Gutmann** was elected Treasurer of the American Association of Endodontists.

Dr. Gutmann has been Professor and Director of Graduate Endodontics at the Texas A&M University System-Dallas, Baylor College of Dentistry since 1996 and the Director of Graduate Endodontics at the Baylor College of Dentistry in Dallas since 1992. From 1982-1992 he

was Professor and Chairman, Department of Endodontics, Baylor College of Dentistry in Dallas. PROTOCOL:

- Approve selection of candidate.
- Assist in scheduling and housing.
- Assist in publicity.

Dean – U.S.A. Dental School:

- Select student with proper criteria:
 - Junior student.
 - Upper 1/2 of class.
 - Language proficiency.
 - Good will ambassador for country.
- Contact dean of overseas school to familiarize and sell program.
- Provide housing if possible (dormitory, fraternity house or personal home).
- Assist in scheduling for incoming students.
- Provide liability exclusions prior to visit.
- Provide forum for post trip presentation by student.

Exchange Student: (U.S.A. and overseas)

- Total willingness to participate.
- Provide partial expenses that are not covered by program.
- Host visiting student to assist the local committee and Dean.
- Understand school environs of other countries.
- Provide written report to Constituent and Projects Committee.

U.S.A. Section:

- Provide approval of funding for program annually.
 - Provide round-trip excursion coach airfare for exchange students.
 - Provide \$150 expense money to each student.
 - Publicize reports in Key, Keynotes and Globe.
 - Approve protocol and oversight.
 - Review program annually for project worthiness.
 - Keep International Council up to date on progress of program and encourage Sections to participate.
 - Assist in liability exclusion for Section.
