

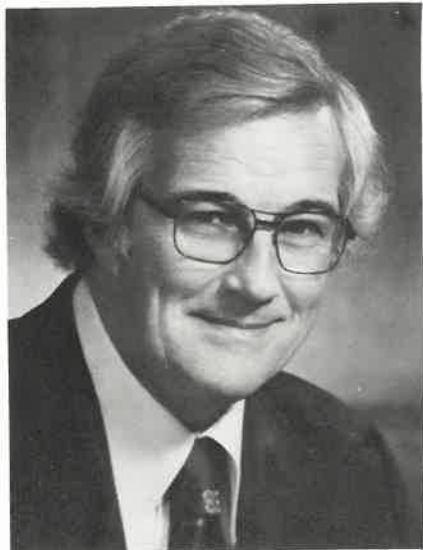

Each year as I sit to write this section of the Newsletter I find that there is more news to tell you than there is space to tell it in. However, it's always a delight to have the opportunity to greet our newest Fellows as well as saying hello to all our other members of the College.

This year we are planning an extraordinary series of visitations to "learn how" from our Fellows in Japan, Taiwan, Hong Kong, and Manila. The visitations will include tours through six dental schools which will include lectures and demonstrations of their techniques and processes. In turn we will have several of our own clinicians present a program that our Fellows in the Far East have requested from us.

I have been in touch with the deans of the Tokyo Dental College; School of Dentistry National Defense Medical Center, Taipei, Taiwan; and the University of the Philippines College of Dentistry in Manila. They all are looking forward to this truly international undertaking with great anticipation.

This will not be a fly-by-night operation just to receive a write off from the Internal Revenue Service. It will truly be a learning process for all concerned Fellows. I have already received invitations for our Fellows to visit in private dental offices in groups of five. We will arrange for specialists to visit offices of their specialties and G. P.s to visit theirs, etc.

The entire program is arranged so that social functions will be personal in design. Such functions are in fact a real and penetrating means by which the profession is advanced. At these functions each dentist will meet his counterpart on a very personal level and both will exchange greetings and professional information the same way.

May I refresh your memory and quote the first six objects of the I.C.D. constitution.

- a. To advance the science and art of dentistry for the health and welfare of the public.
- b. To encourage postgraduate study and research in the field of dental science and cognate subjects.
- c. To endeavor to unite outstanding members of the dental profession of the world for the purpose of fostering the growth and diffusion of dental knowledge and to encourage an exchange of good will among members of the profession.
- d. To cultivate and foster cordial relations among those engaged in the profession of dentistry and other health professions.
- e. To take whatever action is possible to cooperate with dentists and various organizations for the prevention and control of oral disorders.
- f. To maintain and elevate the dignity of the profession by the maintenance of the highest standard of ethical and professional conduct by its members who are enjoined to recognize their responsibility to participate in the affairs of society as citizens of the community and to willingly accept responsibility for committee service in the field of peer review, grievances, legislation and the like when requested and as appropriate.

That's what it's all about. Who could say it better? Our founders in writing our constitution let it be known that their thinking was truly international in quality.

So be it. If you want to expand your professional scope you will join us as we take our knowledge and skills to the Orient. In return we shall bring home new knowledge and skills that our Fellows in the Orient present to us. They are dedicated and brilliant professionals and we shall greatly benefit from their teaching.

events go along smoothly.

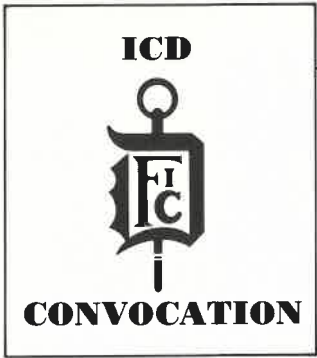

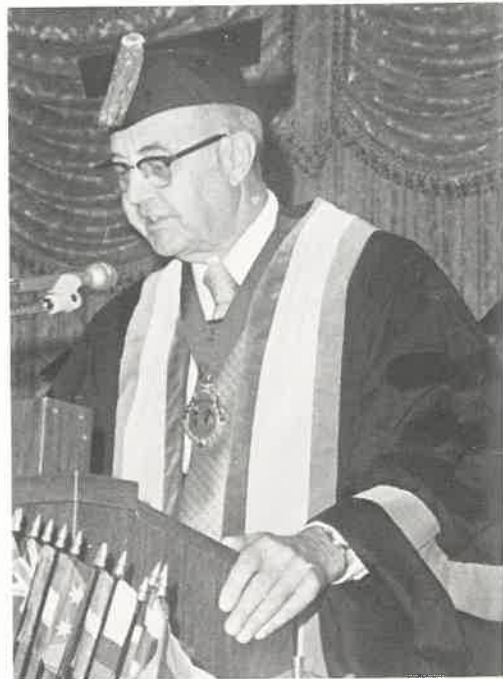

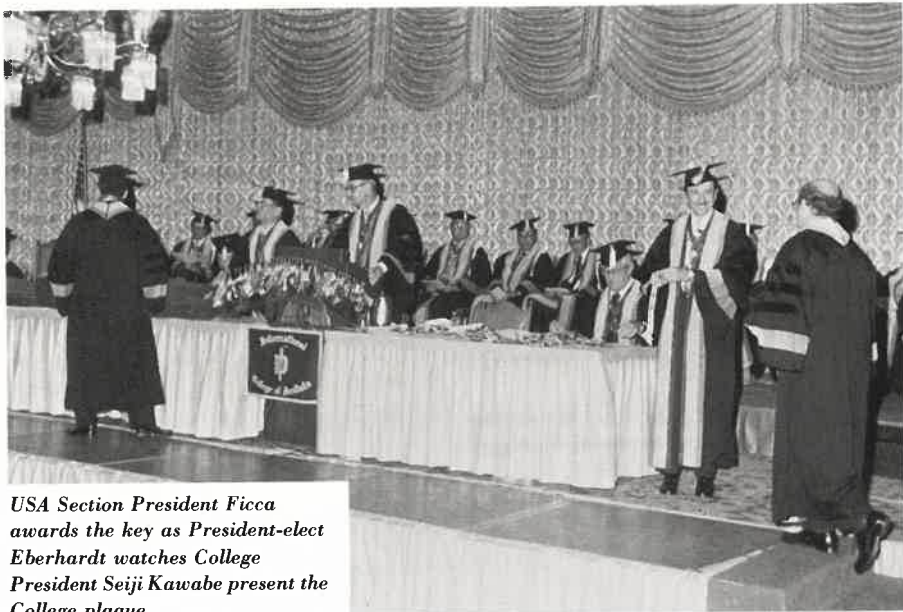

NOT AS A STRANGER

From no corner of the world does any doctor ever enter the International College as a stranger. In every case, several F.I.C.D.'s have been elected or appointed to assume the responsibility of knowing the man, of studying his qualifications, and of granting or withholding recommendations, according to a standard set by our constitution and approved by our membership.

The small numerical membership of I.C.D., which is deliberate in intention, contrasts interestingly with its world scope — a purposeful paradox. Never at any time does “exclusiveness” constitute the reason why hundreds of respected and well-endowed dentists who display an interest in the College are not granted Fellowship. Far from it. Instead, it is a matter of being “selective,” according to certain well-defined principles which have appeared to serve our profession usefully for many years.

Those who do become F.I.C.D.'s are appreciated for the honor they do the College. And they are fully aware of the honor implicit in their College key. Most importantly, they are people both able and willing to extend their own special areas of professional usefulness, with little thought of added personal prestige.

The F.I.C.D. does not flaunt his honor. Instead, he shoulders it with a humble sense of honorable dedication.

Men who have united in such a manner are likely to be personally congenial. The fact is, Fellows have a great time together! Since it is obvious that no dentist would be a part of the College unless he excelled in some area of professional originality or activity, the Newsletter does not, by policy, aim directly at reporting individual achievement on a technical basis.

We all like to know what the rest are up to. Yesterday's “stranger” on the other side of the world often becomes today's close colleague and friend, when Fellowship aims for the profession bring I.C.D.'s together. So it is purely on a “news” basis, to help you know the man himself, that at times your Newsletter touches upon special achievements. At other times, the publication takes achievement for granted and prints the latest fish story from the vacation lore of a man of distinction.

You make the newsletter NEWS, and through the informality and friendliness of your contributions, you make it a LETTER — a “round robin” of I.C.D. reporting that takes a wide global swing once yearly, then settles down in these pages.

The International College is respected throughout the world. We are guardians of its dignity, and proud of the challenge placed on us to live up to its standard in whatever we do. The dignity of the College is perpetually in our hands — but they are hands of friendship and mutual understanding, extended to our brotherhood throughout the world. This has meaning; we know it well. The Newsletter is one among many ways of implementing our purpose. When Fellow meets Fellow, it shall never be as a stranger.

The celebrations associated with the Fiftieth Anniversary of the incorporation of the College whilst giving grounds for justifiable jubilation and pride in achievement may also cause us to ponder and reflect on whether or not we have reached the goals set by those inspired founders of the College, Dr. Tsurukich Okumura who kindled the flame and Dr. Louis Ottofy, who together with his co-workers set up the administrative machinery for the conduct of the affairs of the College. To them we shall ever be grateful for their foresight and initiative in bringing the College into being.

Whilst it is now accepted that the original basis of selection of Fellows and the restraint placed on numbers, finance and role were somewhat restrictive, no-one can deny that the original intention of the College was that it be truly international. From the 300 membership ceiling we have grown to approximately 4500 in number throughout the world.

The College is indebted profoundly to the U.S.A. Section for having kept the College alive during the difficult period of the Second World War and to a large degree its more than generous financial support of the College since those desperate years. However, when we realize that approximately two-thirds of the College membership reside in the United States of America, can we believe that we are as fully representative internationally as may be desirable.

There is a vast untapped pool of dentists throughout the remainder of the world who must surely measure up to the strict basic requirements for admission to the College. My recent visit to Southern Africa and Central and South America confirms these thoughts. For example in West Africa-membership-nil; South and East Africa (and Rhodesia) 2; Bolivia nil; Guatemala-nil; and Brazil with a population of about 110 million people and some fifty dental schools, there are but fifteen Fellows. Can it be that we have suffered too long from the complex generated by the term "College-at-Large?" Now that this term of differentiation (not found in the original Charter) has been eliminated from the College vocabulary, this can no longer be an excuse for lack of development in those vast areas where there has been none or very little development in our fifty years of progress.

Since being elected President-elect and later as President I have three times circled the globe in addition to shorter related visits and at no expense to the College have visited practically every section of the College at least once as well as visiting a number of countries where we have no membership. I have therefore had the opportunity to develop certain impressions. The first overwhelming impression is that Fellows in isolated areas have an intense feeling of wishing to belong and to communicate. Even in countries where we have no membership, leading dentists show enthusiasm at the possibility of becoming involved in College activities.

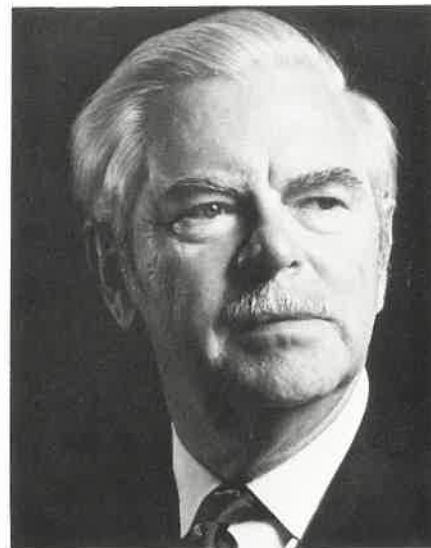
In an effort to further the ideal of communication certain of our Sections produce their own Newsletters in their own language and this is a practice which should be fostered.

Another outstanding impression gained is the need for dentists whilst retaining their justifiable strong patriotic feelings for their own country to nevertheless try to prevent nationalism from overshadowing international aims and obligations. Some Sections even feel that they are the College rather than just a Section of the College as defined by the Constitution and of course this is counterproductive from an international point of view.

On a purely personal level both my wife and I have enjoyed unbounding hospitality wherever we have visited and for this outpouring of friendliness we are truly grateful. The visits have been a two-way exercise because much time was spent not only in discussing every phase of College activity but additionally in wide-ranging talks on dentistry in general, its organization and administration. Some Sections have never before been visited by an officer of the College and it is hoped that this may be remedied as so much seems to have been gained individually and collectively by personal visitation.

Now that the basic structure of the College has been firmly laid by our new constitution, we must set our finances in order so that the College is not so dependent on the generosity of the U.S.A. Section and the good-will and financial sacrifice of its officers and councilmen who almost without exception attend Executive Council Meetings annually at their own expense from around the world.

Finally we have some critics who say that we are not truly international and others that once we have achieved fellowship within the College that we tend to rest on our laurels and just enjoy good fellowship and the social occasions which meetings of the College make possible. If there is any truth in these assertions, then the remedy is entirely in our own hands.

Your new PRESIDENT-ELECT, Cyril de Vere Green, was born in London, England, in June 1909. He was the first member of his family to become a dentist. During his early school days at Highgate and Brentwood, Essex, he showed great ability with his hands. Thus, it came as no surprise to his parents when instead of joining the family engineering firm, he decided to enroll as a dental student at Guy's Hospital. This he did in 1928 and received his L.D.S. R.C.S. degrees in 1932.

After qualifying, he became a House-Surgeon at Guy's Hospital and then felt he would like to complete his training with the addition of a D.D.S. degree at Toronto.

On his return to England, he brought back not only another degree, but a charming wife, whom he had met at the Dental School in Toronto. He was appointed to the teaching staff at University College Hospital in 1936 and in 1967 became Dean of the Dental School. The National Hospital for Diseases of the Heart made him a consultant in 1937, which post he held until 1974.

From 1934 until 1976, except for four years' service in the Army Dental Corps, he was in private practice at 11 Devonshire Place, Wimpole St., London W.1. It was in this house that my brother and I grew up and at all times it was a happy one, full of the sound of music and the voices of friends, many of whom came from all over the world and spoke different languages. They never failed to receive a warm welcome from both my parents, who are the most hospitable people I have ever met.

Professional societies have always played an important part in my father's career. He has not only been an enthusiastic member but has worked through the executive posts to the presidencies.

He is now past-president of the Metropolitan Branch of the British Dental Association, the British Society of Periodontology, the American Dental Society of London, the American Dental Society of Europe, and the European Section of the International College of Dentists. Although an Englishman, he was appointed President of the Canadian Universities Society of Great Britain. He took a very great interest in the University College Hospital Dental Society and became its president eight times.

Over the years, he has traveled extensively and delivered scientific papers throughout Europe, U.S.A., Canada, Is-

rael and Lebanon. He became a member of the American College of Dentists in 1961. In 1969, he had the honour of being invited to deliver the first Pierre Fauchard Academy Memorial Lecture in New York. Subsequently he was made an honorary member of the P.F.A.

In 1973, he was proud to receive the Elmer Best Award from the U.S.A., presented to him by Ambassador Walter Annenberg at the United States Embassy in London.

With all his professional activities one might reasonably suppose that he had little time for hobbies, but this has never been the case; as a man of boundless energy, even when on holiday with his family, he enjoyed sailing a catamaran, and driving a fast speed boat for water-skiing. He rarely found time on the lovely Italian lake shores to sit in a deck-chair!

However, busy as he always was, he managed to find time to take his private pilot's licence and became a member of the Medical Pilot's Association in 1961.

His collection of musical boxes made over the years and now housed in Utrecht led him to become the founder of the Musical Box Society of Great Britain and to acquire the friendship of hundreds of musical box collectors in the world. Not only did they come to visit his collection at home but he has lectured on this hobby many times, particularly in the U.S.A.

A few years ago, he became a Liveryman of the Worshipful Company of Fanmakers and a Freeman of the City of London.

Since retirement, he enjoys attending international dental meetings where he meets old friends and colleagues. I am certain that he will always be an interested and helpful member of his profession, with his long experience, not only in active dentistry giving of his best service to his patients, but also in committee work and in teaching.

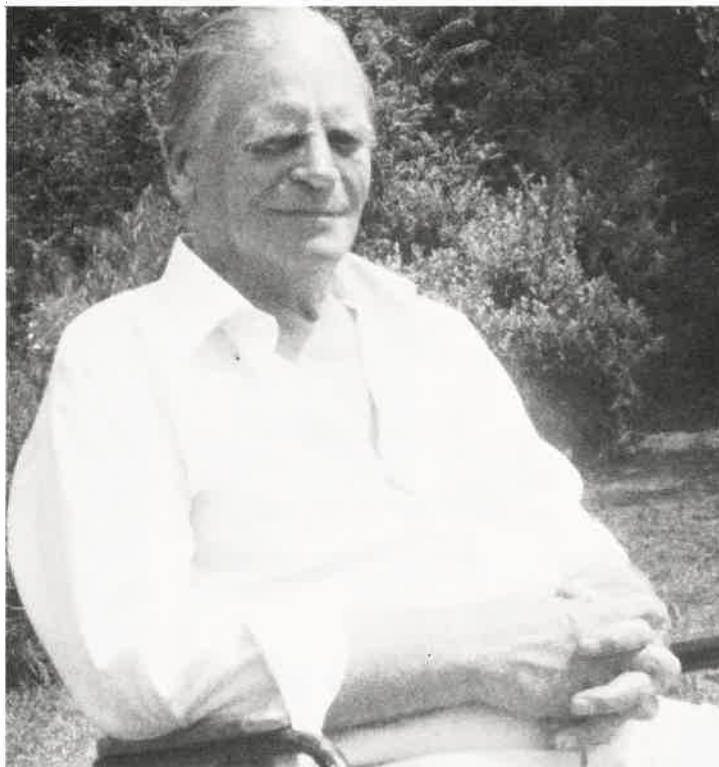

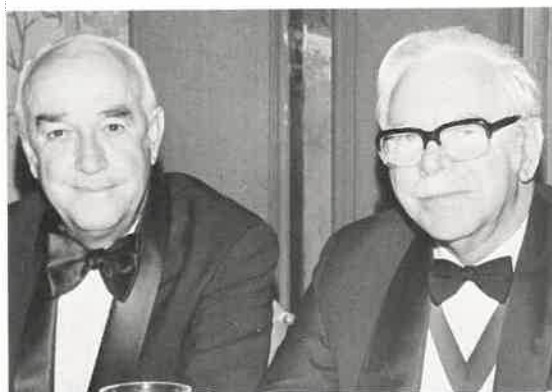

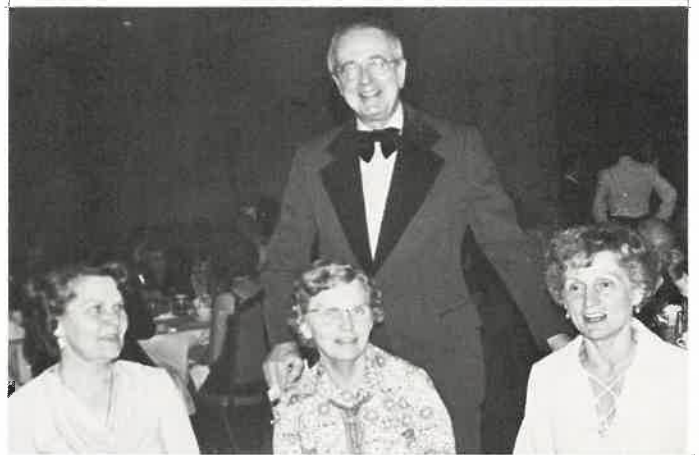

EDWARD M. MIMMACK



DR. EDWARD M. MIMMACK

Dr. Edward M. Mimmack, past president of the U.S.A. Section of the International College of Dentists, past president of the State District Society of New York, member of the Board of Governors of the State Society, president of the Dental Alumni Association of the University of Buffalo Dental School, president of the General Alumni Association of the University of Buffalo, Supreme Grand Master and Supreme Treasurer of Delta Sigma Delta, trustee and 2nd vice president of the American Dental Association. It goes without saying that he has made many contributions to the International College.

Ed Mimmack graduated from the University of Buffalo Dental School in 1921 and went into practice that fall with his father, Alfred E. Mimmack, who was a member of the first class at the University of Buffalo.

At college he was captain of the track team for two years and after college was made a member of the Athletic Committee and served as president from 1927 to 1932.

In 1925 Ed married Frieda (Fritz) Jacobs, whom, he says, has shared his ups and downs and putting up with him ever since. Both Fritz and Ed are members of the Westminster Presbyterian Church where Ed is an elder and Fritz is active in many church activities. They have traveled all over Europe and the Far East. They have two children, a son, Jack, (also a member of the ICD), and a daughter, Margot. They have four grandchildren.

Among the many honors Ed has received are, The Chancellor Samuel P. Capen Award, which is the highest alumni award given at the University of Buffalo and also the 125th Anniversary Award of the University of Buffalo in 1971. He also treasures the Man of the Year Award of the Dental Alumni Association he received in 1955, and the prestigious Jarvie-Burkhardt Award from the Dental Society of New York at its 1976 meeting.

Recipients of Honorary Fellowships

L. M. (BILLY) ANDERSON, JR.

Born October 27, 1913 in Tampa, Florida and attended the University of Florida in 1932-33. He is currently the Chairman of Codesco, Inc., a subsidiary of International Corporation of Philadelphia, Pa, but is based in Florida, and also serves as Chairman of the Exchange Bank of Westshore in Tampa.

When the American Fund for Dental Education was formed many years ago and the American Dental Trade Association was one of its sponsors, the ADA set a quota objective for ADTA to raise from its membership that first year \$100,000 and Anderson and his colleagues raised \$125,000. The beginning of a fund which today stands in excess of \$3 million.

Mr. Anderson, Jr., was one of seven members of the founding group of the L. D. Pankey Dental Foundation and helped the Foundation procure for the Pankey Institute's operation an 18-chair dental suite with practically no cost whatsoever to the Foundation. (No cost to the Foundation, but with a value in excess of a quarter of a million dollars).

When the School of Dentistry at the University of Florida expressed its need for a continuing education clinic, Mr. Anderson, Jr., joined by his brother and sister and company contributed \$60,000 to the School of Dentistry and leveraged that contribution into a \$125,000 dental clinic. With the aid of the late Al Puritan, Mr. Anderson helped start the Florida Academy of Dental Practice Administration.

He is the recipient of three Certificates of Recognition from the Chicago Dental Society, the 1971 Award of Recognition of the American Society of Dentistry for Children, special recognition from the President of Rotary International, the Community Leadership Award of the Committee 100 and Community Leadership Award from the Greater Tampa Chamber of Commerce, Tampa, Florida.

At the present time Mr. Anderson serves as a Consultant to the ADA Council on Dental Care Plans for the dental industry; is a consultant to the Executive Committee of the Pankey Foundation and is a member of the Board of Counselors of the University of Southern California School of Dentistry.

BERNARD J. BEAZLEY

Mr. Bernard J. Beazley, is a native of Chicago and a graduate of the law school of Loyola University (Chicago). Mr. Beazley is a member of national, state and county bar association. He has been awarded an honorary membership in the American Dental Association and in the Chicago Dental Society. Mr. and Mrs. Beazley and their children reside in York, Pennsylvania.

Mr. Beazley was first employed by the American Dental Association as secretary of the Council on Dental Trade & Laboratory Relations. As secretary, Mr. Beazley represented ADA in discussions with the Department of Justice on the federal grand jury study of the dental laboratory accreditation program (1957-60); discussions and presentations to the Federal Trade Commission resulting in the modification of the FTC's trade practice rules for the commercial dental laboratory industry, 1955-57; and in the negotiation between ADA and NADL which led to the present certification program for dental laboratory technicians. Mr. Beazley also served as secretary of the Council on Federal Dental Services (1955-57). For approximately 3 years after his employment by The Dentists' Supply Company in 1957 he served as a consultant to the ADA. Mr. Beazley has served for many years as a member and as chairman of the Professional and Laboratory Relations Committee of the American Dental Trade Association. For many years he was chairman of the AFDH Scholarship Committee for Dental Laboratory Technology and chairman of the Battelle Institute Subcommittee which dealt with licensure of the dental laboratory technician and laboratory facility. He now serves as a director and a member of the Executive Committee of ADTA, and as treasurer, director and a member of the Executive Committee of the American Fund for Dental Health.

In addition Mr. Beazley has been director of: Catholic Social Services (Harrisburg Diocese), United Community Service of York, National Dental Laboratory Scientific and Educational Foundation, Dentsply International Inc.

PAUL A. TOUSSAINT

Born on March 26, 1917 in Berlin, New Hampshire. Educated in local schools, the University of New Hampshire and Boston College of Law School receiving LLB degree in 1942.

Served in the European Theater during WW II, receiving a field commission. Recalled to active duty during Korean War. Throughout both tours of duty served in the infantry except for WW II when assigned to Army Specialized Training Program (principal areas of study being France and Germany), followed by Military Intelligence Training at Camp Ritchie, Maryland.

Between military tours of duty, engaged in general practice of law and was elected and served as Mayor in the city of Berlin, New Hampshire from 1947 to 1951.

In 1952 he became a professional staff member, Senate Committee on Appropriations, which entailed many trips abroad to investigate the Foreign Assistance Program.

Joined the Department of State in 1955 as a Foreign Service Officer. Assigned from 1961 to 1963 as Special Assistant to the U.S. Ambassador in Saigon, Viet-Nam. Upon return to Washington, D. C., became Executive Director, Bureau of International Organization Affairs, until retirement in 1970. Continued as consultant on grievances with the department for two years after retiring. Became associated with a Washington, D. C. law firm and presently engaged in private law practice.

Membership in New Hampshire Bar, District of Columbia Bar, Supreme Court of the United States, Interstate Commerce Commission, United State Court of Military Appeals, Kentucky Colonels, Veterans Organizations, the Foreign Service Association and the Pierre Fauchard Academy.

Paul has assisted the ICD in many ways over the past years through his vast experience and knowledge of foreign affairs when called upon for counsel and assistance in foreign travel.

BERNARD J. DEGEN, II

Bernard J. Degen, II of Chicago is the Executive Director of the American Society of Oral Surgeons. In his capacity as the chief executive and administrative officer, Mr. Degen coordinates the agencies and operations of the Society, which is comprised of more than 4,000 members and residents in the specialty of oral surgery. His duties encompass the entire spectrum of the specialty's interests and activities at the national level including liaison with health organizations such as the Joint Commission on Accreditation of Hospitals and federal agencies. In addition, he acts on behalf of the President and Board of Trustees in administering oral surgery interests with both Chicago and Washington legal counsel, investment counsel and matters relating to dental health and hospitals. Mr. Degen joined the Society in September, 1966 and oversees a headquarters staff of fifteen including six executives. 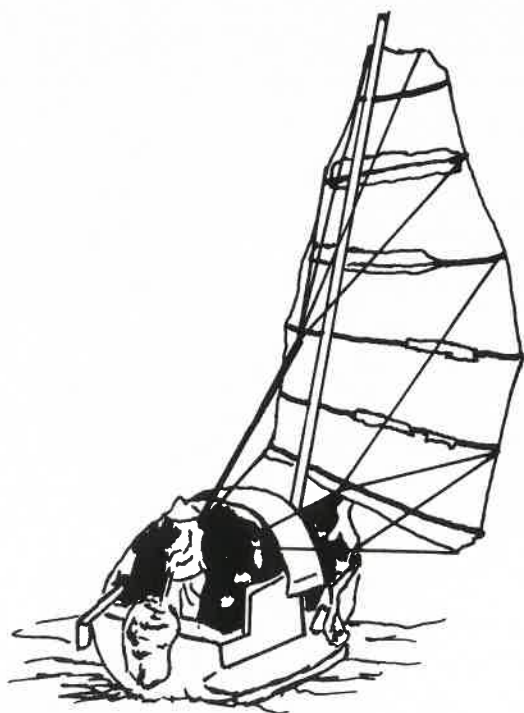

Paul H. Loflin is a native of Beckley, West Virginia, where he was born on August 26, 1924. He attended Marshall University, Huntington, West Virginia, from 1942-1944 and graduated from the Baltimore College of Dental Surgery, University of Maryland in 1948. He served as a dental officer in the United States Naval Reserve on active duty 1948-1950, and was recalled to active duty for the year 1953. He returned to private practice in Beckley, West Virginia in 1954 and was elected Vice-President of the New River Dental Society that year and served as President of that component society in 1956. He was elected New River's delegate to the Executive Council of the West Virginia Dental Association in 1957 and 1958. In 1960 he was elected Secretary of the constituent society and held this office until July, 1967, when he was elected Vice-President. He served as President of that Association 1969-1970. During this time Dr. Loflin also served as a delegate to the American Dental Association House of Delegates and in this capacity was appointed a member of two Reference Committees (Dental Trade and Laboratory Relations and Public Health).

He was chosen by the Visiting Scholars Program of the College to present a paper on Modern Restorative Dentistry with rubber dam at the Iranian Dental Congress. The Congress was held in Tehran, Iran on August 19-26, 1976. His participation was a one hour presentation to the general assembly and a three hour continuing education course.

Paul is a charter member of the Academy of Operative Dentistry and served on its original governing board and the Executive Council until 1976. He now is a member of the Armed Forces Liaison Committee.

Paul was appointed as a consultant in Operative Dentistry to the American Dental Association Council of Devices and Dental Materials in 1976.

Murray Gavel and Edward M. Mimmack; College Treasurer Daniel C. Kamas, and Margie M. Prosser, Central Office Secretary.

Chairman Eberhardt called for a reading of the Minutes of the past meeting and Registrar Kenward read those of the executive committee meeting held in Chicago, last February. The minutes were approved as read.

Registrar Kenward reported on his year in office, which was received with commendation. A moment of silence was observed for the 40 members that passed away since the last meeting. Regent Hudson notified the meeting that Mrs. Charles Berger had passed away two days earlier, Dr. Berger was the recipient of the Degree of Master during the ICD meeting in Las Vegas 1976.

President Ficca gave his report which was received with interest and praise.

Treasurer Reifke reviewed the Annual Audit and financial position of the Section.

There followed an up-date of the Regents Reports. Regent Kershaw of District One commented on the quality of the latest Newsletter sent from the Central Office.

Regent Giordano of District 4 expressed his concern over the Officers of the Government Services having been transferred from the Washington, D.C. area.

Regent Rice of District 7 announced that they had just come out of a state meeting in Ohio where Treasurer Reifke was honored as the "Man of the Year" in his home state of Ohio.

Regent Collings of District 11 reported on his efforts to put together a Scientific and Educational Meeting with District 11 Fellows and Vancouver Fellows in Canada.

Howard Hartman reported for the Publicity Committee and the work that had been accomplished since the Las Vegas Meeting last November. Approximately 225 photographs were made, and a copy of each was sent to the Registrar and subsequently to the editor of the Newsletter. Photographs of honorees and officers were sent during the year to newspapers of their local communities and each photograph carried appropriate legends with it.

Along with the aforementioned photographic activities, photographs showing Jeanette Robbins being honored, Ken Groves in his College activities both at the Greenbrier and the 1976 Convocation, and also Charles Berger, were sent to each of the families of these individuals. In the case of Jeanette Robbins the photographs were made in triplicate so that each of the children could have one.

At the request of Registrar Kenward, Hartman had extended greetings and felicitations of the United States Section of the College at the opening session of the Anglo-Continental Dental Society in London the past May, and also at the opening luncheon of the European Society of the I.C.D.

There was a general discussion of the Visiting Scholars Program, and Jack Hein was made chairman of a committee to re-evaluate the program, and to have a report for the Board of Regents at the mid-term meeting next July.

The question of clarification of the Life Membership By-Law in our new Constitution and By-Laws has raised some question in the Central Office, and it was unanimously agreed that the by-law go back to the constitution and by-laws committee for clarification and a report to be given at the mid-term meeting.

A discussion of the titles to be recognized at the Convocation was held and it was agreed that no titles would be recognized at our convocation and induction ceremonies.

The executive committee recommends that annual dues for the U.S.A. Section be increased from \$35 to \$50, as there is a need for increased revenue to support college activities. It was noted that this increase only brought our dues up to that of similar organizations.

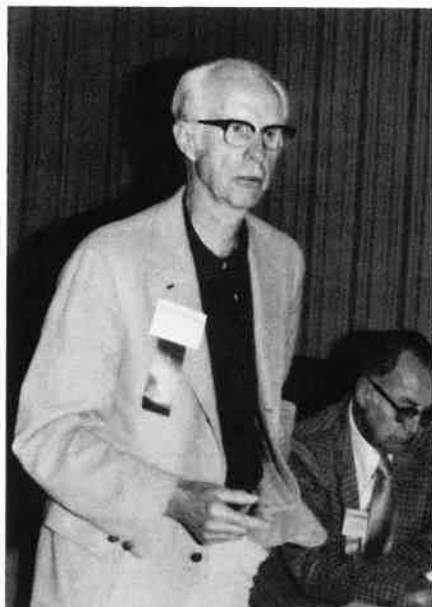

Registrar Kenward's recommendation for the Regents to establish an H.O. Westdahl Award to be presented to the outstanding district of the U.S.A. Section was discussed, and it was agreed to establish the award, not a monetary one, but recognition only. The district to be selected by the executive committee with the cooperation of the central office.

There was a discussion of the use of our funds given annually to the American Fund for Dental Health. It was recommended that the Registrar write the AFDH to see if we might specify how our funds to them would be used.

The Registrar's recommendation that the roster be printed every other year was discussed in detail. It was agreed that the roster would be printed every other year, with a supplement on the alternate year. The supplement to include new officers, regents, deputy regents, counselors and editors, as well as a list of the life and deceased members.

Gordon Agnew, Editor of the Scientific and Educational Journal gave his report on the plans for the journal. Following this report it was agreed that the President would appoint a committee to review the Scientific and Educational Journal, as to Editor's salary, editorial content, printer's fees, and this report to be available at the mid-term regents' meeting. It was further agreed that the Registrar so inform the executive council of the college.

It was recommended by the executive committee that the mid-winter meeting of the executive committee be distributed around the country rather than held annually in Chicago. The districts were encouraged to invite the committee to meet in their area.

The executive committee's recommendation to set up a roster of visitations by the President and President-elect received the full support of the Board of Regents.

It was agreed to have a mid-term regents meeting next July, probably in Minnesota.

The executive committee's recommendation to pursue with the Internal Revenue Service the possibility of changing our accounting procedures from a fiscal year to a calendar year carried.

The budget was reviewed item by item. The following interim resolutions were discussed and carried as follows -

- a) That for calendar year 1978 we have only one issue of the Scientific and Educational Journal.
- b) That the U.S.A. Section address the College to develop a budget which covers the College Journals and inform us of our share.

Al Seyler, Chairman of the Journalism Awards Committee, submitted his report which noted that the winners of the 1977 ICD Journalism Awards were presented with plaques of recognition at the 1977 Conference on Journalism sponsored by the A.D.A. Council on Journalism, held March 28-29, 1977 at Portland, Oregon. A total of 16 plaques were presented.

Regent Collings reported on the membership evaluation report compiled from data received from the central office, to July 30, 1977. This information includes transfers, life members and deceased members that were received for the six month period, from January through July. The report showed the greatest number of members in all districts were between the ages of 50-59. Second largest membership from ages 60-69.

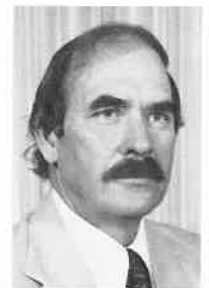

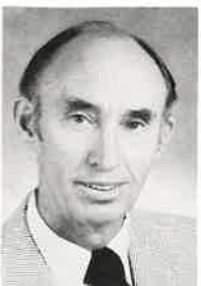

President Kawabe turned the meeting over to Secretary-General Kenward who acted as Chairman.

President Kawabe reported that he visited the Philippine Section on February 8, 1977 on their 10th Anniversary ceremony.

As the 8th Asian Pacific Dental Congress was taking place at the same time, Officers and Regents such as the Australasian Section President, ICD President-Elect A.

Gordon Rowell, and others from Hong Kong, Malaysia, Singapore, Taiwan, India, etc., had the opportunity of getting together and exchanging fellowship.

Secretary General Kenward accepted on behalf of the College the oil portrait presented by the Japan Section of Tsurukichi Okumara, co-founder of the College, and will display it in the Central Office.

Secretary - General Kenward read the minutes of the prior meeting held in Las Vegas in November of 1976, and reported on his activities of the past year. He participated in the Asian Pacific Dental Federation meeting in Manila and presented a scientific lecture on "New High Copper-Content Alloys". At the same time President Santos of the Philippine Section presented the College with an oil portrait of the founder of the College, Louis Ottofy.

He also visited with Regent William Wong in Hong Kong and attended a dinner with the Hong Kong Fellows and their

wives. Kenward advised that the Visiting Scholars Program's first lecturer would be Motohiko Katoh from the Japan Section to the United States.

The membership in the College is 4365, and after the Convocation on Saturday, October 8, it will be 4564.

Treasurer Kamas reported on the financial position of the College and his report was accepted by the Council.

Editor Agnew reported on the ICD Scientific and Educational Journal. He plans to come out with a striking new cover design for our 1978 issue, in honor of the 50th Anniversary of the College.

The Japan Section had underwritten the cost of sending the Journal to each of the Schools of Dentistry in Japan.

At this time the Acting Chairman Kenward read a letter from the American Association of Dental Editors stating that Editor Gordon Agnew was being honored as their "Editor of the Year".

Acting Chairman Kenward read the report of the Canadian Section submitted by Registrar Spence.

The Canadian Section is now composed of 187 Fellows, 37 Life Members and 4 Honorary Members. They plan to hold their Convocation and Induction ceremony in Toronto, Canada during the annual meeting of the Federation Dentaire Internationale. They plan to induct 17 new Fellows, and one Master at this meeting.

The Canadian Section gave a total of eleven Scholarship Awards, one to each Canadian Faculty of Dentistry, in the name of the College. They will also give the First

Teacher of the Year Award in each Faculty this year.

Regent Edmund O'Brien-Moran of Wexford, Ireland, gave the European Section's Annual Report. The Board of Regents had met twice during the past year to deal with a heavy agenda and had discussed the Visiting Scholars Program, but the Board regrets that it would not be able to participate in the program this coming year due to a financial problem, but hopes to participate in the near future.

Councilman Abraham Chisikovsy reported for the Inter-American Section. They have 90 members now, including 35 new Fellows to be inducted October 29, and a new Honorary Fellow also to be inducted.

The Inter-American Section has reorganized their Districts. Instead of having North, Central and South Districts, they now have 12 Districts with one Regent for each.

President-Elect Rowell reported the Australasian Section stands at 121 Fellows, this includes Honorary members. They now have 30 candidates under consideration which includes 7 candidates from New Zealand. Life membership has been granted to 3 more Fellows, with a total of 11 life members for the Section.

The principal feature of the year under review was the attendance of a considerable number of Fellows at the Regional Conference of the F.D.I. held in conjunction with the 8th Asian Pacific Dental Federation Congress in Manila, February 7-14th, 1977.

Secretary-General Kenward reported

for the India Section in the absence of Councilman Manchanda.

This marks the completion of 14 years as an Autonomous Section of the International College of Dentists for India. They began with 56 Fellows and their membership is now 146.

Secretary-General S. Bratt retired after many years of service to the College and was so honored by the members at their annual Convocation ceremonies.

The Board of Regents amended India's Constitution to create a New Zone, and to appoint a Zonal Regent for Sri Lanka, (Ceylon). The Regent for Sri Lanka is Wg. Cdr. Goonesinghe.

The Section has requested their Membership to abide by the India Government's notification that they do not recognize the International College of Dentists in that country. The Section has asked the Dental

Council to reconsider this decision and they hope to resolve the problem in the near future.

The Japanese Section report was given by Minoru Horiuchi. Japan now has 243 Fellows, including 22 new Fellows and three Fellows had died during the year.

Activities of the Japan Section included a year-end meeting and Christmas Party to help promote mutual friendship of all members of the Section and their families. They issued an invitation to all dental students from Southeast Asia and a few other countries who are studying in Japan and researching dentistry. They held a mid-winter conference in March.

Japan plans to send a visiting scholar to the United States for a series of lectures, to have a Mid-Winter Conference, to continue publication of their Journal, and three issues of their Newsletter. They are also working on revisions of their Constitution and By-Laws to conform to the new revised one of the College.

Councilman Tamari reported that the Middle East Section is working on a new Constitution and By-Laws to conform with the needs for the Section and its geographical distribution. They elected Dr. Joe Tamari to serve as a Visiting Scholar this year and appointed Dr. Charles Tager to draw up a set of Rules.

The Middle East Section requests the College to make the states along the Persian Gulf a part of the Middle East Section. It was agreed to list the Persian Gulf Area as part of the Middle East Section.

Dr. L. Kardjian will act as Deputy Registrar of the Section and help in coordinating the activities with Lebanon, while Registrar Tamari will continue transacting the busi-

meritorious and outstanding.

The Section is working on making their By-Laws consistent with the ICD's amendments. They now have 46 members consisting of 39 regular Fellows, 3 Masters, 3 Life Members and one Honorary.

General Items concerning the College

The U.S.A. Section's International Clinicians Program and how it pertained to each Section of the College was discussed in detail.

Secretary-General Kenward has written all the Secretaries of the Autonomous Sections for their plans for our 50th Anniversary celebration. The U.S.A. Section Convocation and Banquet will be in Anaheim at the Disneyland Hotel, next October 21, 1978.

A discussion of the College finances was held, and how the U.S.A. Section had contributed so much to the College, especially to the printing costs of the Scientific and Educational Journal. It was agreed to supply the Council with a statement to cover the expense of running the office, in an effort to determine the responsibilities of the College. To be included also in the statement is a complete breakdown of the dues paid by each Section as well as the number of dues-paying members in each Section.

A very thorough and lengthy discussion was held on the costs of producing the ICD Scientific and Educational Journal. It was unanimously agreed that until the College finances are more defined, that only one edition of the ICD Scientific and Educational Journal be published a year, and that the U.S.A. Section be notified of the College's decision in this matter.

The International College of Dentists is an honorary organization whose aim and purpose is to recognize conspicuous and meritorious service to the profession of dentistry.

In November of 1920 a number of Japanese dentists entertained Dr. Louis Ottofy on the occasion of his departure from the Orient after 23 years of dental service.

Several of those present stated it was difficult to secure information concerning dentistry in many parts of the world, especially the less populated areas. They decided that there ought to be some way to bring dentists, especially those who are not able to frequent dental meetings, into some sort of contact, in some kind of international organization.

At a dental meeting in Philadelphia in 1926 several of Dr. Ottofy's Japanese friends reminded him of his promise made several years ago. In Dr. Ottofy's own words he "promised to do something about it." He drafted the rules and devised the plans for the College which was incorporated under the laws of the District of Columbia on July 9, 1928.

On December 29, 1929, a new Certificate of Incorporation was obtained and at that time the following objectives of the College were brought to the attention of the Fellows:

1. To cultivate and foster cordial relations among those engaging in the practice of the arts and sciences of dentistry, and of medicine, and collateral branches in all parts of the world.
2. To cooperate with dentists and various organizations in the interest of progress in the arts and science of dentistry.
3. To contribute to this end, the College shall endeavor to unite into one compact organization the dental profession of the

world for the purpose of fostering the growth and diffusion of dental knowledge.

4. To establish and maintain a high standard of competency and character for the practitioners of dentistry.

5. To uphold and maintain a high standard in dental education and in regulating the practice of dentistry.

6. To foster and aid in the clinical practice of dentistry, especially in the relationship to hospital practice.

7. To perpetuate the history of dentistry and to raise and maintain high standards of ethics.

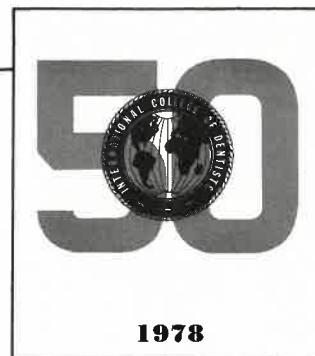
8. To foster measures for the prevention of disease resulting from dental dis-

orders, and to encourage postgraduate study.

9. To maintain the dignity of our profession in its relations to the patient, to interest and instruct the public in dental hygiene, and attempt to secure a higher appreciation of the aims of the dental profession.

10. To provide a method of granting Fellowship in this institution.

As the years progressed the membership of the U.S.A. Section grew in the ratio of 2.5% of the American Dental Association membership. Great care was exercised to maintain equal geographic distribution of membership. The membership evaluation committee also stressed a balance of all age groups in candidacy for membership.

Along with the growth of the membership the U.S.A. Section accumulated sufficient funds to enable it to embark on special projects. A thorough study was made of projects that would be desirable, financially feasible and of benefit to both the profession and the College. Some of the projects that the U.S.A. Section has supported are as follows:

1. Present a bronze-on-wood plaque in each U.S. Dental School, wishing to participate, to the graduating dental student who is deemed to have shown most professional growth and development during his years of dental study.

2. Make a total grant of \$1500 to each U.S. Dental School for loan to senior dental students. The maximum loan per student will be \$300 and repayment is to

be made within 3 years after graduation so that the fund in each school will be self-perpetuating. It was voted that the loan program will be offered to new dental schools as senior classes of students make them eligible.

3. Support with \$10,000 creation, with the American Association of Dental Schools, of a colored, animated exhibit (film and audio) to aide in recruitment of dental students.

4. In 1965 the Board of Regents voted substantial grants to the American Fund for Dental Education and to the S. S. Hope, which have been renewed annually. In 1966 a 3 year research grant was authorized for W.H.O. In 1970 a grant was voted for the Harold Hillenbrand Foundation, which is expected to be made annually.

5. In 1969 it was voted to financially support, with the College, a scientific publication to be edited by R. Gordon Agnew, professional contributions to be made by Fellows of the College from every area. This is sent annually to every Fellow of the College.

6. In 1968 it was voted to support, with the College, the mailing of quarterly issues of Dental Abstracts to all Fellows of the College outside the U.S.A. and Canadian Sections, and this support has been renewed annually.

7. In 1968 it was voted to support transportation costs for teaching programs of International Clinicians to dental groups in other countries where requested to be arranged by Fellows of the College.

8. It was voted in 1970 to inaugurate an award program to recognize excellence in dental journalism, the first awards were made in 1972.

9. In 1973 it was voted to support, with the American Student Dental Association, a student exchange program between five U.S. and five foreign dental schools.

Each year on the Saturday preceding the American Dental Association national convention the U.S.A. Section holds its formal Convocation and Induction Ceremony. This official cap and gown ceremony is held at 1:00 p.m., and a formal banquet is held the same evening to honor the new Fellows. Fellows from all Sections of the College are invited to attend.

Every year the Central Office receives many requests for information on requirements for admission to the College. These requests are referred to the appropriate Sections of the College for review and action.



District 1 News

At the Annual meeting in Miami, District 1, USA Section had a breakfast meeting on October 8, 1977. At that time it honored the out-going President of ICD, **DR. SEIJI KAWABE**. Many friends outside of District 1 came and we had good fellowship.

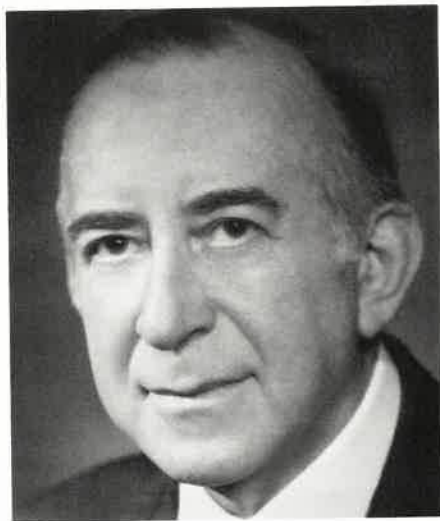
RICHARD PASSWATER presented a timely topic entitled, "How to Live Longer Better". The audience learned with great joy that from now on they would all be able to

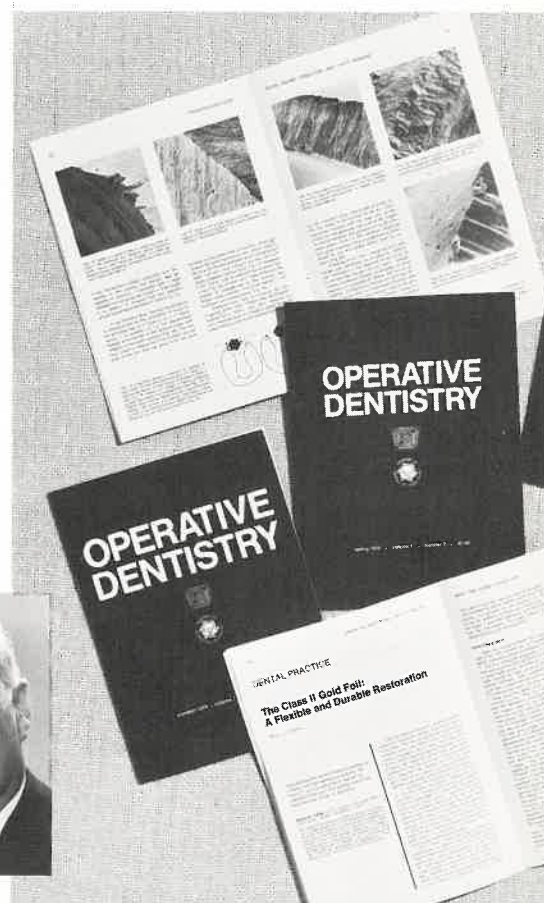

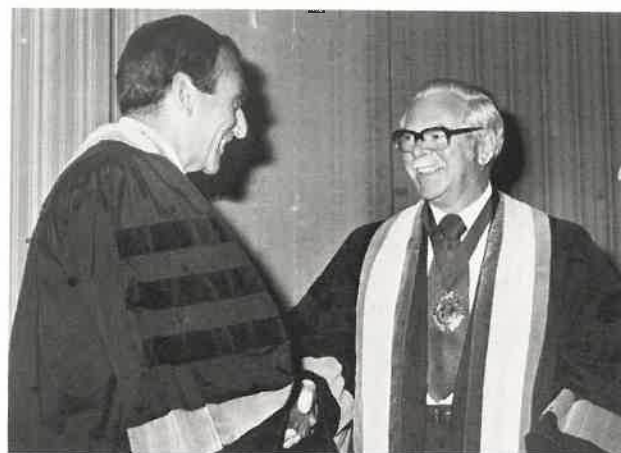

India Section

This year we will have completed fifteen years as an Autonomous Section. It was in mid 1963 that the India Section of the International College of Dentists, as an Autonomous entity came into being. We started with 56 Fellows on our rolls and in the course of 15 years, we are now 146.

The Annual Convocation is held every year when we have a dignified and attractive function to induct the new Fellows. Due to the cyclone in the South, we could not hold our Annual Convocation at Guntur (Andhra Pradesh) during December of 1977; however, it was held on February 26, 1978, in Delhi.

Our last Annual Convocation was held at

Poona Club, Pune, when our Indian Dental Association was also having their Annual Conference in Pune. We had a very successful function at Pune where the elite of the society and many renowned Dental Surgeons from all over the country were present at the Convocation.

The other touching and significant event at the function was the retirement of our veteran Secretary General, **S. BRATT**, who handed over the office to **JAGDISH CHANDNA** who had already been working with him as Deputy Secretary for many years.

At the Annual Convocation, he was given a standing ovation and President **NOSHIR KAPADIA** presented a citation to him. He was presented with a beautiful Silver Salver and other small mementos. The Board of Regents designated him as Secretary General Emeritus and made him a member of the Board of Regents for life.

The India Section of the International College of Dentists have been conducting two Essay Competitions every year: the **DR. R. AHMED** Essay Competition for Dental Surgeons and the I.C.D. Essay Competition for Post Graduate Students. However, this year two more competitions have been started, the Ranbaxy Award for all House Surgeons and the Alarsin Award for all Dental Surgeons. With the addition of these two, we now cover: Dental Research, Dental House Surgeons, Practising Dental Surgeons, Students and Post Graduate Students.

The Board of Regents in the last meeting amended the Constitution to create a new Zone for Sri Lanka (Ceylon) and to appoint a Zonal Regent. This will give more opportunity to Dental Surgeons in Sri Lanka for active participation in the College activities. The Regent for Sri Lanka Zone is **WG. CDR. GOONESINGHE**.

The only problem which our College faces in India is the recognition of this Fellowship (FICD) by the Government of India. Due to some unfortunate reasons, the Dental Council of India has recommended and the Government of India has approved that abbreviations like FICD, MICD, FACD etc., are not allowed to be used along with the name of a dentist. We have already issued instructions to all the Fellows to abide by the Government of India's notification, but have asked the Dental Council to reconsider this decision again as there is no ban in medical profession by the Medical Council of India. tal Council only creates disparities between the medical and dental fields. We are going ahead to resolve this problem.

ject Hope has an extensive dental program planned for Egypt during the next four years which includes many of the specialty areas of the profession along with corresponding refresher courses.

During his assignment **GEORGE** presented lectures and seminars to dental students, prosthodontic postgraduates students, faculty and public health dentists at both Cairo and Alexandria Universities.

Africa -

BASHIR A. QURESHI of Nairobi, Kenya was awarded an honorary citation by the International Circuit Courses of the American Prosthodontic Society. **QURESHI** is a member of the World Health Organization and acts as Secretariat for Dental Health in Africa.

Egyptian Health Care Program

For the past 18 months Project Hope has been involved with health care programs in Egypt, one of which has related to establishing a Maxillo-Facial Prosthodontic Reconstruction Program. **W. ARTHUR GEORGE**, Associate Dean of the University of Pittsburgh, School of Dental Medicine was asked to go to Egypt for three months to determine the feasibility of such a program and if applicable to determine what was needed to get one started. Most of his time was spent in Alexandria where the potential for getting started was greatest; however, the needs are greater in Cairo where the population is five times that of Alexandria. Plans are now in motion for Project Hope to send a Maxillo-Facial Prosthodontic team to Egypt in October to begin treating patients who have suffered from major diseases and traumatic injuries to the head and neck.

As in most developing countries, dentistry has received less attention than has the field of medicine. The Dental Schools in Cairo and Alexandria suffer from overcrowding, out-dated equipment and a shortage of faculty. However, new buildings are under construction at Alexandria and Tanta, with extensive renovations scheduled for Cairo. Another major need is for dental equipment repair personnel to keep the present equipment operable. Pro-
