The recently concluded I.C.D. Orient Dental Sessions provided many new experiences, intellectually and emotionally, as well as physically, for the 96 member dentists, their families and friends who participated. Additionally, it served to illustrate most graphically the purpose of the College outlined by its founders, Dr. Louis Ottofy and Dr. Tsurukich Okumura, 50 years ago, that of "determining the progress being made by the dental profession in all parts of the world and of distributing such information to dentists everywhere."

In observance of the anniversary year, tour members, who included I.C.D. fellows from six countries in the western hemisphere, visited their counterparts, in Tokyo, Kyoto, Taipei, Manila and Hong Kong. Together they took part in the scientific programs presented by nine tour clinicians and eight lecturers from the Far Eastern countries. The visitors toured dental schools and university-related hospitals. Special social events in each city provided an opportunity both for the exchange of information on an informal basis and the establishment of friendships to be cherished through the years.

In Taipei, College President, Cyril deVere Green welcomed nine new fellows into the College in the first induction ceremony ever to be held there. Some 400 dentists attended the scientific program. And in Manila a record-breaking attendance was recorded for the day-long learning session. Programs in Japan and Hong Kong were similarly successful.

The warm and enthusiastic welcome afforded the tour group by local members and their associates was an unforgettable experience. And I want to state again my gratitude to our hosts in Japan, Taiwan, the Philippines and Hong Kong who received us so royally. As one tour participant wrote to me after his return to the United States, "The College means so much more to me now that I realize its true international scope."

This 50th anniversary year has been an exciting administrative adventure for your Secretary-General. Because so many of the sections planned special anniversary celebrations, we have been hard-pressed to keep everyone informed of dates, places and events. We urge you to supply the central office with information about your scheduled program in ample time that fellows from other areas may plan to attend.

It is unfortunate that the meeting dates set by the Federation Dentaire Internationale and the American Dental Association are in conflict. As a result many of our fellows will miss the excellent post-graduate learning sessions sponsored by the European Section of the College.

During the coming year I look forward to visiting South America to complete arrangements for the forming of an autonomous section in that great area. Membership there has now reached a size which merits this action and we will aim for a charter presentation some time during 1980.

We anticipate a year of increasing activity whereby scientific knowledge and fellowship may be shared by I.C.D. members round the world — just as its founders envisioned a half century ago.

The receiving of the gavel of the International College of Dentists, a cocktail party then off to Los Angeles Airport, for a flight to Japan with 96 I.C.D. Fellows and their wives, this was my induction to the presidency of the International College of Dentists at Anaheim, California in October 1978.

I doubt if any other President of the I.C.D. has had his life and that of his wife so highly organized before.

The long flight over the Pacific — the confusion of crossing the International Date line — gave one an opportunity of getting to know one's fellow travelers a little better.

At the Banquet of the U.S.A. Section in Anaheim, I had been given the honor of not only presenting Past-President Gordon Rowell with his Past-President's Lapel Pin but of saying a few words.

I remarked that 1978 not only celebrated the 50th Anniversary Year of the I.C.D. but that according to the literature in my hotel room the 50th Anniversary of the birth of Mickey Mouse! To my mind there are countless millions of folk throughout the world who know all about Mickey but have never heard of the I.C.D.

The tour of the Far East was so extremely well organized by our Registrar and Howard Tours Inc. of California that just nothing was left to chance.

The welcome which we Fellows and our wives received was just tremendous. Even on one occasion when our plane was four hours late in arriving there awaited us our Fellows of the I.C.D. with their wives and even the press.

I suggest you look up the definition of the word "Fellowship" in your dictionary, you will then appreciate all the more just what Fellowship in the I.C.D. means.

In this our 50th Anniversary Year we have heard and read a good deal regarding the Founders of the I.C.D.

But now what of the next 50 years?

I take, from a personal contact view, a most brilliant, far-seeing and far-reaching horizon.

I predict that the I.C.D. will expand until it is comprised of the keenest, the most knowledgeable and most influential members of our profession throughout the world.

I foresee that its aims and objects in the whole world will become identical and that its financial status will enable the President and the Registrar to be sent to every Section to conduct Induction Ceremonies, but and this I stress, FELLOWSHIP MUST BE THE KEYNOTE.

I have and so have many others, the feeling that the true Fellowship of our College may in the long run have a world wide profound effect on and in our profession.

It has always been my belief that our calling through our personal contact with our patients, who respect our judgements and decisions, can — if it so wishes — sway the thoughts and desires of tens of thousands of patients each day.

In fact, I am suggesting that the dental profession might have a more powerful influence eventually than newsprint or television. This can or could be the responsibility of ourselves.

If we could put into effect the aims, the objects and the aspirations of the International College of Dentists, I firmly believe that this world of ours would benefit.

May I wish you all success in your efforts towards these ideals.



CYRIL de VERE GREEN

Your new President-Elect, George D. Selfridge, was born in Pitman, N.J. on September 24, 1924. He was the product of a railroad family: his father was a conductor for the Pennsylvania Railroad and worked for many years on the New York City-Washington D.C. run, his uncle was an engineer on the same run and became a high official of the Brotherhood of Railway Engineers, and another uncle was head of the insurance division of the Pennsylvania Railroad. George grew up with a love of railroads, but says that he never contemplated becoming a railroad man himself.

Sports were his main interest as a youth in Pitman. He won letters in football, basketball, and baseball in high school. On the gridiron, playing center and linebacker, he made the New Jersey all-state team for his school's division. He also played on a basketball team that was runner-up for the divisional state championship.

He was awarded an athletic scholarship to Gettysburg College in Pennsylvania and played football there as a freshman in 1942. He had determined by that time that he would work toward a career in some branch of the health sciences. During the Fall of 1942, with World War II in progress, George enlisted in the Navy and was selected for the V-12 Program, a Navy officer training program. He went

on active duty in July, 1943, and was sent to Muhlenberg College, also in Pennsylvania, where he began training to be a Navy line officer, but also found the time to play another season of college football.

While at Muhlenberg, George informed the Navy of his interest in dentistry or medicine and his orders were changed and he was given an opportunity to take additional science courses as preparation for assignment to some health care post.

From Muhlenberg, George was sent to the Bainbridge, Md. Navy Training Center, where he received six months of training as a dental technician and then he was assigned by the Navy as a dental student at the University of Buffalo (now the State University of New York at Buffalo) dental school. He began an intensive three-year program at Buffalo, which was completed with his graduation in December, 1947. He had been discharged from the Navy in 1946 and continued in dental school as a civilian student, but accepted an Ensign's commission in the Naval Reserve. After graduation, in December, 1947, he became eligible for active duty in the Navy and was commissioned Lieutenant, Junior Grade. His first assignment as a dental officer was with the Marines in Camp LeJuene, North Carolina in February, 1948.

Just before beginning his Naval career, George was married in his hometown to the girl who had been his sweetheart since high school days.

His dental training continued in the Navy Dental Corps with a rotating internship at the National Naval Medical Center, Bethesda, MD. and the Navy Hospital at St. Albans, N.Y. He later completed an oral surgery residency at the Navy Hospital in Jacksonville, Florida. His selection in 1948 as one of the first six Navy dentists chosen to participate in the Navy Internship Program helped influence him in deciding to make Naval dentistry his career.

During the 28 years that followed, George rose steadily through the Navy ranks and received a great diversity of duty assignments. He served at various times with the Navy's air arm, submarine force, and service ships, and spent almost 10 years on a variety of sea duty assignments.

George received an intensive indoctrination in dental education from 1969 to 1972 when he was Chairman of the Educational Resources Department and Assistant Director of Graduate Programs at the National Naval Dental Center. At that time he began work toward an M.A. degree in higher education, which he was awarded in 1974 by The George Washington University.

In 1973, George was appointed Commanding Officer of the National Naval Dental Center with the rank of Rear Admiral. His position was comparable to that of a Dean for Graduate Studies with the additional responsibilities as Commanding Officer of a major military command.

In 1976, George decided to retire from the Navy after 28 years of active service and to accept an invitation to become Dean of the Washington University School of Dental Medicine in St. Louis, Mo., the nation's fourth-oldest continuously operating dental school. He made the decision because he had developed a deep interest in dental education and felt that great improvements were possible in the methodology of delivery services in health education, using new approaches to match those dental science has made in the last two decades. He also wanted to make a personal contribution toward the preservation of private dental education, which he describes as "the last frontier for private enterprise in

dentistry, and an endangered species.” He feels strongly that, through good management procedures and curricular innovation, private dental education can survive the impacts created through social-economic and political impacts.

George is the recipient of the Navy Commendation Medal, the Certificate of Merit from the Surgeon General USN, and the Legion of Merit presented by the United States government in recognition of his service to the armed forces. In 1978, he was chosen as Dental Alumni Man of the Year by the alumni association of his alma mater, the State University of New York at Buffalo.

George and Ruth Selfridge reside in Chesterfield, Mo., an attractive western suburb of St. Louis. They are the parents of three daughters: Pamela, 25 years old, who works in Washington, D.C. as a para-legal assistant for an international law firm; Kim, 21 years old, who is majoring in psychology at the University of Missouri at St. Louis; and Cheryl Beth, a 16-year-old high school junior who already has begun a modeling career and also has strong interests in art.

The time demands on the dean of a busy dental school are extensive, but in what little spare time is left to him, George enjoys watching sports — especially football — and also enjoys landscaping work around his home.

The Minutes of the previous meeting (October 7, 1977) were approved.

President **ROWELL** reported on his year in office and his visits to almost all Sections of the College—Central and South America, Mexico, Canada, New Zealand, India, Australia, Singapore, Philippines, Japan, Taiwan, Hong Kong, Pakistan, Iran, Israel, Morocco, Algeria, Spain, England, Ireland and the U.S.A. He officiated at an induction ceremony of 4 men in Lahore, Pak-

istan. Many recommendations came of this extended travel, but the President is deleting his specific recommendations until the Secretary General has had time to investigate the matter of Section composition and report to the Constitution Committee. **ROWELL** pointed out that Article XI of the Constitution provides for changing Section boundaries and chartering new Sections as feasible.

President **ROWELL** recommended that a permanent standing committee, The Finance Committee, be written into the Constitution. **ED MIMMACK** so moved and the motion carried. Members are **ERNESTO**

ACUNA, E.S. O'BRIEN-MORAN and **DAN KAMAS**. The Finance Committee made the following preliminary recommendations:

1. That each Section should pay a minimum \$10 for each fellow.
2. That each section should pay a minimum induction fee, per inductee, of \$25.
3. That each section should be responsible for purchasing its own keys for inductees.
4. That the Treasurer should be reimbursed his air fare where appropriate when he is required to attend meetings of the Executive Council.
5. That the aim of the College should be to establish a reserve equal to the operating costs of the previous year.

ROWELL suggested it is time for the Constitution to be revised. **FRANK AMATURO** moved to establish a permanent standing committee to amend the Constitution; motion approved. Amendments should be referred to Committee in time for all Councilmen to be notified prior to next meeting.

GORDON AGNEW reported on his recent visit to China.

Secretary-General **KENWARD** read the specific recommendations of **JOSE MEDINA** with reference to establishing an autonomous Section in South America. In brief:

1. That the establishment of a South America Section be pursued by the Registrar (Secretary General) as quickly as possible, and the preliminary ground work laid should facilitate development.
2. That the Section, from its inception, consist of two Districts.
 - a. District I (CONO SUR) to include Argentina, Bolivia, Brazil, Chile, Paraguay, Peru and Uruguay;
 - b. District II (CONO NORTE) to include Colombia, Ecuador, French Guiana, Guyana, Surinam and Venezuela.
3. That **KENWARD** actively initiate communication with **VIEIRA** and pursue a visit to South America around March of 1979.
4. That present designations of Section 3 and Section 4 be reexamined and that adjustments be made in the constituent countries.

No decision was made on South American constituency. Vice President **GEORGE SELFRIDGE** moved that as soon as finances are available that the Secretary General be authorized to visit Central and South America to see what can be done in

that area and develop it adequately. It was felt that Mexico should be a separate Section and that a separate Section be established for Central America. This to be referred to Constitution Committee for proper action.

The Secretary General's report is summarized as follows:

1. Roster will be published early in 1979. Many changes have been reported since 1977 Roster came out.
2. Under the International Clinicians program **JOHN BOWMAN** was sent to Tehran and **JOSE MEDINA** to South America.
3. **MOTOHIKO KATOH** of Japan was



brought to lecture in U.S. under Visiting Scholar program.

4. Dental Abstracts were mailed 4 times a year to all Sections of the College (except 1 and 2) as gift of U.S.A. Section.
5. **KENWARD** is working with President-Elect **CYRIL DE VERE GREEN** putting together plans about visitations.
6. He commended President **ROWELL** on an excellent year.
7. 50th Anniversary celebration was a memorable occasion.
8. Central office is now well organized.

Treasurer **DAN KAMAS** reported the changes in fiscal year from June-June to January-December and the report was received as information pending a more detailed report later. Councilman and U.S.A. Section Editor **WILLIAM E. HAWKINS** reported that at the U.S.A. Board of Regents meeting it was voted to withdraw any special support of the Scientific and Educational Journal and recommend that the Executive Council consider suspending this publication and consider alternatives. **HAWKINS** recommended increasing the Newsletter coverage and that the Newsletter replace the Scientific and Educational Journal as the College publication with the Letterette being a solely U.S.A. publication.

Editor **R. GORDON AGNEW** reported that he felt the Scientific Journal is a necessary part of the College and is well received and a useful means of communication on an international scale. He felt there would be funds available to continue the Journal. A discussion of the subject revealed that the cost of printing has increased 30% in the last 3 years and most advertisers are not interested in utilizing this type of publication. Therefore it was felt advertising would not bring in sufficient funds even if approved, as Secretary General **KENWARD** stated, the I.C.D. has tried for 2 years to raise funds for this publication, citing discussions with **ART WILK** of Colgate and **BERNARD BEASLEY** of Dentsply.

Vice President **SELFRIDGE** moved that **HAWKINS'** recommendations be adopted and the Council voted in favor of this and

fully implement this program.

HAWKINS also recommended that **AGNEW** be made Editor Emeritus of the College and **EBERHARDT** and **AL SEYLER** be appointed as Editorial Consultants to the College.

The report of Editor **HAWKINS** was adopted. President-Elect **DE VERE GREEN** recommended that **HAWKINS** be congratulated for his report. President **ROWELL** states we are indebted to **GORDON AGNEW** for his work with the Scientific and Educational Journal over the years. Councilman **ABRAHAM CHISIKOVSKY** proposed a resolution to acknowledge **AGNEW'S** work and that recognition be awarded in due course. The resolution was approved as was **HAWKINS'** motion that **AGNEW** be named Editor Emeritus.

President **EBERHARDT** reported for the

of Councilmen of the Section; i.e., one U.S.A. delegate voting for all 12. This matter is to be referred to the Constitution Committee for consideration and to be reported on at the next meeting.

4. Make the Editor an officer. **EBERHARDT** read list of new officers, including **WILLIAM HAWKINS**, Editor. The U.S.A. Bylaws will reflect this amendment.

HAWKINS also recommended that the College support an International Dental Editors Award to be presented at a meeting in a Section of the College patterned after the U.S.A. Golden Pen, Golden Pencil and Golden Scroll. A judging team of 3 to 5 members to be appointed by Section Editors, one member to be a journalist. The winning publications in each section will then be submitted to the International Awards Committee of 3-5 members appointed by the Editor of College for the final judging of International Award winners. It will require three or four years to

U.S.A. Section on the planning for the 50th Anniversary, the mid-year meeting in Brainerd, Minnesota in July, and the induction of 197 new Fellows on October 21, 1978. The Board of Regents at its meeting on October 23 voted to:

1. Recommend that South America be made an autonomous Section
2. Drop its special support of Scientific and Educational Journal and make the Newsletter the official publication of the College.
3. Develop a mechanism about proxy votes. Request the Council to consider an amendment to the College Constitution allowing a delegate to cast the number of votes equal to the number

Although no report was received from the India Section, the central office received in August a list from Secretary General **J. C. CHANDNA** showing 124 members

and 11 inductees as well as a check for 1975-76 dues and the statement that the next dues are already in process and will be sent soon.

Nominations were called for to elect a Fellow to represent the Section at Large (International Section). **WILLIAM W. WONG** of Hong Kong, Regent, was nominated and was appointed the official representative. He gave his report stating that 9 Fellows will be inducted in Taiwan on Nov. 4 during the Orient Tour. He will soon be visiting Korea and will investigate the delineation of Section 23. It was decided not to reduce the initiation fees for candidates from Africa as requested by Fellow **BASHIR QURESHI** who acts as representative there. Life Membership granted was **M. HOSEIN** of Pakistan.

President **ROWELL** brought up the matter of persons being inducted into the College from an area other than that in which he resides. By common consent it was established that a man comes in from the country of origin. While Fellows don't join a Section, they join the College through the proper channels. In the event of moving, **O'BRIEN-MORAN** suggested a set waiting period before requesting affiliation with the new Section, while continuing as member of old Section.

ROWELL suggested the name "International Section" instead of "Section at Large" to apply to the non-autonomous Sections.

JOHN HEIN recommended that the Editor be an officer of the College. Motion made by **FICCA** that Editor be listed as officer

carried. **ROWELL** nominated **BILL HAWKINS**, nominations were closed and **HAWKINS** elected Editor.

Presenting Carl Rasmussen PRESIDENT ELECT, U.S.A. SECTION

V. Joseph prize, and the Omicron Kappa Upsilon National Honor Fraternity Key.

Carl discovered his bride at Creighton where both were in attendance and wedding bells transpired following dental school graduation. First child, Jerry Lee, arrived while at San Diego and now resides in Wichita, Kansas as an FBI agent and the daddy of Carl's three grandchildren.

Briefly, both Illinois and Nebraska State Boards were successfully completed and his first dental practice followed in

The minutes of the July 1978 meeting in Brainerd, Minnesota were approved with the addition of the notation on Dental Abstracts to read "a gift of the U.S.A. Section of the I.C.D."

JOSE MEDINA, International Clinician, reported on his trip to South America where in addition to lecturing, he made contact with I.C.D. members relative to

the formation of an autonomous Section in South America. Great enthusiasm for the autonomy of this Section was evident in the cities he visited. He recommended two districts within the Section, with **VIEIRA** as coordinator. **KENWARD** read the letter from **VIEIRA** following **MEDINA'S** visit expressing enthusiasm both for the clinician and the plans for development of the autonomous Section.

President **EBERHARDT** updated his Brainerd report and delivered greetings from Regent **ED HINRICHS** of District 10 who was unable to attend this meeting due to illness.

Registrar **KENWARD** stated that the I.C.D. has been assigned the Fairmont Hotel for its meeting in Dallas in October, 1979.

The names of the recently deceased Fellows were read and a moment of silence observed in their memory. A contribution of \$15.00 is sent to the American Fund for Dental Health for each man.

Treasurer **REIFKE** gave his annual report which was approved as given.

Regent **RICE** noted that President-elect **PAUL LOFLIN** addressed the opening ceremony of the International Association of Dental Students at Case Western Reserve University in Cleveland, Ohio in August.

The Journalism Committee noted that the U.S.A. Section voted to discontinue any special support of the Scientific and Educational Journal at Brainerd and this will be brought up at the Executive Council meeting as the College may decide to continue this publication. An alternative is to have the Newsletter become a College publication.

The nominating Committee Chairman **FICCA** discussed the term of office of Executive Councilmen from the U.S.A. and their number. Regent **GREWE** moved that 2 delegates and 2 alternates be appointed as

U.S.A. representatives to the Council. Seconded by Regent Kershaw. After much discussion Regent Grewe's motion was defeated.

Regent HUDSON then moved that delegates be directed to discuss this matter of a delegate having the power to vote for other members. Regent GIORDANO seconded. This would call for an amendment to the Constitution changing the bylaws to allow any Section's delegation the full vote. Motion carried and was to be referred to the Executive Council.

Next on the agenda it was reported that a membership evaluation form providing for a 6-year study has been prepared and will be distributed to Regents for their Deputy Regents to turn in with their annual report. It is recommended that screening procedures be standardized throughout the Districts and that the Information Forms be filled in fully in the space provided for reply.

That the U.S.A. Section make a \$500 grant to the American Fund for Dental Health was moved by Regent RICE and seconded by Vice President RASMUSSEN and carried. The distribution of Banquet tickets and the reservations were discussed briefly, and an improved plan will be developed for next year.

Another banquet change concerning the one or two tier head table arrangement was discussed and Regent HOPKINS moved to have one tier only in the future as was the case this year. Regent RICE seconded the motion and it carried.

The subject of a mid-year meeting on a regular basis was discussed and it was decided to leave this to the discretion of the Registrar.

The budget will be prepared and submitted to the Executive Committee at its February meeting in Chicago. As the fiscal year is being changed to conform to the cal-

endar year, there was not adequate figures available at this time on which to base a new budget. The Executive Committee has the power to act for the Board in approving the budget so the budget will be considered in February of 1979.

Registrar KENWARD recommended that stricter regulations be made and kept as to applicants. It was reported that to date over 100 have been accepted for the Class of 1979. Regent GIORDANO seconded Regent MALLERNEE'S motion that members should be censured for conduct which is not up to Colleague standards.

Registrar KENWARD recommended that the Board of Regents vote to encourage the formation of an autonomous Section in South America and that this recommendation be made to the Executive Council. The motion carried after discussion.

Amendments to the Bylaws were recommended as follows:

- (1) Article VI, Section 1 (page 19): The officers of the Section shall be a President, a President-elect, a Vice President, a Registrar, a Treasurer, and an Editor.
- (2) Article XI: An Editor shall be elected by the Board of Regents . . . (not appointed)
- (3) Article XIV, Section 1: The fiscal year of the Section shall begin on January 1 of each year and end on the following December 31.

These matters were referred to Bylaws Committee Chairman HUDSON for action.

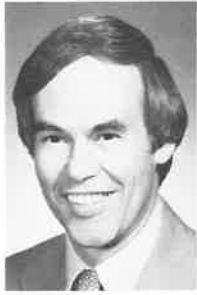

Golden Scroll

The Golden Scroll Award is given to the editor whose publication showed the most improvement during 1978 in such basics as content, increased coverage, design, and format.

Golden Pen

The Golden Pen Award is given to the editor whose publication carried the most outstanding article or feature during the year. The article is evaluated for interest and timeliness of subject, development of topic, organization of material, and writing quality.

Golden Pencil

The Golden Pencil Award is given to the editor who, during the year, demonstrated the most creative and effective use of illustrations or other graphic arts.

Special Citation

The Special Citation Award is given to the editor whose publication presented an unusual treatment, combining different aspects of journalism, not common in other publications.

The Competition:

All publications in the U.S.A. that are associated directly or indirectly with dentistry are invited to enter the annual competition sponsored by the U.S.A. Section of the I.C.D. The competition came into being in 1971 with the first awards being made in New Orleans on April 17, 1972 in conjunction with the A.D.A. conference on Journalism.

Each year the number of publications submitting entries has grown and the competition had reached a point in 1976 that bought the Awards Committee to add Special Citations that were given to publications that did not fit into one of the three original categories. After three years of successful testing this has become a perma-

nent category and part of the competition. In order to fully utilize this category the publications that do not fit into Golden Scroll, Golden Pen, or Golden Pencil must submit a cover letter with each entry so the judging team will be able to properly evaluate the article or publication.

The awards Committee feels that all dental related publications regardless of physical size or distribution are worthy of consideration. Newsletters, Bulletins, Auxiliary publications, Student publications, Scientific Journals, Proprietary publications, Component Journals, State Journals, any and all publications will be accepted and judged impartially.

With the establishment of the Special Citation category all publications that meet the requirements of the judging team can

receive recognition.

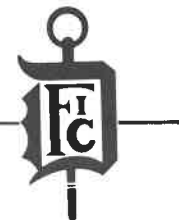

Seminars in the Orient

A group of 96, including I.C.D. members, others in the dental profession, families and friends, participated in the I.C.D. Orient Dental Sessions which were held immediately following the ADA annual meeting in Anaheim, Calif.

Represented in the tour membership were all regions of the United States, including Alaska, also Great Britain, Mexico, Holland, Puerto Rico and Costa Rica. College President **CYRIL de VERE GREEN** of Surrey, England, was in the group as were **GEORGE J. COLLINGS**, Vice President of the U.S.A. Section; **JOHN REIFKE**, Treasurer; **WILLIAM HAWKINS**, Editor; **FRANK KENWARD**, Registrar, and other College officials including Regents and Deputy Regents.

The main tour itinerary included Tokyo and Kyoto, Japan; Taipei, Taiwan; Manila, and Hong Kong. In each of these cities the traveling dentists joined local I.C.D. members and other professionals for scientific programs and specially arranged social and cultural events. Following the initial portion of the trip some tour members also visited Bali, Singapore and Bangkok as well as mainland China.

REMINGTON**, Chippewa Falls, Wis.; **JOHN F. BOWMAN**, Gainesville, Fla.; **JOSEPH E. MUSSER**, Wichita, Kans., and **WALTER W. NIEMANN**, Ann Arbor, Mich. Regent **JAMES KERSHAW** served as backup for **GAVEL** when he became ill during a part of the trip.

The all-day dental session in Tokyo included visits to both Nippon Daigaku

and Tokyo Dental Colleges and dental seminars presented by both American and Japanese Fellows.

In Kyoto the visitors toured and heard presentations at both the Morita Dental Equipment Factory and the Shofu Dental Materials Manufacturing Co. In Taipei the scientific session was held at the Vet-

erans General Hospital and attended by 400 dentists from that country. A highlight of the program was the induction by **DR. de VERE GREEN** and Registrar **KENWARD** of nine Fellows into the College, the first such ceremony ever held in the Republic of China. Local lecturers included **DR. C. CHUNG**, a renown acupuncturist.

The all-day dental session at the Manila Hotel in the Philippines broke attendance records and late registrants were turned away for lack of space.

The visiting dentists joined members of the Hong Kong Dental Association for a learning session at which American clinicians presented the program.

In addition to the scheduled program, many of the dentists had an opportunity to visit other dental schools and facilities guided by their local I.C.D. hosts. The group visiting the Peoples Republic of China were able to tour a hospital and dental clinic in a large commune outside Canton.

Registrar **KENWARD** termed the tour as "highly successful in carrying out two purposes for which the International College was established 50 years ago: The dissemination of scientific information and the promotion of fellowship within the profession throughout the world. Because of the extremely enthusiastic response by both tour participants and our foreign hosts to this first venture, we hope to schedule other trips in the future."

THE CHINA EXPERIENCE

From Hong Kong 12 of the Orient Seminar Group entered the People's Republic of China, which was closed for more than a quarter century to the U.S.A. We saw many people during our 4 days inside the People's Republic of China but still only an infinitesimal percentage of the 900 million population.

From Hong Kong where China Travel Service, the official tourist organization known as Luxingshe, verified our itinerary and completed arrangements for our entry we traveled with a group of 100 people. English speaking guides were designated to greet us at each destination. With travel documents, badges and train tickets supplied by Luxingshe, we took the train from Hong Kong to Lo Wu, the gateway between Hong Kong and Canton. We were assisted through customs clearance and scrutinized by border guards who verified that our faces matched those of our passports. Then we crossed the Shum Chum Bridge into China — a world totally different from anything we had experienced before.

We were immediately aware of the hospitality of the people, as courteous personnel directed us to the various rooms for clearance. Sessions with health and immigra-

tion officials and baggage inspection were speedily accomplished.

We changed our money at the station's government bank into Renminbi or People's money. They came in denominations of one, two, and ten Yuan. Smaller bills were one, two and five Jiao. Coins were of one, two and five Fen. (Yuan=53.735 cents and one dollar=Y1.86.) Tourist transactions are paid in cash.

A Luxingshe guide escorted us through the building to where lunch was served in a spacious dining hall. After lunch, we boarded the train for Canton City, one hour and 45 minutes away.

The train was immaculate, girls swept and wet mopped the aisle at intervals. Covered tea cups were kept full and boiling hot. We sipped tea and gazed out of the windows at South China's richest agricultural district, the Pearl River delta area. Here, rice is harvested three times a year. Every bit of land is used, up to within a foot of the track. People were working in the fields planting, cultivating or harvesting a variety of crops.

CANTON

We arrived in Canton, pronounced

Kwangchow, a metropolis of four million people. This principal city of South China is the home of the National Commodities Fair (Canton Fair) held every spring and autumn for sales of China products. A China Travel guide welcomed us at the modern station and we were bussed to our hotel.

CHINESE CLOTHING

Simplicity is the keynote in all forms of clothing which are made for practicality. Young children wore multi-colored tops and pants. The blue colored jackets and pants worn by the general populace gave a unisex look. These loose fitting garments are cool in summer, often open to the breeze. It is the same outer-garment for winter, but fortified with multi-layers of light and heavy sweaters, longjohns and hand knit wool inner pants. People's shoes leave much to be desired in style and material but are serviceable. Generally, men wear black cotton flat shoes with plastic soles, Women's style resembles the "Mary Jane" with a strap across the instep. Shoes similar to our U.S. Keds are worn by soldiers, only olive in color.

CHINESE CUISINE

Chinese food with its contrasting tastes and blending of complimentary flavors and textures met us each meal.

PEOPLES COMMUNE

We visited the Pingchow People's Commune consisting of 20 production brigades which are subdivided into 266 production teams. It has 16,859 households with a population of 69,859. The whole commune occupies an area of 67.5 square kilometres, of which 4,563 hectares are under cultivation. The main produce of the commune is rice. Other types of farming include oil-bearing crops, sugarcane, fruit and vegetable growing, and fish, livestock (pigs and dairy cows) and poultry raising. Besides, the commune runs quite a number of small factories, such as a food and oil processing mill, a farm implement manufacture and repair shop, a machine shop, a hardware shop, a cement works, a lime kiln, a silk reeling mill, a rattan-ware shop, a brick kiln and a printing shop. At this commune we were allowed to visit the Dental Clinic, the highlight of the tour, and our pictures of the facilities, the dentists, and technicians, speak for themselves.

The visit to the People's Republic of China was most enlightening and enjoyable.

Visiting Scholars Program

ACROSS THE U.S.A.

The first visiting clinician from abroad sponsored by the International College of Dentists arrived in the United States November 19, 1978 to begin a speaking tour of approximately two weeks. He is **MOTOHIKO KATO**, D.D.S., of Tokyo, Japan, and a Fellow of the College.

KATO, spoke to dental students, I.C.D. members and others in the profession at the University of Washington, Seattle; the University of Oregon in Portland; the University of Minnesota, Minneapolis; Temple University and the University of Pennsylvania in Philadelphia; the University of Alabama, Birmingham; the University of Florida in Gainesville; the Loma Linda University Los Angeles, California.

KATO, who has a private dental practice in Tokyo, has given lectures and table clinics throughout the world on periodontics, conservative dentistry and time-motion relationships in the dental office. His talks during the series in the United States were focused upon these relationships in the dental operator which, he states, exist between patient-assistant-dentist and enable full utilization of the concept of four-handed dentistry.

A graduate of the School of Dentistry of Nihon University in Tokyo in 1954, **KATO** subsequently took a dental internship as a Fulbright Scholar at the Albert Einstein Medical Center. He served as advisory dentist at a U.S. Army Dental Hospital in Japan and lectured at both Nihon University Dental School and the School of Dental Hygiene. Fluent in the English language, he frequently serves as interpreter for foreign dentists and scientists in Japan.

Arrangements for his visit were under the direction of **GEORGE J. COLLINGS** of Portland, Oregon, Chairman of the International Clinician Program for the International College.

Seattle, Washington

KATO spent a full day at the University of Washington School of Dentistry where he met with faculty representatives of the Departments of Restorative Dentistry, Periodontics and the Center for Oral Biology Research. He also toured the clinical and research areas of the school.

A noon-time luncheon at the Washington Athletic Club was shared with **KATO** by School of Dentistry faculty and I.C.D. Fellows from Western Washington. A newly-published textbook by U. of W. faculty members, **RALPH YODELIS**, **SAUL SCHLUGER** and **ROY PAGE** was presented to **KATO**. The sizeable text covered the interwoven disciplines of restorative dentistry, periodontics and dental research and histology.

National Advisory Council

similar to those in the United States. They have an active research program and it appeared that students gained a great deal of experience in clinical dentistry. Many of the materials and supplies were the same as we're using in the U.S.A., and as near as he could tell the program was structured similar to a standard curriculum. The

pre-dental programs were somewhat different but by the time the students completed the four year dental school activity, they had a lot of experience in patient care.

The second school visited was in Denmark at the University of Aarhus. He spent almost an entire day with **FEJERSKOV**. He was chairman of the restorative dentistry department and a current candidate for election to the office of Dean. An interesting system whereby deans are elected at certain intervals. The emphasis in his department was highly research oriented. **FEJERSKOV** comes with a background of pathology and hard tissue mineralization interest. The equipment in Denmark was somewhat old and outdated, although the facilities were spotlessly clean. We noticed that there were a large number of females in the dental program in Denmark. Much more in numbers than in Holland. Their program was similar although Pedodontics in both of these areas is not a recognized specialty and is taught as a minor part of the curriculum. Of course in Denmark the emphasis on children's care is handled in the schools so it is a totally different program. Not very many family dentists in Denmark treat children as most of the child patients are treated in the school dental health programs. He saw two totally different programs and felt that the stan-

dards of care and of information were quite good in both areas.

He also had an opportunity to visit very briefly the school in Rome. This was just a walk through and it was really not much of an opportunity to gain information. His impressions in Rome were that the standards were somewhat different and the concerns not quite so great. **CARROLL** really did not have enough information to gain a valid impression of the program there.

Regent Yee Visits

The P.R.C.

Sacramento's **HERBERT K. YEE**, who led a group of 25 Chinese-Americans on a 35-day trip to China, got a unique view of the once-forbidden nation.

"Hoy," the dentist would say to the Chinese school children, "Hoy how." And they opened their mouths.

YEE is in a good position to compare dentistry in America and China. When he was chairman of the American Dental Association's Council on Dental Education, he made accreditation trips to many of the nation's dental schools. He also served on the state Board of Dental Examiners for eight years (as President in 1969) and was a special examiner for the board for four years afterward.

In China, he visited dental facilities at Toi Shan, Hangchow, the University of Peking and a Shanghai commune. **YEE'S** general conclusion: Chinese dentistry is about where American dentistry was in the 1940s and there are shortages of supplies and equipment, but the people seem to be getting adequate care.

The drills are not high-speed. Crowns are pre-formed shells rather than individual castings made for each patient. The Chinese dentist works standing alone on a patient sitting nearly upright.

Chinese dental facilities are usually located in or near a hospital. The straightening of teeth is largely limited to big cities. Gum disease may be more prevalent in China.

America with its 200 million plus population has 60 dental schools; China with 900 million plus has 20.

Schools take a limited number of new students each year, usually 60 to 100. Chinese students enter dental school right after high school and attend for five years. A practicing Chinese dentist is often assisted by eight to 10 paramedics, trained by himself during a two-year period.

Yee said professors at the University of Peking read American textbooks and are interested in the latest techniques.

During a meeting with China's student exchange director, Hu Shou-hsin, Yee, a University of the Pacific Regent, asked if China, which already has a few students at Stanford and Berkeley, might be interested in sending some to the University of Pacific. Hu asked if UOP would be interested in setting up a six-month post-graduate course for Chinese dentists.

YEE said he would talk with UOP officials, and he also suggested that it might be easier to send a few instructors to China. **HU** said he had been getting requests from western doctors and dentists who want to share their knowledge while making a trip to China. He asked for help in selecting the best. **YEE** said America is interested in visits from Chinese dentists expert in techniques such as acupuncture.

Professionally, China today reminded **YEE** of another trip. "I lectured in Japan in 1962," he said, "and they were about that far behind us then, but look how quickly their country has modernized. I don't know if I would like China to move that fast."

Marjorie Jackson Is First Canadian Woman Elected Fellow of International College

MARJORIE JACKSON, professor of dentistry at the University of Toronto's Faculty of Dentistry, is the first Canadian woman to be elected a Fellow of the International College of Dentists.

Born in St. Thomas, Ontario, **JACKSON** received her Diploma in Dental Nursing and, later, her DDS from the University of Toronto. She operated a private practice limited to children from 1950 to 1959 and, in 1959, she was appointed full-time associate professor in the University of Toronto's Department of Pedodontics. In 1967, she was appointed Professor of Dentistry and Director of the Division of Dental Hygiene.

In addition to the many courses she has taught, **JACKSON** has designed courses in preclinical and clinical dental hygiene and in dental assisting. The co-author of several research articles, she has served in various capacities in a wide range of organizations. **JACKSON** was a member of the Ad Hoc Committee on Dental Auxiliaries appointed by the Department of National Health and Welfare's "Wells Committee". She is a Past President of the Dental Nurses Alumnae Association of Canada, the Association of Women Dentists of Ontario, the North Toronto Dental Association, and the Tau Tau Chapter of the Omicron Kappa Upsilon. In addition, she is an honorary member of the Ontario and Canadian Dental Hygienists' Associations; a past chairman of the Ontario Dental Association's Dental Public Health Committee; a former member of the ODA's Board of Governors, the Canadian Dental Association's Public Health Committee, and was consultant to the Commission on Dental Practice of the Fédération Dentaire Internationale. She was a member of the Ontario Dental Nurses and Assistants Association's Advisory Committee and the recipient of the first honorary certification to be awarded by that same Association.
