Congratulations to the new autonomous Section of the College! Before an assemblage of members and guests from various countries of South America, the United States, Europe and the Middle East, the South American Section of the International College of Dentists gained autonomous status at ceremonies in Sao Paulo, Brazil January 16, 1981.

The Charter for the new Section was presented to President Dioracy Vieira of Sao Paulo by Joseph W. Tamari of Beirut, Lebanon, President of the International College.

Other officers of the South American Section are Nicolas Parula, Argentina, President-elect; Ruben Quintana, Chile, Vice President; Ramon Castillo, Peru, Treasurer; Carlos Leon-Diaz, Venezuela, Editor, and Julio Begazo, Peru, Registrar.

The occasion also included formal induction ceremonies for 52 candidates into membership for Section IV, the new Section. Among them were members from Brazil, Colombia, Ecuador and Uruguay.

I was privileged to participate in the Convocation along with Cyril de Vere Green, Surrey, England, Past President of the College and Joseph Tamari, President of the College.

Among those present were 113 members and guests participating in the I.C.D. sponsored tour to celebrate the presentation of the Charter. They came from the United States, Puerto Rico, and several European countries and included many Officers of the College. In the group were fourteen clinicians who participated in a scientific program in conjunction with the Convocation.

The tour group subsequently traveled to Buenos Aires, Argentina and to Santiago, Chile, where there were both scientific programs and induction ceremonies for new Fellows. Tour clinicians also took part in the scientific sessions in Lima, Peru. Induction ceremonies for Peruvian Fellows were scheduled for a later date. Attendance for each session averaged approximately 600 people.

The itinerary also included a number of social events shared with our local I.C.D. members and their wives.

As Secretary-General of the College, I am very grateful to men like Alfonso Mancebo of Rio, Dioracy Vieira of Sao Paulo, Ruben Quintana of Santiago, J. Barrancos Mooney of Buenos Aires, and Julio Begazo of Lima for making all of our plans come together. And as with all of us, their wonderful spouses are owed a great deal of admiration for their wonderful help and participation.

There are many others that should be thanked, but space limits me in doing so. But I'd like to ask you to remember men like Homer Vaughan and the late Charles Berger for their work in laying the groundwork for this happening, and also Jose Medina, Vice President of Facilities Planning and Operations at the University of Florida, who advised me during the last two years.

It's been a long time coming, but at last it's a fact, and my personal feelings are of elation that the new Section will now take its rightful place on the Executive Council of the College. It is in this spirit of cooperation that we continue to grow. Our profession will benefit as we exchange knowledge and promote its dissemination throughout the world.

Fellowship And Fulfillment

Among the most significant events in the life of a professional man is his induction into Fellowship, but perhaps more significant still is his enduring ability to savor and to live the meaning of that Fellowship. In this regard previous meritorious service and outstanding achievement may not play a role in the fulfillment which is to follow. Then it is the moral fiber of each individual which comes into play. Although the interaction between our moral code and our set of values may vary in style from place to place, from country to country, in the final summation our intellectual honesty should, all things being equal, help us reach the same tabulation of results. This tabulation knows, however, no figure, it is an abstract. But we somehow know when we have reached it.

What, therefore, might we ask, should the word "Fellowship" mean? What is Fellowship?

Fellowship is the discovery of people, their needs, their interests and their aspirations;
Fellowship is the discovery of their aches, their pains, their hopes, and our acceptance of their natural frailty;

Fellowship is intellectual honesty;

Fellowship is our freedom of thought and our resolve to sustain it;

Fellowship is tolerance of prejudice;

Fellowship is forgiveness, understanding and love;

Fellowship is our ability to translate all these ideals into the practicalities of our daily life.

These ideas were going through my mind as I was reviewing the outstanding line-up of inductees in Sao Paolo, Brazil during the inauguration ceremony of the South American Section. There could not have been a more select group of people. One could not have any doubt about the high standard which Doracy Vieira, President of the South American Section, established in order for a candidate to be accepted as a Fellow. My feeling was that this fine group of people had the intrinsic ingredients necessary to savor all that is to be savored, that is, a fulfillment in Fellowship. The feeling of what is beyond fellowship.

The same feeling pervaded me two days ago during the Convocation in Singapore. Regent Lim Kheng Ann had a yardstick no less sensitive than Fellow Vieira's, and his selection of candidates was so impressive that it made the F.D.I. President, Fellow Louis Baume, who was present, say a little later, "Today I am proud to be a Fellow of the International College of Dentists."

As this is being written to meet a press deadline, I shall not be able to describe the territories I have yet to discover, which I am scheduled to visit in the months to come: the Philippines, Japan, Korea, Taipei, Hong Kong, etc., but I am sure I shall delight there also in a satisfying communion of feelings with people who share these same common denominations.

DON L. ALLEN

Don L. Allen, the new President-elect, was born in Burlington, North Carolina on March 13, 1934. Burlington, then as now, was a typical southern textile town. Both his parents were textile workers. The family moved to Virginia during the war years where his father was employed in a defense factory. Before the end of World War II, they returned to Burlington.

Don was educated in the local public school system. Sometime around the seventh grade, he decided he wanted to be a dentist. After graduating from high school with honors, he attended Elon College, a small church school located approximately ten miles from Burlington. He attended college as a day student and worked in a local textile mill to support his college education and put something in the bank toward dental school. At the end of the freshman year, he received the award for the highest academic grades in chemistry in the college. Subsequently he applied to dental school at the University of North Carolina and was accepted after three years of college into the entering class at Chapel Hill in September, 1955. On August 2, 1958, he was married to the former Winifred Rouse, upon her graduation from dental hygiene school at UNC.

Don was elected President of the student body (Spurgeon Dental Society) and served in that capacity during his senior year. His introduction to dental education was somewhat of a fluke since he never had that in mind for a career. About mid-point during his senior year, he was notified by his local draft board that he would be drafted sometime in 1960. A few weeks after that he was approached by the Chairman of the Department of Periodontology and Oral Pathology relative to the possibility of joining the faculty as an instructor in that department. Since it seemed a reasonable thing to do for one year, until he entered the military, he and Winnie decided to spend a year in teaching. It didn't take him long to learn that that was where he wanted to spend his career. So, after three years of teaching, he received a U.S. Public Health Service Postdoctoral Fellowship in Periodontics and went in 1962 to the University of Michigan. The Allens took with them their first son Donny, who had been born nine months previously. Two years later Don graduated with the Master of Science Degree from the University of Michigan and returned to UNC as an assistant professor. He and a colleague established the first advanced educational program in Periodontics at UNC where Don served as co-director.

In 1965, the second son, Michael, was born. The next year, a daughter Susan completed the Allen family.

One of his proudest moments was in 1966 when he received the outstanding teaching award from the graduating class at UNC.

In 1967, Don was appointed by the Dean at the UNC to head a committee to do a comprehensive evaluation of the dental curriculum and made recommendations for a curriculum revision. This ended by being a very expansive involvement and he became even more interested in the dental educational process. In 1969, he was appointed Associate Dean for Administrative Affairs and Curriculum Implementation. That same year he was promoted to professor in the Department of Periodontics.

In 1970, he was invited to join the group at the University of Florida who were planning the first dental school for that state. The opportunity to develop some of the curricular concepts which Don had dwelt on the previous three years was an overwhelming temptation. So, in August, 1970, the Allens moved to Gainesville where Don was appointed Associate Dean

and Professor of Periodontics. His initial major task at the University of Florida was the development, with the other faculty members, of a flexible modular curriculum, a system quite unique to dentistry and most of higher education. The University of Florida has continued to employ that curriculum since the matriculation of the first class in 1972.

In 1973, Don was appointed Interim Dean and in 1974, Dean of the University of Florida College of Dentistry, the position which he still holds.

Don served as a consultant to the Council on Dental Education of the ADA from 1970 until 1978, when he became a member of the ADA Council on Dental Education and the Commission on Dental Accreditation. Currently he serves as chairman of the Committee on Advanced Education. He is

Chairman of the Florida Section of the American College of Dentists. He is a member of the American Academy of Periodontology, the Southern Academy of Periodontology, and the Florida Society of Periodontists. In 1978, he was appointed by then Secretary of Department of Health Education and Welfare, Joseph Califano, to the National Advisory Council on Health Professions Education. Recently he was elected as the non-federal Chairman of that Council.

With the assistance of Frank Kenward and the International College of Dentists, a sisterhood agreement has been developed between the Tokyo Dental College and the University of Florida College of Dentistry. This agreement will promote teaching and research at both institutions. Don believes that the integration of the

In addition to his membership in the American Dental Association and its component groups, he is a member of the International Association for Dental Research and the American Association of Dental Schools. He had served in the delegation from Florida and the Fifth District to the ADA since 1973. Currently he is

It was further requested that the Minutes of any special meeting convened to consider an amendment to the Constitution be recorded separately and not as a minute of a general meeting. Carried.

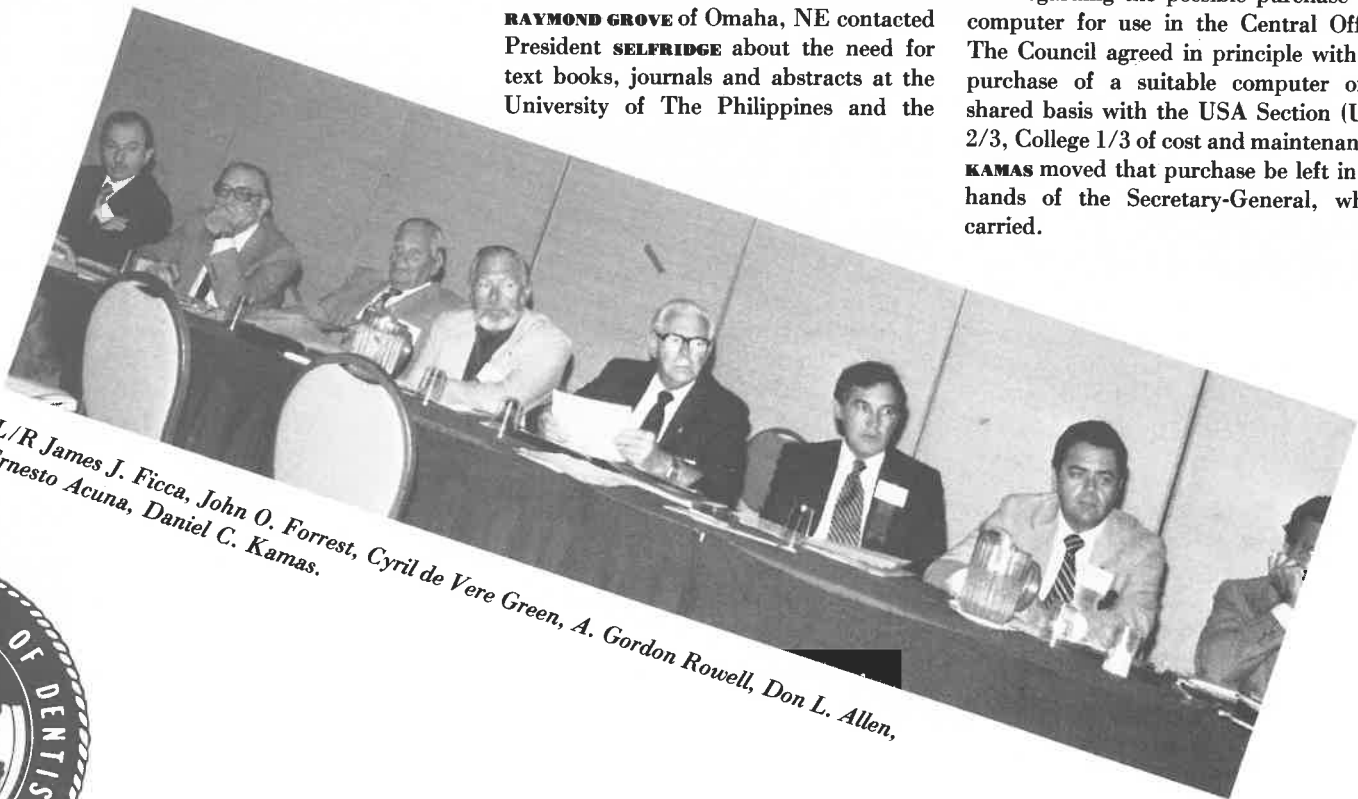
PRESIDENT'S REPORT

The President reported on his visits to various sections of the College and "Operation Outreach". His first official duty took him to Puerto Rico for a meeting of dental school deans during which time he addressed a joint meeting of ICD Fellows and faculty of the University of Puerto Rico School of Dentistry. Then last spring he visited Seoul, South Korea; Osaka and Kyoto, Japan; Taipei, Taiwan; Hong Kong, and the Philippines where he gave the B. B. Erana Memorial Lecture and participated in the induction ceremonies in the Philippines and in Tokyo, Japan, en route home via Hawaii. When Fellow **RAYMOND GROVE** of Omaha, NE contacted President **SELFRIDGE** about the need for text books, journals and abstracts at the University of The Philippines and the

Philippine Dental Association expressed its need for books and journals. Explained "Operation Outreach" in which books were collected throughout the USA for shipment to the Philippines, needed a low cost method of shipping the material President **SELFRIDGE** enlisted the support of the U.S. Navy to transport these books aboard Navy ships to Subic Bay in the Philippines. To date some 5,000 volumes have been sent and plans are now being formulated to extend the operation into Taiwan. President **SELFRIDGE** expressed his gratitude to University dental libraries and the ADA Library and the C. V. Mosby Company and Quintessence Publishing Company for their contributions.

SECRETARY GENERAL'S REPORT

The Secretary-General commented on the arrangements which were being made for the granting of the Charter to the new South American Section. He also mentioned the investigation of the USA Section regarding the possible purchase of a computer for use in the Central Office. The Council agreed in principle with the purchase of a suitable computer on a shared basis with the USA Section (USA 2/3, College 1/3 of cost and maintenance). **KAMAS** moved that purchase be left in the hands of the Secretary-General, which carried.

EDITOR'S REPORT

The Editor noted that the deadline for the 1981 edition of the Newsletter would be April 15. He requested the assistance of all Sections in providing suitable items for inclusion. He discussed the fact that the American Dental Association was unwilling to continue with the quarterly mailing of *Dental Abstracts* for distribution by the U.S.A. Section to all overseas members of the College. It would require an annual subscription of \$14 per Fellow and therefore he moved that no further action be taken on this matter as it was too costly. Carried.

TREASURER'S REPORT

SECTION REPORTS

Reports had been received and circulated with the papers for the meeting from Sections 1, 2, 3, 5, 25, 30 and 31.

AWARD TO SECRETARY GENERAL KENWARD

President **SELFRIDGE** said that at this time it would be necessary for the Secretary-General to leave the meeting as his attendance was necessary at a meeting of the Association of Dental Editors where he was to be presented with that Association's Distinguished Services Award for his "outstanding contribution to Dental Journalism".

The Chairman read the letter of invitation to **KENWARD** from **VELMA CHILD**, Executive Secretary of the Association of Dental Editors, whereupon the Council added its congratulations on the receipt of such a prestigious award, and the motion of congratulations was carried unanimously with acclamation. The Secretary

Councilman **ROWELL** recommended that the College should amass reserves within a reasonable period to match the requirements of one year's operation without receipt of funds. This is accepted internationally as 'good housekeeping'.

A request was made by Councilman **O'BRIEN-MORAN** that in the next financial statement income from each Section be stated. In reply, the Treasurer explained the difficulties under present arrangements because the payment from the USA took into account that amount which should be reimbursed to it for office administration and supplies in respect to College activities in the Central Office. He explained that the general expenses were shared on a 2/3 USA Section and 1/3 College basis.

Councilman **ROWELL** expressed the view that in the interest of more correct book-keeping and audit requirements that the USA should pay the College a sum based on its capitation fee responsibility and that

presented by Chairman **ACUNA** was approved.

GENERAL BUSINESS

Secretary-General **KENWARD** read a letter from the American Dental Association regarding a change in arrangements for the Opening Ceremony for its meeting in Kansas City in 1981 from Sunday to Saturday. He stated that Dr. **DONALD ERICKSON** and A.D.A. representatives had attended the USA Board of Regents meeting on October 9, 1980 and had presented the views of the ADA regarding its projected meeting. He stated that the College left the ADA in no doubt as to its feelings and assured the ADA that the College would proceed with its Convocation and meetings in accordance with its time-honored schedule irrespective of what decisions the ADA took. In view of the implications of such proposed changes, it was decided to defer the discussion on this matter to the section 'New Business'.

ROSTER It was reported that the Roster would be printed in January 1981 and requested that any changes be reported immediately.

KEYS U.S.A. President **RASMUSSEN** spoke about the need for new College Keys and the expense involved. He indicated that a quotation had been received from Artunian Jewelers in California, and he produced a sample for examination. The Council agreed with the purchase of new

OFFICE OF SECRETARY-GENERAL

Following discussion of the proposition that the Secretary-General position should be filled by a contractual arrangement with a suitable person who need not be a Councilman for an extended term of five years, it was agreed in principle that such action be taken. COLLEGE EXPANSION Councilman **ROWELL** spoke on the matter of implementation of his various Presidential Reports on this subject. He requested that specific action be taken in respect of South Africa where a new Fellow, **HELMUT HEYDT**, had recently been admitted to the College and who was au fait with the College's requirements in his area. Approved.

ISRAEL SECTION As a Regent for the European Section, Councilman **O'BRIEN-MORAN** read a letter from the Israel Section requesting that because of its geographic isolation and lack of contact with other College activities that the Section be disbanded as such and that the Fellows become part of District 2 of the European Section which consists of Great Britain, Malta, Ireland, and Cyprus. Councilman **O'BRIEN-MORAN** supported by Councilman **FORREST** moved that the Council agree to such change. Carried.

Councilman **ROWELL** moved that in conformity with the provisions of the Constitution (Article XVII) that insofar as the proposed amendment was not on the agenda, that the Council agree to the matter being considered at the meeting. Carried Unanimously.

AMENDMENT TO BY-LAW 1 - SECTIONS **O'BRIEN-MORAN** moved that By-law 1 be amended to delete Israel Section (Section 20) and include Israel within District 2 of the European Section (Section 5). Carried.

CANDIDATES FOR ADMISSION TO THE COLLEGE The problem was considered of candidates for admission to the College who originally came from another country where there was a Section of the College. **O'BRIEN-MORAN** moved that when such candidate was being considered that the Section of the country of origin be notified and requested to provide a comment on the suitability of the candidate for admission to the College before the candidature is finalized. Carried.

PROTOCOL Attention of the meeting was drawn to certain irregularities in respect to protocol by certain Sections at formal dinners when Heads of State were being toasted. It was agreed that the toast be "To the Head of State of the country in which the dinner is being held coupled with the Heads of State of those countries represented". It was agreed that this decision be brought to the notice of Sections by the Secretary General.

NEW BUSINESS

It was proposed that the Council consider holding its meeting in countries other than the USA every second or third year. The Council agreed in principle with this suggestion and will consider it further.

It was further recommended that the Council hold such meeting along with a suitable meeting of the F.D.I. to ensure maximum attendance by the Councilmen.

It was further recommended that the matter be referred to the Finance Committee which was requested to carry out a financial analysis of the cost involved in holding such meetings outside the USA. It was realized that to reimburse some expenses for Councilmen by way of tax benefits, it would require that such meetings be held during nationally recognized dental meetings.

COLLEGE CONVOCATION 1981

Following discussion of the ADA proposal re a possible alteration of the College schedule following its own change in arrangements for the Kansas City meeting in 1981, **EBERHARDT** moved that the College continue its regular schedule for that meeting. Carried.

Councilman **ALLEN** referred to the American Dental Association's intention to abolish the Council on International Affairs. **KENWARD** indicated that he, along with other Councilmen, would attend the Reference Committee hearings to speak in opposition to its abolition.

REPORT ON NOMINATING COMMITTEE

The slate of Officers presented by the Nominating Committee was approved on motion of Chairman **C. DE VERE GREEN**. The 1980-1981 Officers are:

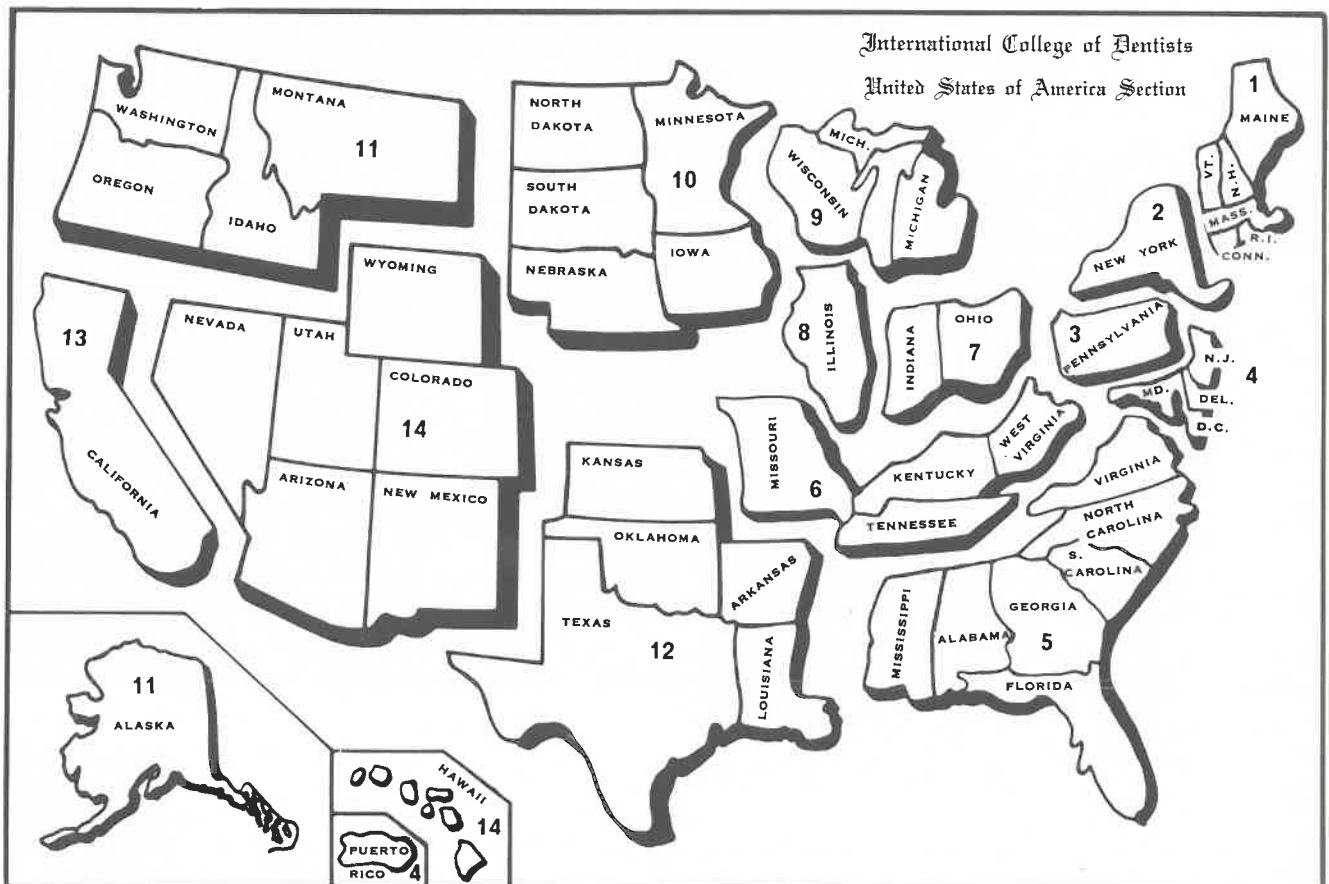

With the South American tour still uppermost in my thoughts, I will give you a brief account of events . . . though the many "natural wonders" and happenings could cover many pages.

On January 16, 1981, in Sao Paulo, Brazil, College President Joseph Tamari from Beirut, Lebanon presented the Charter, forming the autonomous South American Section, to Dioracy Vieira, of Brazil who accepted it on behalf of the South American Section. Approximately 75 Fellows were inducted into the College this January. It was gratifying that we were able to be a part of this occasion as they assumed their own identity, but we, of the U.S.A. Section should not lose sight of our own.

We shared Scientific Dental Sessions in Sao Paulo, Buenos Aires, Santiago and Lima. They were good sessions and well attended. Each person made special friends while mixing knowledge and cultures.

Even though each city seemed very much like a large city in the U.S.A., there was something unique and different in each country. To me, a Westerner, the millions of people and high-rises seemed overwhelming but as R. W. Emerson said, "The true test of civilization is not the census, not the size of the cities, nor the crops, but the kind of men that the country turns out" and there was no doubt about the warmth of their hospitality and the knowledge of dentistry. Special sights like Rio De Janeiro at night, Iguassu Falls, the Pampas, the Andes, Cuzco, Machu Picchu and the Amazon were unequalled wonders that many of us had only read about before. We had a busy schedule but quickly learned what "manana" meant. In many respects, our South American Fellows have the right idea and certainly know how to relax. After an extended wait in one of the airports, Past President Cyril de Vere Green, of England, put a touch of his humor into the situation, "When you have time to spare, go by air."

On March 9th I attended the U.S.A. Section's I.C.D. Journalism Awards presentation in San Diego. I think these awards are the most sought after and inspirational awards in Dental Journalism. Quoted Christine Nolen, Secretary for the Council on Journalism, "The Council is grateful for the I.C.D. Journalism Awards program which has resulted in a noticeable improvement in dental publications."

ROLLIN E. MALLERNEE

Rollin Mallernee was born in Michigan, the first of six children. His father was a minister who had to supplement his income by entering the sales field to support Rollin's mother, two brothers and three sisters.

Rollin learned to be a printer in high school due to the influence of a neighbor who had a print shop in his garage. This training stood him in good stead as he worked his way through pre-med at Columbia College in Maryland and dental school in Atlanta, Georgia at Emory University. The lack of transportation brought Rollin into the art of photography doing free lance work in Washington, D.C., where he accumulated fifty dollars which he promptly invested in a Model "A" Ford, that carried him to Atlanta and dental school. Still needing financial assistance to pay his dental school tuition he took lecture notes, organized them, and falling back on his printing knowledge, mimeographed and sold them to his classmates.

Once out of dental school he entered the Army Dental Corps before returning to Atlanta and private practice. His search for knowledge led him back to graduate school at Ohio State University, where he earned a Masters degree in Periodontics. Rollin then accepted a position on the faculty at Loma Linda University where he spent five years as Chairman of the Department of Oral Diagnosis and Radiology. But the lure of the old South was too much and he returned to Atlanta and private practice where he and his lovely wife Betty now live. His son practices law in Atlanta and one brother holds Rollin's ties with Michigan as he practices dentistry there.

He has served as President of the 5th District Dental Society of Georgia, the American Association of Dental Editors and the Georgia Dental Association. Served as General Chairman of the Thomas P. Hinman Dental Meeting in 1980 and as a Regent for District V of the ICD for six years.

He has been made an Honorable Fellow of the Georgia Dental Association, a Fellow of ICD and ACD, OKU, a member of Pierre Fauchard Academy, International Association for Dental Research, FDI, ADA, and many other organizations.

The Minutes of the previous meeting of the Board of Regents in Dallas and those of the Executive Committee meeting in Chicago had been approved by mail ballot.

President **RASMUSSEN** reported that the U.S.A. Section of the College had a successful year and he was pleased with the quality of the functions and activities of the Section and College. He reviewed his

year and thanked everyone for their support in the past year.

The Registrar pointed out that some 40,000 pieces of mail go out from his office each year. The total membership of the College, including the 203 Fellows to be inducted October 11, stands at 5,202. Of this number 3,552 belong to the U.S.A. Section and 1,650 to other Sections of the College. He reviewed the College and Section activities for the year and recommended that a mini-convention be held in July 1981 in Snowmass, Colorado.

The Treasurer summarized his detailed report and it was accepted and approved.

The Editor reported that the U.S.A. Section Journalism Awards presentation will be held in San Diego March 9-10 and that the Newsletter deadline is April 15, 1981.

Regents reports were distributed and read, all were accepted.

The report of the Finance Committee was read and approved.

HERB GREWE, Projects Chairman reported on the major project of the Section this year, "Operation Outreach". College President **GEORGE D. SELFRIDGE** who was instrumental in working out the delivery part of this project visited the Philippines in May, reported that Fellow **RAYMOND L. GROVE** of Omaha, Nebraska contacted him about the need for text books, journals and abstracts at the University of The Philippines Dental College and that the Philippine Dental Association had also expressed its needs for books and journals. **GROVE** had interested the Nebraska Chapter of the I.C.D. in the project, and all of District 10 joined in the response. Transporta-

tion was the problem, and President **SELF-RIDGE** enlisted the support of the U.S. Navy. Arrangements were made to forward the books to San Diego and then transport them aboard Navy ships to Subic Bay in the Philippines. Early this year all 14 Districts of the U.S.A. Section joined in the effort and to date, approximately 150 cartons (some 5,000 volumes) have been sent. Plans are now being formulated to extend the operation into Taiwan.

For his idea and his efforts, Fellow **GROVE** will be awarded the H. O. Westerdahl Award "Spark Plug of the Year" at the Deputy Regents' Breakfast on Sunday, October 12.

The Washington Chapter of the I.C.D. presented the Section with a check for \$550.00 to be used for Operation Outreach.

On the recommendation of the Executive Committee, **BRALY** moved and **EBERHARDT** seconded a motion which passed, that Article IV, Section 1 be amended to read "of any recognized dental organization" instead of "of the American Dental Association".

The proposed slate of Councilmen provides for 12 as specified in the College Constitution, Article IX, Section 2. Article X, Section 3 includes the Secretary-General in this number. **EBERHARDT** and Committee is to review this matter as well as proxy vote and report back to the Board at next meeting.

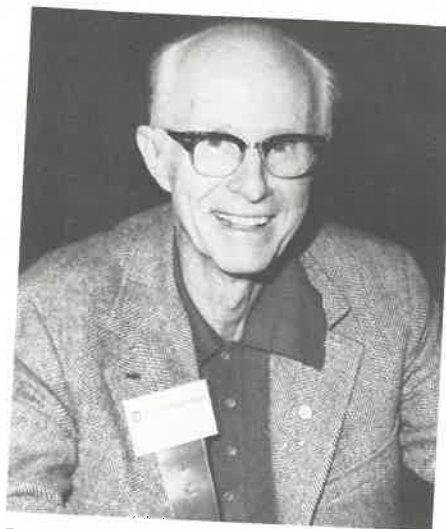
Membership Evaluation Committee Chairman **HERBERT YEE** stated that younger men are now being inducted and that the present Class is composed of 50% under 50 years old. He stressed that those

invited to Fellowship should be of the highest quality and achievements in both the dental profession and community service be noted.

Fellow **ALLEN A. COPPING**, Convocation Speaker, will receive the status of Master on Saturday evening.

Letters from **CHARLES S. HSIA**, long-time member in China, were read. The board was asked to think about the possibility of encouraging him and other Chinese dentists in an exchange of lectures. This was tabled for further discussion and decision at Snowmass.

Representatives from the A.D.A. came to the meeting to advise that the A.D.A. would be holding its opening ceremonies on Saturday in Kansas City next year, with clinics that afternoon. The A.D.A. representatives included **DONALD O. ERICKSON**, 1981 Convention General Chairman; President-elect of the A.D.A. **JOHN J. HOULIHAN**, Mr. **WILLIAM T. McCORMICK**, Chairman of Convention Services. **ERICKSON** explained the changes, and **HOULIHAN** informed the Board that the A.D.A. will meet Saturday, Sunday, Monday and Tuesday to encourage better participation in the annual session on the part of those who can more readily attend weekend meetings. It was suggested I.C.D. move its ceremonies to Friday and assurance given that adequate services would be provided whether a change was made or not. A brief question and answer period followed, and Registrar **KENWARD** voiced a strong protest as to changing established I.C.D. meeting date, seconded by the board. Reply will be made by letter when I.C.D. dates are firm.

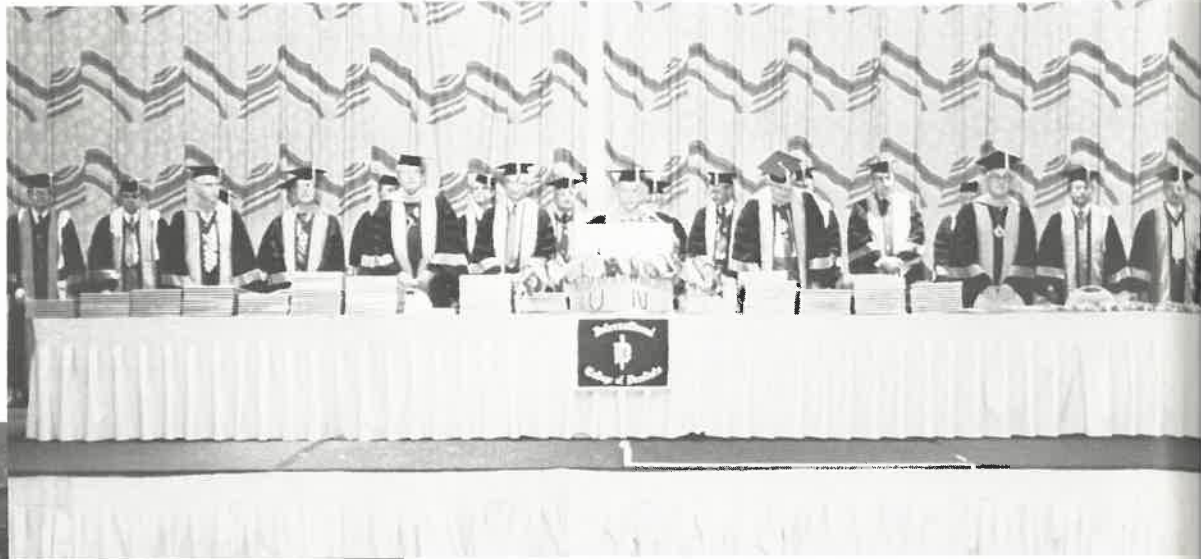

Was this an illicit smuggling operation, bringing forbidden cargo aboard the aircraft carrier USS RANGER prior to its September departure for a western Pacific deployment? Not on your life! It was the Navy Dental Corps reaching out to help dentists around the world!

Officials in the Republic of the Philippines have mandated that the Dental Schools of the Philippines will not receive any financial aid for their libraries until they have at least 250,000 books and journals on the shelves. The International College of Dentists undertook "Operation Outreach" in an attempt to fill the needs of these professional educational institutions in the Philippines, and they requested the assistance of the U.S. Navy Dental Corps in the project.

Several dental schools in the U.S., professional libraries, ICD chapters, several publishing companies, and individual dentists and physicians are donating textbooks and professional journals, which can be used in these libraries. The books are being forwarded to the Navy coordinator, Rear Admiral **JULIAN J. THOMAS, JR., DC, USN**, Commanding Officer of the Naval Regional Dental Center, San Diego, California, with the contributors picking up the postage/freight charges to San Diego.

Expressing his belief in the program, and the goodwill that it will generate, Admiral **THOMAS** stated "This is an excellent example of the traditional teamwork be-

tween the people of this great country and its Navy to help those with a need."

From San Diego, the books are placed on westbound Navy ships with dental officers aboard, such as the most recent shipment aboard the USS **RANGER**. Once the ship arrives in the Philippines, the **RANGER's** Dental Officer, CDR **ROBERT ECKSTEIN**, will transfer the educational cargo to Capt. **B. FRANK TAYLOR**, Commanding Officer of the Naval Regional Dental Center at Subic Bay Naval Station, who will, in turn, present the books to representatives of the local I.C.D. Section who will contact the University of the Philippines, and the Philippine Dental Asso-

ciation and distribute the books.

Any additional individual dentists, organizations, or professional libraries who would like to contribute new, duplicate or discontinued medical or dental books and journals to this worthy project notify the ICD office for instructions on shipping.

PICD (Philippine International College of Dentists) Dental Health Foundation. This is a semi-autonomous body created by the ICD Philippine Section and empowered to raise funds and undertake projects sanctioned by the Section. Dr. **BLANCHE BARBERS** has been very active as Chairman of this Foundation and has entered into a multi-agency agreement for financing and operations of "Project Smile" in Metro-Manila, a community-oriented service program on dental health for school children. Its services include the self-application of fluoride in the form of rinse-ins and/or brush-ins, the removal of plaque by means of brush-outs, and the early detection and prompt fillings of decayed teeth by means of prepaid dental case plans.

The strategies designed to implement the foregoing will include: the Smile Bus, Puppet Show, Smile Club, Smile Squad, Smile Insurance Plan, Smile Media, Smile Fund Campaign, and Smile Awards. Project Smile will be in operation for five years to be recycled every five years thereafter until funds permit and if the project has proved the worth after proper periodic evaluation.
