“**E**ncourage the growth of knowledge and promote its dissemination throughout the world.” I’m not sure with whom that portion of our College creed originated, but it caught my fancy and became my personal motto when I accepted the office of Registrar of the U.S.A. Section and Secretary-General of the College.

As dentists, we have exceptional opportunities to enrich our personal as well as our professional lives by participating in meetings such as those the College sponsors and contributes to all over the world. In so doing, we find we are not only colleagues, but neighbors, with common interests and common goals, for the area of health is not defined by national or geographic boundaries.

Our meetings also accomplish other objectives. We learn from outstanding scientific presentations by essayists and clinicians. We can renew personal friendships and form new ones.

We would like your input, as well. If you will send us your suggestions as to the kind of continuing education program which would be most beneficial to you, we will give them serious consideration in our future plans for “encouraging and disseminating” knowledge.

A Message from Ernesto Acuna, III

It is a privilege for me as a dentist, and an honor for me as a Mexican to serve this organization. At the same time, it is a tremendous responsibility for any individual to represent their colleagues who form part of this worldwide College.

When I learned that I was being considered for this position, the first thing that came to mind was that this office can also be an instrument to promote peace among all men, women and all nations. The Minutes of the previous meeting at the Crown Center Hotel in Kansas City, Missouri on October 23, 1981 and those of the Special Meeting immediately preceding the Regular Meeting were approved by mail ballot.

PRESIDENT'S REPORT

President ALLEN reported on the following: Trip to Southeast Asia in May with Fellows KENWARD and YEE and wives. — Programs presented in the Philippines and induction of 5 new members. — Attendance at the Japan Section meeting and induction ceremony. — Visitation to Tokyo Dental College, sister school of University of Florida. — Lectures and meetings in the People's Republic of China with the hope of reactivating the Section. — Visit to Bangkok and Chulalongkorn Dental School. — Visit to Hong Kong to discuss future plans for Section 22 with Regent WONG — Attendance at the F.D.I. meeting in Vienna in October. — His work with A.D.A. Council on International Relations. — U.S.A. project of sur-

veying programs open in U.S. Dental Schools to dental graduates from other countries. — Announcement that Past President CYRIL DEVERE GREEN and Councilman FRANS LANKHOF were to receive Honorary Membership in the A.D.A.

SECRETARY-GENERAL'S REPORT

The Secretary-General commented that he had been in contact with Chinese Embassy with reference to U.S.A. Operation Outreach program of sending books and that plans are underway for a tour to China in May of 1983. Membership in the College now stands at 5,780 including U.S.A. inductees, with 5,600 in Autonomous Sections and 180 in International Section. He reported U.S.A. Section has sent clinicians to Uruguay, Peru, Norway and Switzerland this year.

EDITOR'S REPORT

The Editor reported that the College publications were received by the Sections and requested continued support from the Sections.

TREASURER'S REPORT

The Treasurer reported that the college was financially sound and the new budget and audit was approved.

FINANCE COMMITTEE REPORT

The chairman of the finance committee stated that the dues will be \$10.00 per member and the initiation fees will be \$25.00 for Autonomous Sections and

\$100.00 for the International Section members as of 1983. The division of expense between the Sections and the College was discussed and it was the feeling that the College would be self-sufficient from the income produced by the new dues structure. The one possible exception could be the Roster, but the amount, if any, can not be determined at this time.

CONSTITUTION COMMITTEE REPORT

Sec.-General **KENWARD** read excerpts from Chairman **GORDON ROWELL'S** letter

citing difficulty in chairing a Committee when he is not present. Fellow **EBERHARDT** said there is no action to be taken by Council until the Constitution Committee has met as suggestions should be considered by this committee before coming to Council for official changes. He requested that a Chairman be appointed so the Committee could meet. Fellow **EBERHARDT** was appointed as Chairman of the Committee comprised of Councilmen **FORREST**, **SIEGEL**, **TAMARI** and **SELFRIDGE**.

SECTION REPORTS

Registrar **SPENCE** reported for the Canadian Section, issuing an invitation to the Council to meet in Montreal in 1984. President-elect **ACUNA** reported for the Mexican Section in Councilman **CHISIKOVSKY'S** absence.

South American Section President **JULIO BARRANCOS-MOONEY** gave Section 4's report. On October 29, 21 new Fellows were inducted in Caracas, Venezuela. He recommends dividing this Section into 3 Districts and stated Brazil has asked for its autonomy. South America would like 3

Fellow **HORIUCHI** read the report of the Japan Section, and Councilman **KAWABE** distributed copies of their Journal.

Philippine President **PRIMO GONZALES** updated Section 30's report, detailing various programs sponsored by that Section.

Fellow **TAMARI** reported for the Middle East Section and distributed copies of that report. He stated the Section is in a state of total disarray, and since it was divided into districts with autonomous powers, it is gradually disintegrating. He requested that the Middle East Section be absolved from paying dues for Iran members who cannot be reached. He questioned if the College has the mechanism to give I.C.D. Fellows the

Introducing John W. Hein

AN INTERVIEW



JOHN W. HEIN

Interview with John W. Hein, the new President of the ICD

REPORTER: Where were you born?

HEIN: In Chester, Massachusetts.

REPORTER: Where is that?

HEIN: I hope you mean where's Chester. Everyone knows where Massachusetts is.

REPORTER: Yes, where's Chester. We'll get to Massachusetts in a minute.

HEIN: Chester is a small town deep in the Berkshire Hills. It's about 120 miles west of Boston. Of course, I only lived there nine months, then the family moved 20 miles downstream to Westfield where I grew up next door to Jinny.

REPORTER: Who's Jinny?

HEIN: My wife. I've always known a good thing when I've seen it.

REPORTER: Yes, of course. Where did you go to college?

HEIN: American International College in Springfield, Massachusetts. That's 10 miles further downstream from Westfield.

REPORTER: You seem to be pre-occupied with water.

HEIN: You're right. Fishing is one of my oldest hobbies.

REPORTER: Leaving fishing for a moment, what did you major in at AIC?

HEIN: Chemistry and mathematics. The latter was a mistake.

REPORTER: What do you mean mathematics was a mistake?

HEIN: It taught me to see things which many other people are not bothered by. For example, you look at a budget, you analyze where and how the money flows and you know who controls the show. It can scare you to death and it's a habit that can make you as popular as a barracuda in a school of mullet.

REPORTER: Did you graduate from college?

HEIN: Yes. Received a B.S. and was

valedictorian of the class of '41.

REPORTER: How come you decided to be a dentist?

HEIN: Jinny's stepfather was a dentist. I worked a couple of summers doing laboratory work for an orthodontist. I won a four year full tuition scholarship to Tufts Dental School.

REPORTER: Did you enjoy dental school?

HEIN: Absolutely. It was an exciting intellectual adventure.

REPORTER: Did you enjoy dental school?

HEIN: Absolutely. It was an exciting intellectual adventure.

REPORTER: That description is a bit unusual. Would you please explain it.

HEIN: It was the environment. The Dean was Basil Bibby, a microbiologist. The head of the clinic was Joseph Volker, a biochemist. The head of oral pathology was Irving Glickman.

The head of oral diagnosis was Helmut Zander. The head of the dental research department was Richard Manly, a chemist. All of them were up to their armpits in research and any student interested in participating was heartily welcomed. I was and did.

REPORTER: That explains your interest in research. Did you go directly into research upon graduation?

HEIN: Hardly. It was 1944. Spent three and a half years in the Army Dental Corps after a six month oral surgery internship with Bert Anderson at Grace Memorial Hospital of Yale Medical School.

REPORTER: Did you enjoy the Dental Corps?

HEIN: Very much. Actually I volunteered for an extra year of service and almost decided to stay in the Corps.

REPORTER: Why didn't you sign up?

HEIN: I received a letter from Dr. Bibby who was leaving the Deanship at Tufts to become Director of the Eastman Dental Center in Rochester. He said I'd had enough fun and should return to the serious business of preparing for a research career. He had seen Trendley Dean at NIH and had lined up an NIH fellowship for me so that I could work for a Ph.D. at the University of Rochester.

REPORTER: That must have been an important decision for you.

HEIN: It certainly was. I was stationed

in Hawaii and knew what paradise was like.

REPORTER: But you went to Rochester. Why?

HEIN: I guess the inspiration of the faculty at Tufts had irreparably added my senses but I've never regretted the affliction.

REPORTER: How long were you at Rochester?

HEIN: Seven years, from 1947 to 1955. It took five of them to earn my Ph.D. under Dr. Harold Hodge in Pharmacology. I spent two more years as the first head of the Department of Dentistry and Dental Research.

REPORTER: I don't wish to be impolite but isn't five years a long time to take to earn a Ph.D.?

HEIN: It's not long if you are happily involved in research, running a department while still a graduate student and supporting yourself and your research with industrial research grants. Actually the average time for the Rochester dental fellows to obtain the Ph.D. at that time was 4-5 years.

REPORTER: I note you left the Chairmanship of the Department at Rochester to become the Dental Director of the Colgate Palmolive Company in 1955. Wasn't that decision a bit unusual?

HEIN: Most people thought so. However, at that time NIH was still an unimportant factor in the support of biomedical research. Since my research at Rochester was largely supported by industry, I thought it would be interesting to move to the other side and try to foster industrial-academic interaction from that angle.

REPORTER: Was that a satisfying experience?

HEIN: Immensely so. I learned that excellence in research was not confined to academia. There is also something very exciting about participating in the R and D process which finally brings a successful product to market.

REPORTER: But you left Colgate for the Deanship at Tufts. Why?

HEIN: It was my dental school and they asked me to come.

REPORTER: The decision was as simple as that?

HEIN: Almost, except for the mathematics. It involved a 50% cut in pay.

REPORTER: After three years as

Dean you left Tufts in 1962 to become Director of the Forsyth Dental Center where you have been for the last 20 years. Why the move and why no moves since?

HEIN: In 1962 dentistry had no internationally reknown independent research institutes comparable to the many existing in medicine. I believed that, if one were to exist, Forsyth was one of the few places, if not the only place, where one might be developed. When the Trustees of Forsyth asked me to become Director I knew it was probably the one chance in my lifetime to attempt such a project. As to the twenty years, I guess the soil at Forsyth was right for my roots.

REPORTER: Please don't be offended, but many dentists I've talked to have never heard of the Forsyth Dental Center or its research institute. Didn't your aspirations materialize?

HEIN: Oh, they materialized. Forsyth's Research Institute is today the largest independent dental research institute in the world. There are 45 full-time scientists on the staff and the Institute's budget is over \$4,000,000. Forsyth is very well known in the international dental research community.

REPORTER: You were not offended by my remark?

HEIN: Of course not, unfortunately it's true. Most dentists are not deeply interested in the research arm of their profession.

REPORTER: Why is it unfortunate?

HEIN: It's unfortunate because the research taking place today is going to yield payoffs which will produce drastic changes in the future practice of dentistry. By not being better informed about the existence and progress of this research, most practitioners will be caught by surprise and less able to cope. If one can anticipate change, adaptation to it is always easier.

REPORTER: Back to the Research Institute. You must be proud of its success. What's the secret?

HEIN: No secret. I followed the advice of Professor Hodge at Rochester.

REPORTER: What was that?

HEIN: If you want to develop an out-

standing organization, surround yourself by people who are smarter than you are and spend your own time making it as easy as possible for them to excel.

REPORTER: Apparently that was good advice. Does Forsyth have other programs?

HEIN: Yes. The Forsyth School for Dental Hygienists is the second oldest and the largest private dental hygiene school in the United States. Our Infirmary Division has postdoctoral programs in Endodontics, Orthodontics and General Dentistry designed to train people for academic research careers.

REPORTER: Isn't the combination of the largest private research institute and the largest private dental hygiene school a strange mix?

HEIN: Some people thought so. Actually it makes great sense. For example, many research discoveries related to prevention can best be brought to the public by the hands of the dental hygienists. After all, they were originated with the idea that they would bolster the preventive side of dentistry. From the dental hygiene side being located in the midst of a research institute provides a research oriented environment for our students which few dental students are fortunate enough to enjoy.

REPORTER: It is obvious that research is a major interest of yours. Is that the only facet of dentistry in which you are interested?

HEIN: Hardly. Dentistry consists of three interconnected arms; namely: practice, education and research. If research is going to create drastic changes, it

will affect the other two areas of the profession. I believe it is essential for people in my position to be involved in the affairs of all three arms so as to be in a position to speak out about what research holds in store for the future.

REPORTER: What kind of involvement do you mean?

HEIN: Well, in my case it means to be an active member of the ADA, the American Association for Dental Research and the International Association of Dental Schools. To attend all their important meetings and to speak out on issues. It has also meant serving as an Officer and President of the Massachusetts Dental Society and the USA Section of the ICD.

REPORTER: In ancient times bearers of tidings portending change often were executed. It seems that perhaps you may often have found yourself in such a position; at least figuratively.

HEIN: Frequently, but one gets used to it.

REPORTER: As the President-elect of the International College of Dentists, do you have any special thoughts?

HEIN: Of course I feel very honored to have been selected to be President. The College is the international honorary organization of dentistry. But more than that, the College is also dedicated to fostering the pursuit of excellence and knowledge by the dental professions in all countries of the world. I sincerely hope to do my best to help the College fulfill these missions.

REPORTER: One last question which has been bothering me from the beginning. Where is Massachusetts?

HEIN: It's the part of the United States which keeps Cape Cod from floating out to sea.

PRESIDENT'S REPORT

President **MALLERNEE** reported on his year in office. In addition to attending area meetings of the College, President **MALLERNEE** presented a plaque to the American Society of Dentistry for Children from the I.C.D. in honor of 50 years of continuous publication of their journal.

REGISTRAR'S REPORT

The Registrar reported on his extensive travels this year and thanked College President **DON ALLEN** and Regent **HERBERT YEE** for participating in the trip to the Orient for lectures and induction ceremonies and further development of Operation Outreach. He recommended a meeting of the Membership Evaluation Committee next year and consideration of a joint meeting with Canada and Mexico in the future. He also stated that dues to the College will be increased to \$10 for all members, and with this, the College should become self-supporting.

DECEASED

A list of those deceased since last year's meeting was read. A moment of silence was observed in memory of these members: A \$15 memorial contribution is made to A.F.D.H. for each of those deceased.

EDITOR'S REPORT

The Editor reported that the Newsletter was receiving good support by the Sections and the deadline is April 15. The Letterette is well supported by the State Chapter. Journalism Awards will be presented April 10 in Scottsdale, AZ. in conjunction with A.D.A. Council on Journalism meeting.

TREASURER'S REPORT

The Treasurer's report, budget and audit of the Section were approved.

REGENTS' REPORTS

Regents Reports were received and accepted.

Regent **BRINKER** reported that Treasurer **JOHN REIFKE** received the Alumnus of the Year award from Case Western Reserve University and that Vice President **RICHARD RICE** would be honored by the Ohio Dental Association. The Board offered congratulations to both members.

HONORARY AWARDS COMMITTEE

The Honorary Awards Committee reported that **A. JAMES KERSHAW** and **L. D. PANKEY** would be elevated to the Status of Master at the banquet Saturday evening, and Honorary Fellowship would be conferred upon **KAMAL ASGAR** and **THOMAS J. GINLEY**.

INTERNATIONAL CLINICIAN

International Clinicians Chairman **GEORGE J. COLLINGS** reported that the Section's Clinicians and host countries were: **WILMER EAMES** to Norway; **H. LOREN MILLER** to Switzerland; **NASEEB L. SHORY** to Uruguay; **JAMES MARSHALL** to Peru.

The Board congratulated **COLLINGS** for his efforts in coordinating this.

INTERNATIONAL RELATIONS

College President **DON L. ALLEN** reported for International Relations and Reverse Flow Scholars. He had been contacted by the A.D.A. Council on International Relations to assist them send out letters to some 50 Deans requesting reply if they were willing to participate in a project of gathering photographs of dental school design and structure from around the world. These will be displayed at the 1983 A.D.A. meeting. To date 12 affirmative replies had been received. During the year he did a survey to see what U.S. Dental Schools could offer foreign dental graduates in advanced education. 48 schools replied, listing 261 different programs.

He recommends the I.C.D. publish a brochure including the information obtained from the survey and be sent to Presidents of all Sections with instructions for them to promulgate them to all dental schools and national dental associations in their Section, and that survey and the brochure be updated every 4 years. This recommendation was approved unanimously.

Fellow **ALLEN** also spoke on his attendance at the F.D.I. meeting in Europe. He further recommended that the I.C.D. consider holding a biennial international meeting which could be held in conjunction with the F.D.I. or separately, the meeting to include a business meeting, international lectures, continuing education courses, a general meeting to recognize incumbent I.C.D. and Section Presidents and new members in attendance, and forums for the exchange of projects and ideas. A program

committee should be appointed with members of the host country appointed in prominent positions on the committee. These recommendations were approved unanimously.

MEMBERSHIP EVALUATION

Membership Evaluation Chairman **JACK B. RICE** reported that a re-evaluation is necessary at this time. Registrar **KENWARD** said plans are to hold a membership Evaluation Committee meeting next year to determine what is happening within the organization as the last meeting was 6-7 years ago.

PROJECTS COMMITTEE

Projects Committee Chairman **LAURENCE C. WRIGHT** stated that 7 projects had been voted on in Chicago and final action needed to be taken by the Board at this meeting on those not considered separately.

A grant for dental research was approved unanimously on motion by Chairman **SAPP** that USA Section of the I.C.D. support international dental research programs that promote the growth and dissemination of significant scientific knowledge throughout the world and that such support be evaluated for approval or disapproval at the discretion of the Board of Regents during their Annual Meeting.

Chairman **BRINKER** proposed the adoption of "Operation Counsel" to aid senior dental students in transition to professional in areas where there is no dental school. **LUNDHOLM** recommended advising Deputy Regents of this service and **HERBERT** suggested letting each school know what dentists would participate in each area. Approved.

A "Big Brother-Big-Sister" program to encourage new graduate dentist to participate in organized dentistry and aid

them in adjustment from student to professional proposed by Chairman **R. RICE** was approved.

Fellow **HAWKINS**, Chairman of the Post Graduate Education Committee, moved that the Post Graduate Education Committee of the U.S.A. Section proceed to establish an annual Post Graduate Education Conference with the first conference to be held in 1983. No fee would be charged to members for these courses in central locations beginning at Washington University, St. Louis, MO. Carried.

The Board also conferred Life Membership on disabled members **ADOLFO BRUNI** of Texas, **A. M. LAWSON** of California and **PAUL F. SIEGEL** of Ohio.

CERTIFICATE

CERTIFICATE DESIGN — The Canadian Section proposes a new design for the Membership Certificate. That and the current certificate were shown to the Board. Although the present one contains some archaic language and countries of the College speak languages other than those used thereon, the Board approved retaining the present certificate.

INVITATIONS TO COUNCIL — Europe and Canada have invited the Executive Council to meet there in 1984.

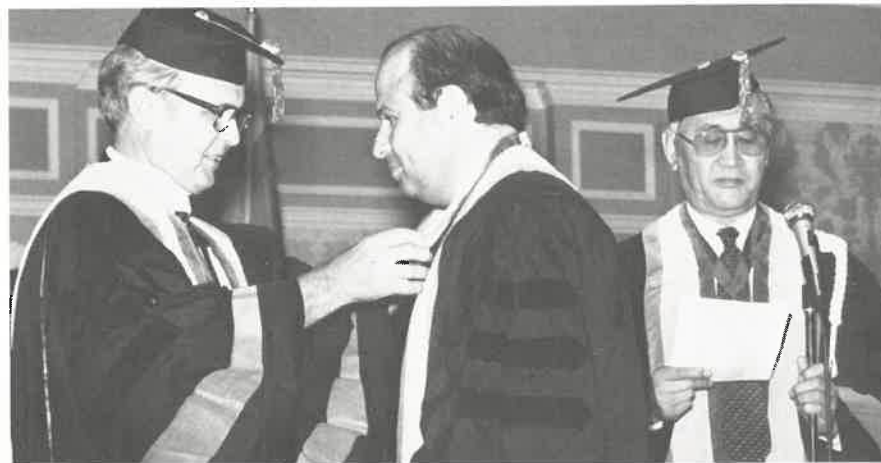

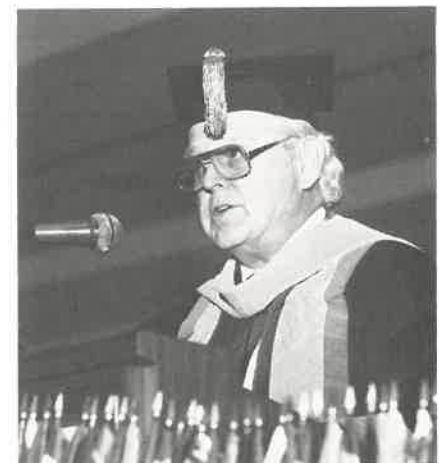

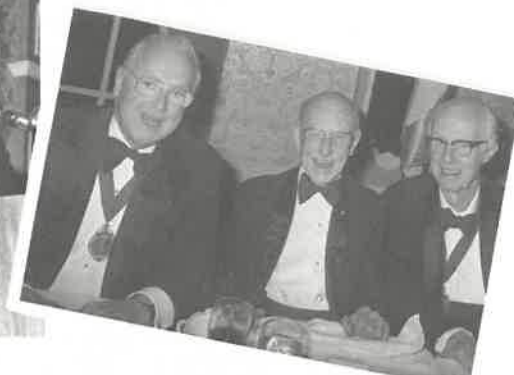

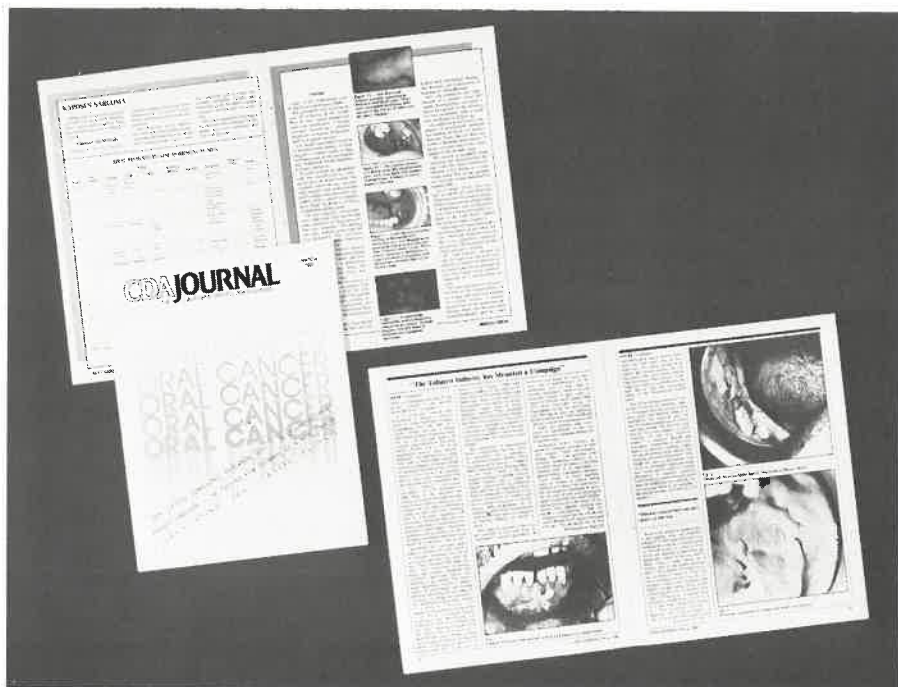

U.S.S. POINT DEFIANCE**

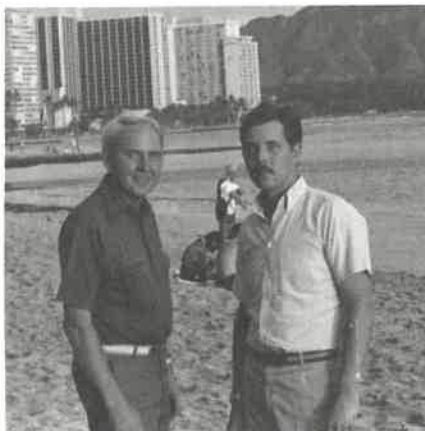

He was able to take advantage of a program instituted a few years ago by the United States Navy, called a family or "Tiger" cruise. What essentially is involved is the opportunity to join a family member who is currently on active duty aboard a ship. His son, **ENSIGN PAUL JR.**, is serving aboard the U.S.S. Point Defiance (LSD-31), a ship 550 feet long by about 80 feet in width. It normally carries a crew of 250; 20 officers and 350 combat-loaded Marines. The Point Defiance recently completed a six-months cruise, part of a squadron of five ships that departed San Diego last spring to engage in amphibious exercises in the Western Pacific.

The "Tiger" cruise is put together by a number of people, headed by the captain of the ship who appoints a cruise coordinator. Crew members are invited to inform their families of the opportunity to join them. It is limited to males. There are females aboard some ships, for example, Navy nurses on hospital ships and transports, but theirs had none.

He was referred to a travel agency that makes all the transportation arrangements. "Tigers" pay for them personally.

He made reservations to fly to San Diego the last days of September and join with the other "Tigers." They flew to Honolulu at their expense and were transported directly to their respective ship. The annual tradition of contributing \$100.00 to the T.D. Health Foundation preceded election of officers.

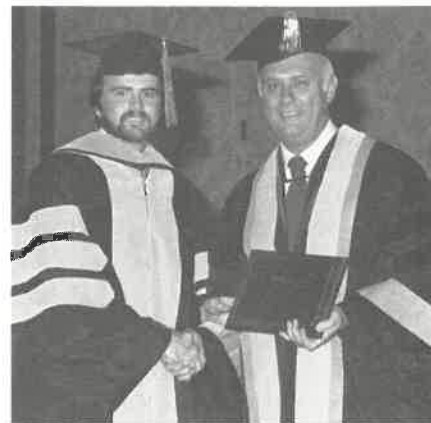

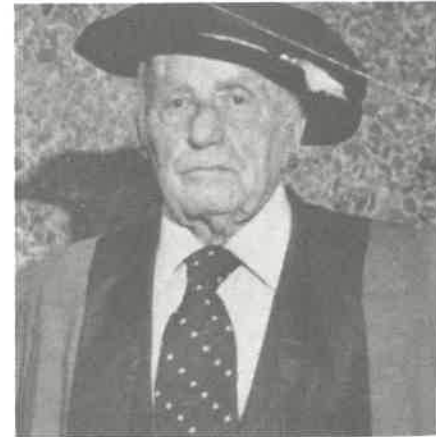

CYRIL DE VERE GREEN 1909-1983



CYRIL DE VERE GREEN

It was spring and yet not springlike. Rain threatened and there was a blustery cold wind. Yet they came in hundreds, from the very young — grandchildren — to the old. They were family and they were friends, professional colleagues and those who shared the same enthusiasms and hobbies. They came from close by and they came from abroad, for his influence extended far beyond the boundaries of the village of Hambledon where he was buried.

A service of thanksgiving for the life of Cyril de Vere Green was held at the University Church of Christ the King in London on Friday the 22nd of April, 1983. This splendid church, occupying a position in the Bloomsbury heart of London University was filled with those who had been influenced by the special qualities of the man. Dominating the service, the organ music was a reminder of Fellow de Vere Green's keen interest in music and musical boxes.

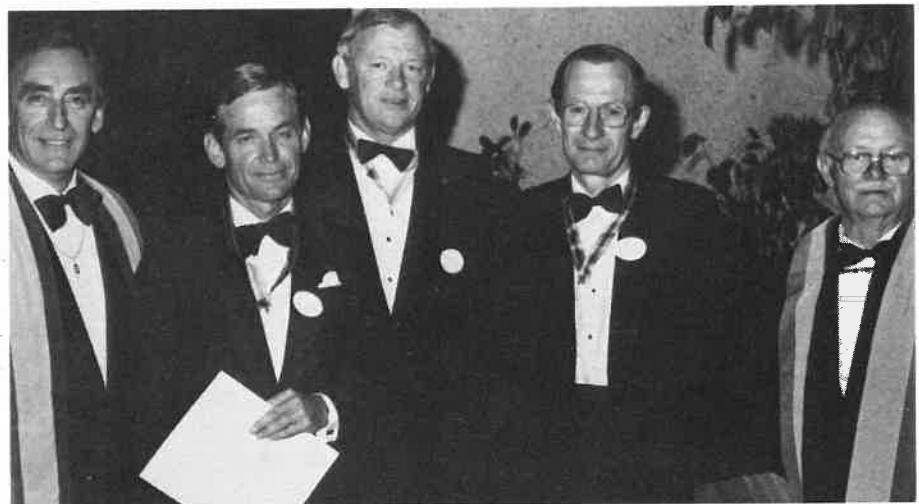

A Message from J. G. Sutherland

SOME ASPECTS OF DENTISTRY IN THE AUSTRALASIAN SECTION OF THE INTERNATIONAL COLLEGE OF DENTISTS

The Australasian Section of the College covers an enormous area in that the continent of Australia itself spreads over approximately 3,000 square miles and although much smaller, New Zealand is some 2,000 miles distant.

It will be readily appreciated therefore, that frequent personal contact between Fellows residing in this vast area is not easy. And this is basically the reason why a comprehensive get-together of Fellows in the Section is normally only possible every two to three years when Convocations are held in conjunction with Australian Dental Congresses in one or other of the mainland Capital cities.

The most recent Convocation of the College was held in Perth, Western Australia on May 2nd, 1982 in conjunction with the 23rd Australian Dental Congress. Despite the relative isolation of Perth on the continent — being some 1,400 miles from Adelaide, its nearest Capital city, this Convocation was an outstanding success, attracting an all-time record number of participants. Apart from these Convocations however, at somewhat infrequent intervals each State holds its own meetings which usually take the form of College dinners.

The economic conditions affecting Australia and New Zealand at present are probably no different from those affecting other countries elsewhere and very clearly Australasia is experiencing the full impact of a recession, to put it mildly. This of course is reflected in the profession where the opportunities for practice are bad, with many of our young graduates just out of Dental School literally being unable to find positions. Even very senior Dental practitioners are suffering, although on the credit side, many are immeasurably improving their golf handicaps as their appointment books display ever-increasing numbers of blank spaces.

Much of this is attributable of course to the economic climate, but it cannot be ignored that the effects of water fluoridation in Australia — with 66% of the population living in fluoridated areas, has made its contribution. Furthermore, the advent of operative auxiliary Dental personnel has had a very real impact on dental manpower. For many years now, School Dental Therapists with

similar qualifications to those of the well-known New Zealand Dental Nurses have been operating in our Schools and the latest figures available for Australia show that in 1980, some 1186 were estimated to be so engaged. In addition, it was estimated in that year that there were some 56 Dental Therapists practicing under the supervision of dentists in Western Australia and 92 Dental Hygienists practicing under similar conditions in South Australia.

Finally, there are the Dental Technicians who have been given chairside status to deal directly with the public in Tasmania, Victoria and New South Wales. These operative auxiliary personnel of which 478 were estimated to be operating in 1980, enjoy various titles — such as Dental Prosthetists (New South Wales), Advanced Dental Technicians (Victoria) and Dental Mechanics (Tasmania) but collectively the Australian Dental Association refers to them as "Denturists".

Now the total active dental workforce in Australia on December 31st, 1980 was estimated to be 6,283 Dentists, but the effect of some additional 1,800 operative auxiliary Dental personnel on private practice must indeed be obvious, and the numbers are forever increasing.

Despite this, or perhaps because of it, the social status of the Dental profession in the Australasian Section has never been higher. However, this has not always been the situation in comparison with our American Dental colleagues and our Australasian Medical colleagues who seem to be more highly respected by the community — at least in the past as far as Australia is concerned.

But more recently in this part of the world, the tides of change have become increasingly more obvious and it might well not be confidently stated that the situation could be in reverse with respect to the Dental and Medical professions. Dentistry in the eyes of the public is certainly on the up and up, and seldom these days in the media does one ever see or hear any criticism of the Dental profession — even though as with other professions it is experiencing a bad time. Without doubt, the profession has gained tremendous respect of the community by advocating water fluoridation — to, in the public's eye, its own detriment.

Turning to Dental School education in Australia, the economic climate is also

having its effect, and this essentially because of decreased funding of the Universities, all of which are virtually free, and therefore apart from some Bequests, almost entirely dependent for their existence upon Government Grants.

There are 6 Dental Schools in the Section, five being in Australia and situated within the Capital cities of Sydney, Melbourne, Brisbane, Adelaide and Perth; and one in Dunedin which is situated in the South Island of New Zealand. Each School enjoys full Faculty status within its University, and although most are not really located on campus, they adjoin or actually form part of Dental Hospitals which basically treat patients unable to afford private dental fees.

It is from these Institutions, controlled by Boards of Management from which the Dental Schools derive not only their clinical teaching material but also much of their clinical equipment which incidentally is very modern and largely obtained from European or Japanese firms. In general, the Dental Hospitals are funded from State Government sources, while Dental School staff, research equipment, basic teaching aids, etc. are financed from University sources which in turn depend on grants from the Commonwealth Government for their operation.

The staffing of the Dental Schools consists of full-time teachers appointed by the University with positions ranking from full professors through to associate professors, senior lecturers, lecturers or tutors. Part-time staff is also appointed from amongst members of the practicing profession both in general and specialist practice. These professionals are employed as clinical instructors and play an important role in marrying the realities of private practice with the not-always-mundane approaches by the academics.

The teaching philosophies and curricula in the several Schools are very similar and tend to combine in their 5-year courses, the best aspects of both American and British Dental undergraduate education. The Deans meet annually in one or other of the Capital cities of Australia and New Zealand and in addition there exists an Association of Dental School Teachers which meets each year in conjunction with National I.A.D.R. meetings. Thus, it is possible to obtain some uniformity of courses and in fact the similarities between the various

curricula are such that, subject to places being available, it is not difficult for a student mid-course to readily transfer at the same level to another School.

Conscious of the current economic climate, unfortunately there seems to be a decline in the number of students interested in enrolling in the Faculties, as a result of which, although each Faculty has an intake quota, the standard of entrants tends to be lower. In Australia, the student intake ranges from about 30 in the smallest School which is in Western Australia to 130 or so in Sydney. In 1981, the total number of undergraduate dental students in Australia was 1,425 and interestingly enough 25% of these were women — a trend that has become increasingly obvious over recent years. The number of graduates from Australian Dental Schools in 1980 totalled 274 and the corresponding

figures for New Zealand are an annual intake of about 60 students with graduating classes between 50 and 55.

It would appear that in the present circumstances, the Dental profession as with Medicine is being oversupplied and the Australian Dental Association is currently very concerned about this trend. It is estimated that the annual output from our Dental Schools would just about equal the wastage and to this end some of the registration authorities in the Section, have, irrespective of quality, placed restrictions on the entry of Dentists with foreign qualifications desirous of practicing in Australia.

In so far as the activities of the Australasian Section of the College are concerned, these can only be said to be exciting to contemplate. The newly elected Board of Regents which recently met in Sydney has many projects in mind

— one of the most significant being to devise ways and means of assisting our less fortunate colleagues in the Asian-Pacific region. To this end a Committee is currently exploring the possibility of sending much wanted literature to these countries and in due course lecturers and clinicians to their Schools, professional associations and Health Departments. Another method being considered is the possibility of bringing selected Faculty members from their Schools to visit our own Schools for short periods of time, and while in our Section to be accommodated by Fellows of the College. In this way, not only would we be meeting one of the objectives of the College of "... fostering the growth and diffusion of Dental knowledge" but we would also be living up to the basic concept of its being truly International, not only in name but also in deed."

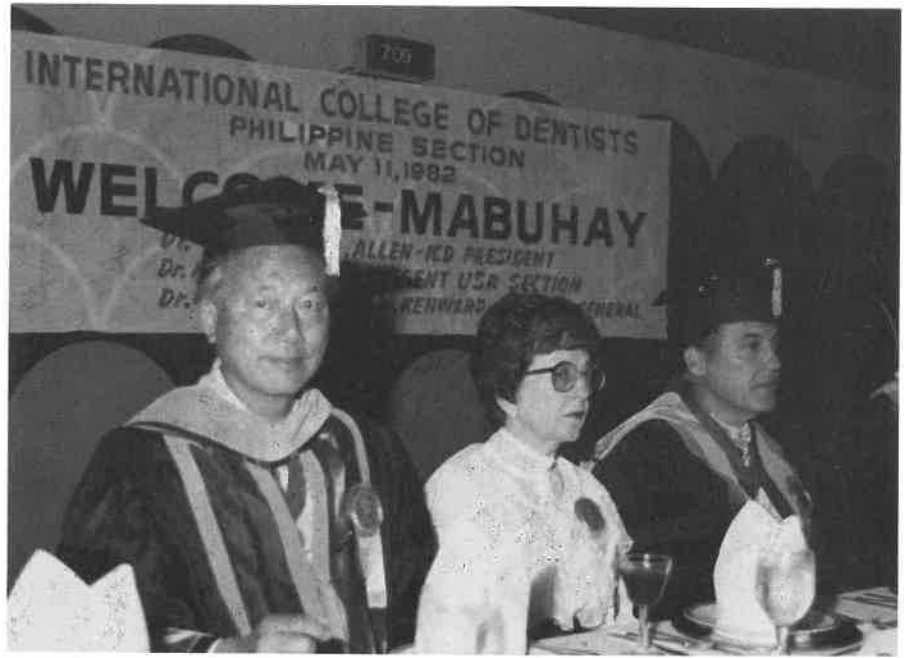


Five Distinguished Dentists Elected to Fellowship

Taiwan

The first four Taiwan FICDs were all recommended by Fellow **GORDON R. AGNEW**. They were Dr. **JEE-LUM WONG** (1958), Dr. **KWAI-WANG SHYU** (1962), Dr. **HSIAO-BSUNG FAY** and Dr. **CHIEN-YUAN HWEI** (1972). In 1978, Fellow **KWAI-WANG SHYU** recommended nine candidates for Fellowship before he went to the United States to attend I.C.D. and A.D.A. annual conventions in Anaheim, California. Immediately after the meetings, a group of I.C.D. members and their wives visited Taiwan. The first I.C.D. Taiwan Dental Seminars were held at the Veteran's General Hospital in Taipei. More than two hundred dentists attended the seminars. Nine new Fellows were inducted at a special ceremony in November, 1978. The Keys were presented by the President of the College, Fellow **CYRIL DE VEREGREEN**. During that year, the Deputy Regent of Taiwan District was **C. Y. HWEI**.

In the next year, Fellow **HWEI** left Taiwan and Fellow **KWAI-WANG SHYU** was nominated to be the succeeding Deputy by the Regent of Section 22, Fellow **WILLIAM W. WONG**. He planned to expand I.C.D. memberships in Taiwan area and

recommended twelve Taiwan dentists as the candidates for fellowship in 1980. They were then inducted by Fellow **JOSEPH W. TAMARI**, the President of the College on May 12, 1981 in the Tri-Service General Hospital in Taipei. It was the first formal induction ceremony in this area. All the fellows were in I.C.D. caps and gowns. The ceremony was very successful. It paved the way for future development of our College in Taiwan.

On May 15, 1982, another twelve new fellows were inducted at Tri-Service General Hospital. support they need, and recommended the formation of an "Emergency Committee" to meet the needs and coordinate relief in emergency situations. **SELFRIDGE** recommended a committee be appointed to develop guidelines and report back to Council. The President asked if there were other situations where this Committee could serve, and that it should cover all such matters as defined. **TAMARI** moved that the President appoint an Emergency Committee to handle emergency help, **SPENCE** seconded and the motion passed.

Vice President **HEIN** inquired who may be on Committees; **KENWARD** replied any member of the College was eligible. **HEIN** recommended that Past Presidents could comprise this Committee as ex-officio members of the Council. President **ALLEN** said the Constitution Committee should consider that in order to avoid an excess of Committees, a Past Presidents' Committee could serve as Emergency Committee. Approved by common consent and turned over to Constitution Committee for action.

The Australasian Section had appointed Past President **CYRIL DE VERE GREEN** as its representative, and he was called on to report. Section 29's new Registrar is **ROBERT NORTON**. As Convocations are held only every 2-3 years, Fellows are inducted at local dinner meetings of which 3 were held this year.

Fellow **KWAI WANG SHYU**, Regent of Taiwan, was present and reported on I.C.D. matters in that country.

The International Section report

prepared by the Central Office Secretary stated 12 Fellows were inducted in Taiwan in 1982 and 14 will be inducted in 1983. Fellows **SHYU** and Fellow **P. C. KWONG** of Hong Kong were elevated to the status of Master, Regent for Korea is **HUEN TAIK JHEE** and Regent for Hong Kong is **JEFFREY TSANG**, Fellow **WILLIAM W. Fellow **JULIO BEGAZO** Registrar of Section 4, discussed the Section's division into two autonomous Sections. It was decided to postpone this division at the present time.

The South American Section was divided into three Districts rather than the present division of two with District A being composed of Brazil; District B being composed of Argentina, Uruguay, Paraguay and Chile; District C being composed of Peru, Bolivia, Ecuador, Columbia, Venezuela, and the Caribbean Islands.

Section meeting dates as known for 1983 were announced as follows: U.S.A. — Anaheim, CA October 1, 1983; Canada — Vancouver, BC September 24, 1983; Mexico — November, 1983; South America — Buenos Aires, October 23-26, 1983; Europe — Vienna, June 2-5, 1983; Japan — Tokyo, May 14, 1983; Philippines — May, 1983.
