## ***A Message from Franklin M. Kenward***



**FRANKLIN M. KENWARD**

**T**he International College of Dentists continues to serve the profession with dignity and devotion. Each section now has developed its own projects and encourages its members to personally participate in their fulfillment.

It hardly seems possible that it has been 10 years since I wrote my first message for the Newsletter as your Secretary-General. In those 10 years College membership has grown from 2,227 to 6,447 Fellows, and the College has expanded its activities and global influence as well.

During my 26 years as a member of the College, I've had the pleasure of meeting and coming to know as friends dedicated men and women of our profession from every continent. This same fellowship is as available to each member through his Roster, a world-wide directory of those who share similar ideals, interests and objectives. One of the great bonuses of College membership is this opportunity for discovery of these common bonds with members whose cultural, political or social climate may be quite different from our own.

Recently, in response to the amicable provocation of Past President Gordon Rowell of Australia, South African Fellows Helmut Heydt and Ellie Lasersohn invited me to their country to discuss expansion of the College there. We had the opportunity to present the purpose, function and objectives of the College to approximately 40 outstanding prospective members in Johannesburg, Cape Town and Durban, and much interest was evinced. Of course, there are always problems in creating a new section, but nothing is impossible. The thriving South American Section, which many said could never be viable because of the political and language differences existing there, attests to that!

In its first annual meeting outside the United States, the Executive Council of the College met this year in Montreal, in conjunction with the Convocation of the Canadian Section. I was privileged to receive honorary membership in the Canadian Section, an honor especially significant to me because my father, also a dentist, was Canadian by birth. Following a Council meeting in San Francisco in 1985, the group will convene in 1986 in Amsterdam, another indication of our international strength and cooperation.

This year the USA Section has launched a new project, to record for its archives the outstanding leaders of international dentistry on professional quality audio-visual tapes. Focus of the project will be the "quality of leadership" and how it developed among these dentists who have contributed to the profession with such distinction. The first of these leaders to be filmed was, fittingly enough, Fellow H.O. Westerdahl, who served as College Registrar and Secretary-General for 18 years and guided the organization to the strong and prestigious position it holds today. Several hours of interviews with "Westy" have been condensed into a 20-minute tape and will be made available for viewing to all College sections, as will subsequent tapes.

The College continues to emphasize quality above quantity and to replenish our ranks with the best of our profession. To our new ICD Fellows we wish a bountiful year of learning and fellowship. We recognize your accomplishments and are proud to have you join us.

And we urge all Fellows to continue to supply information about your activities to the Newsletter and other publications, to continue to send your suggestions or comments to the Central Office. Help us keep the lines of communication open.

## ***A Message from John W. Hein***

**I**t is a great honor to have the privilege of sending the greetings of the President of the College to Fellows throughout the world and I do so with humility. Each of you were invited into the College because you had demonstrated excellence and outstanding achievements in some facet of the practice of dentistry. Since the measurement of professional achievements must take into account the environment in which accomplishments take place, every Fellow of the College is in fact a unique and outstanding leader. Thus, from my view as President, all Fellows of the College are far more expert in what they do than I. This is as it should be in a community of leaders.

I hope that you all sense as I do that the College is now gathering momentum which hopefully will carry it to every nation where the profession of dentistry exists. This too is as it should be because science and art transcend political borders and in each nation there are most certainly exceptional individuals whose accomplishments in dental practice, dental education or dental research make them deserving of the honor of election to the College. And when we identify and honor them, we add new stature and significance to the College itself.

As the College becomes more truly global in scope, as the founders intended it to be, we must be very careful not to erect any barriers which will inhibit those identified as worthy of election to Fellowship from accepting the honor. The most likely of these barriers may be a financial one wherein dues or induction fees may be set so high that they are unrealistic in relation to the economic conditions existing within a particular nation. Wherever this situation might arise it would intrude an unwarranted burden on those singled out for the honor of election to the College. This is not as it should be. For this reason I have recommended to the ICD Council that a graduated dues and induction fee structure be established which is based upon the comparative per capita income of nations. This would seem to offer the fairest method for assuring that outstanding dental teachers, dental scientists and dental practitioners throughout the world may equally aspire to the honor of being elected an ICD Fellow.

Looking ahead to the future, there are good reasons to believe that those purposes of the College related to fostering the exchange of information and knowledge will become increasingly important. Many dramatic changes affecting dentistry are taking place in different parts of the world. The prevalence of dental caries is declining in some areas and increasing in others. The median age of the population is increasing in some nations and decreasing in others. The prevalence of periodontal disease varies widely throughout the world. In some countries dental schools are closing while other new schools are opening. And while all these changes occur, dental science is yielding progressively more effective methods for controlling, preventing, or treating oral diseases. All of these factors will exert different effects on the dental professions in various nations. As never before, dentists throughout the world have much to learn from each other and as never before they have great need to learn from each other.

Thus, if one were to imagine an era when the International College of Dentists might most completely fulfill the aspirations of those who founded it, the years leading from now to the onset of the 21st century would be that time. Having achieved an international organization of the most outstanding members of the dental profession, the challenge before us is to increase the ways in which this resource of talent can help play a role in determining the future of dentistry.

It has been said that many societies are leaving the period of industrialization and entering an information era. Perhaps it is time, therefore, for the College to consider what it might do to improve the flow of information among the Fellows about major

### CONSTITUTION COMMITTEE REPORT

Councilman SIEGEL reported for the Constitution Committee in the absence of Chairman EBERHARDT that on November 6, 1982, the Constitution Committee met following the Annual Meeting of the Executive Council in Las Vegas, Nevada, USA. Present were JOHN FORREST, IRVING SIEGEL, JOSEPH TAMARI, GEORGE SELFRIDGE and the Chairman, HAROLD EBERHARDT.

It was noted that on September 29, 1983, the following members of the Committee, comprising a quorum, GEORGE SELFRIDGE, JOSEPH TAMARI and IRVING SIEGEL, met to complete the report and recommend the following changes in the Constitution.

1. Under By-Law 3, page 10, headed "Officers and Their Duties", the addition of a Section 7, headed "Past Presidents".

(a) Past Presidents shall be ex officio members of the Executive Council, without voting privilege.

(b) They shall receive all official correspondence.

(c) They shall be subject to call by the Secretary-General to serve in an advisory capacity or otherwise as needed.

(d) They shall, whenever the need arises, report to the Council individually or collectively, their views on matters of concern to the College.

2. Under Article XXII, page 8, paragraph 6 under Rehabilitation and Appeals Committee should read:

"The Committee shall consist of seven (7) members who shall be the immediately preceding Past Presidents. The Immediate Past President shall automatically become a member of the Committee, replacing the most senior Committee member in terms of service."

The present composition of the Committee is: ERNEST ACUNA '83, DON ALLEN '82, JOSEPH TAMARI '81, GEORGE SELFRIDGE '80, A. GORDON ROWELL '78, SELJI KAWABE '77, J. MURRAY GAVEL '75.

The Secretary General stated the Council should act on the recommendations of the Committee. HAWKINS moved that this report be accepted. SPENCE seconded and the motion passed.

LOFLIN moved and LANKHOF seconded to adjourn the Special Meeting.

## PRESIDENT'S REPORT

President **ACUNA** gave his report in which he told of his travels which included several meetings in the U.S.A. and Mexico as well as participation in ceremonies in the Philippines, Japan, Korea, Taiwan, India and Europe. He also gave presentations on the "National Dental Health Program by the Volunteers of the Mexican Dental Association" at many of these meetings. He recommended that for future growth and fellowship better communications be established between each Section as to their activities. President **ACUNA** expressed regret that he was unable to visit South America during the year.

## SECRETARY GENERAL'S REPORT

The Secretary General reported on his extensive travels during the year including leading a tour to Japan and the People's Republic of China and meeting with Councilman **WONG** and Regent **TSANG** in Hong Kong. He reported on plans for

the meeting of the Executive Council in Canada in April of 1984. A large wooden key which was prepared in Mexico through the efforts of President **ACUNA** and Councilman **CHISIKOVSKY** was presented to the College and shown to all assembled. This key will be used as a backdrop for the College banquets. Fellow and Mrs. **JULIO BARRANCOS MOONEY** of Argentina presented the Council with a green and gold ICD flag. Sec. General **KENWARD** announced the need for more office space as the College has been expanding rapidly. Present membership is now over 6,100, reflecting a 10% increase in the past two years.

### EDITOR'S REPORT

Editor **HAWKINS** reported that the Newsletter had stayed within the Budget this year, but that some USA news would have to be condensed to keep the publications to 70-80 pages. He requested that each Section President submit a page for the next issue.

### TREASURER'S REPORT

Treasurer **KAMAS** reported that the College was financially sound and that the College has borne the total expense of the Roster and Newsletter in 1983 for the first time. Councilman **SELFRIDGE** commented that the Central Office needs to be expanded and that in some areas the dues situation is unfavorable at present and questioned the need for publishing the Roster every two years. Editor **HAWKINS** suggested listing new members in the back of the annual Newsletter.

President-elect **HEIN** moved that we publish the Roster every 3 years; on the interim years we print a supplement of the names of new members in the Newsletter. **ROWELL** seconded and the motion carried.

### DECEASED

Three Past Presidents of the College who died in 1983 were eulogized in a special ceremony: **THEODORE LEE**, 1976; **CYRIL DE VERE GREEN**, 1979; and **GORDON AGNEW**, 1960.

### U.S.A. SECTION REPORT

U.S.A. Section President **HOPKINS** reported on the U.S.A.'s first Continuing Education Conference which was attended by members from 23 states. He announced the next Conference would be in April 1984 in Bethesda, MD, and invited other Sections to attend. He reported on the Audio-Visual project of the U.S.A. Section which would be a "video historical chronicle" on the leaders of the I.C.D. He stressed that Operation Outreach would be continued as many requests for books have been received.

### CONSTITUTION COMMITTEE REPORT

Councilman **SIEGEL** summarized the work of the Constitution Committee in the absence of the Chairman, **HAROLD EBERHARDT**. A Past President's Committee was created to give counsel and advice as needed and to act as a Rehabilitation and Appeals Committee in emergency

situations. These recommendations were approved at the Special Meeting held earlier.

### CANADIAN SECTION REPORT

Councilman **SPENCE** reported that he and the Secretary General would make a site inspection in Montreal in November at which time they would finalize plans for the Executive Council meeting to be held there. Vice President **SPENCE** reported that the scheduled events for the Executive Council meeting in conjunction with the Canada Section meeting are as follows: Friday, April 6, 1984 — the Executive Council meets. Canada President hosts reception. Saturday, April 7, 1984 — Reception for new inductees. Sunday, April 8, 1984 — Reception and black tie induction ceremony. Monday, April 9, 1984 — Canadian Section Board meeting all day.

### EUROPEAN SECTION REPORT

Councilman **LANKHOF** invited all the Fellows of the College to attend the Europe Section meeting in Florence, Italy, May 31-June 2 and extended an invitation to the Council to meet in Amsterdam in 1986.

### OTHER REPORTS AND BUSINESS

The India Section expressed a difficulty in paying \$10 capitation fee per member as that is the total received from each member.

Japan reported that Fellows **MATSUMYA** and **SATO** represented the College at the Federation Dentaire Internationale meeting in Tokyo.

Councilman **ROWELL** reported for the Australasian Section.

College Vice President **GONZALES** reported for President **FELIPE GALVAN** of the Philippine Section and reiterated the Philippine Section's invitation to the Council to meet in Manila in 1986.

Councilman **TAMARI** reported on the Middle East Section and called attention to the fact that there is considerable difficulty in carrying out College activities there. He requested absolution of financial responsibilities until situation is resolved. The Secretary-General stated all should be billed even though they cannot pay at the time.

Treasurer **KAMAS** said a decision about dues needs to be made regarding three Sections of the College — India, South America and the Middle East. Councilman **SELFRIDGE** expressed the feeling that all areas must be treated the same. He recommended the Council continue to maintain the present dues structure and review this on an annual basis.

Councilman **BARRANCOS MOONEY** read his letter requesting a reduction in South American dues for the present because of tremendous inflation there. **SELFRIDGE** moved to maintain the dues structure as it now stands, acknowledging that there are some areas — Middle East, South America and India — that will not be able to meet their obligation now, and review this on an annual basis whereby those countries will have to come to some kind of fiscal settlement to reestablish them as members in good standing. **KERSHAW** seconded the motion which was passed.

Councilman **TAMARI** stated Middle East Section was in state of upheaval and that he has not been able to contact Egypt and Iran and has had no response from Turkey and Sudan. **TAMARI** moved that the Middle East Section be relieved of the financial responsibilities of Iran, Egypt, Turkey and Sudan and that they be returned to the custody of the Council. **ROWELL** added they become a part of the International Section of the College. **HEIN** seconded the motion which passed. The International Section is comprised of Sections 22, 23, 24, 26, 27, 28, 32 and 35 and now numbers 203 Fellows. No action was taken on renumbering or renaming these areas of the College.

South America Section President **BARRANCOS MOONEY** said Brazil had requested autonomy previously and that Section IV approved this action. **MALLERNEE** moved that Brazil become an autonomous Section next year and that the necessary procedures be placed

before the Executive Council in Canada. **ROWELL** seconded, **BARRANCOS MOONEY** agreed, and the motion carried. Secretary General will advise the proposed new autonomous Section as to administrative housekeeping.

President-elect **HEIN** feels the need for an analysis of membership of the College by Section and suggested a mini-convention for the College might be considered with an analysis of the membership tied in with this meeting. Sec. General **KENWARD** said a mini-convention of Canada, Mexico and the United States is under consideration. He informed the Council that the U.S. Section would hold its own mini-convention in July of 1984 in Colorado, and that as Registrar of the U.S.A. Section he would send other Sections information. Fellow **KENWARD** stated that the U.S.A. Section was continuing its Operation Outreach project and that the last collection of books destined for the People's Republic of China was still in storage awaiting shipment on a Chinese vessel. **ALLEN** stated that 35 of 60 U.S. dental schools had agreed to accept foreign dental graduates in advanced educational programs and had indicated what courses are available to them. The

Central Office will prepare a brochure listing the schools and programs and distribute same to Councilmen for schools in their countries.

The Executive Council of the International College of Dentists met in a Special Session in Montreal, Canada, on Friday, April 6, 1984 to consider constitutional changes. President HEIN opened the meeting.

The Secretary General recorded the following Fellows were present: President JOHN W. HEIN, Medfield, MA, U.S.A.; President-elect WILLIAM J. The Constitution Committee Chairman, HAROLD S. EBERHARDT, explained the need for a change in the term of office, Article X, Section 4 of the Constitution. On motion by EBERHARDT, seconded by FORREST, the Section will read:

“The office-bearers shall hold office for a period of one year and shall be eligible for re-election excepting for the office of President and President-elect who shall serve for a period of one year only in each office. Office-bearers shall remain in office until their successors have been

duly elected at the Annual Meeting of the Council. Their Installation Ceremony may be held at the Annual Meeting of the Council but their term of office shall start on January 1st of the following year."

Motion passed with no amendments offered.

Fellow **EBERHARDT** discussed the function of the Rehabilitation and Appeals Committee and that Article XXII reads: "A Standing Committee to be known as the Rehabilitation and Appeals Committee shall be constituted annually.

"It may give: Aid, Counsel, Advice, Assistance and Direction to any College member who is identified as being in need, subject to, or victim of riot, civil unrest, insurrection, or natural disasters.

"When such a College member directly or indirectly appeals to the Central Office, the Secretary General shall refer the information received to the members of the Committee for immediate action with such information also being sent to the Councilman representing the area in question.

"The chairman of the Committee shall inform the Secretary of the Committee's decisions and/or actions and shall report such decisions and/or actions to the next annual session of the Executive Council. This report shall appear as a line item on the Agenda.

"If the Committee Chairman cannot present the report to the Executive Council, he shall appoint another Committee member to do so.

"The Committee shall consist of seven (7) members who shall be the most immediate Past Presidents. The Immediate Past President shall automatically become a member of the Committee, replacing the most senior Committee member in terms of service.

"If the Immediate Past President is unable to serve or a vacancy occurs, the President shall appoint a replacement from the Past Presidents. The President shall appoint the Chairman from among the members of the Committee."

"When funds are available a special fund may be set up to facilitate the actions of this Committee".

Chairman **EBERHARDT** reported that the Constitution Committee would meet again during the Montreal meetings and again in Atlanta in an attempt to re-do the whole Constitution.

On motion by **EBERHARDT**, seconded by **KAMAS**, the Special Session of the Executive Council was terminated.

The Minutes of the Regular Meeting and the Special Meeting held in Anaheim, California on September 30 were approved by mail ballot, and were accepted corrected.

President **HEIN** reported to the College and his report was accepted.

Secretary General **KENWARD'S** report was accepted.

Editor **WILLIAM HAWKINS** gave his report and **DON ALLEN** recommended that an Assistant Editor be appointed in each Section to send information to the Editor, and Fellow **HAWKINS** was asked to send out a directive stating this request.

It was requested to have the Section Editors get printing estimates based on the last Newsletter. This request was made to explore every avenue of cutting the printing costs. **ALLEN** commented that much of the costs are in postage, so savings could only be on printing.

On motion by **HEIN** seconded by **LANKHOF**, it was moved to accept advertising in the Newsletter. Motion defeated. **TAMARI** suggested a "printing sponsor" or series of sponsors who would receive acknowledgement only in the Newsletter. This thought was accepted unanimously.

The Treasurer reported that the College was in good financial condition now but would need a dues increase to continue in the future. He presented the 1985 Budget which was approved.

It was suggested that President **HEIN** appoint an Acting Financial Committee to review the financing and handling of funds in the Central Office and to report to the Executive Committee of the College in Atlanta. **EBERHARDT** so moved, **COLLINGS** seconded, and the motion passed: The Committee is to be composed of Fellows **ACUNA**, **ALLEN**, **KAMAS** and **KENWARD**.

The Rehabilitation & Appeals Committee Report was discussed and President **HEIN**, with President-elect **SPENCE** in agreement, appointed an Acting Committee, with **ERNESTO ACUNA** as Chairman.

Section reports were given by the respective representatives. The USA Section will hold a Mini-convention in Steamboat Springs, Colorado, July 21-23 and members of the Council were invited

to attend.

Fellow **ACUNA** reported for the Mexican Section. He is President of the Mexican Section this year and proposed a meeting in Mexico City after the San Francisco meeting with each Section giving a scientific paper.

Brazil and Argentina have withdrawn their requests for autonomy in view of a new financial arrangement.

All Sections were invited to attend the Europe Section meeting in Florence this year, and Europe's representatives reiterated their invitation to the Council to meet in Amsterdam in 1986.

Secretary General **KENWARD** read the India Section report.

A 30-minute tape of Japan Section 25th Anniversary was shown and a copy of its Silver Jubilee book displayed.

Fellow **WILLIAM THOMPSON** of Canada represented Australasian Section. He reported they only have a Convocation every 3 years and will meet in May of 1985.

The Philippine Section reported that the Federation Dentaire Internationale meeting will be held there in 1986, and hopes the Council will meet there then.

Dr. **TAMARI** reported for the Middle East Section and explained how the Section is operating in times of war. The countries of the Section were recently surveyed for new members. Special reference was made about Kuwait and the indispensability of abiding by the Constitution in recruiting new members from that locality.

Members of the College in Iran, Egypt, Turkey and Sudan had been contacted by the Registrar of the Middle East Section and the Central Office and notified that they were "returned to the custody of the Council". Replies have been received from 6 members in these areas.

Secretary General **KENWARD** read the International Section report. It is now composed of 225 members. Thailand plans to induct 6 and Korea 14 in May of 1984.

The Executive Council will meet in San Francisco, California, November 1, 1985.

It was voted to meet in Amsterdam, Holland in June of 1986.

No decision was reached as to autonomy in Section 22.

President **HEIN'S** recommendation in his report pertaining to the Middle East was discussed. **TAMARI** stressed the outstanding record of his Section and called upon the Council to give the M.E. Section the recognition it deserves. Motion to maintain the M.E. Section as it presently is made by **LANKHOF** and seconded by **FORREST** passed unanimously.

It was decided on motion by **LOFLIN** seconded by **KAMAS** that a 3-tier dues structure be established which would be readjusted every 3 years.

On motion by **EBERHARDT**, seconded by **LOFLIN**, the dues structure of the College was raised to \$15.

President **HEIN** mentioned that the College should consider a Mini-convention somewhat along the lines of that held in the USA for the training of all the officers of the College in every aspect of running the College.

The Secretary General stated that Councilmen were welcome to attend the USA Mini-Convention this July to observe the proceedings.

Councilman **ALLEN** distributed copies of the Advanced Educational Programs in U.S. Dental Schools brochure which had been prepared by the Central Office from information he had gathered while President.

Each representative was asked to take

enough brochures for each Dental School and Dental Association in his territory.

The Central Office will send copies to the American Dental Association and Federation Dentaire Internationale and areas of the International Section.

Fellows **HORIUCHI** and **KAWABE** explained the Ottofy-Okumura Award which was accepted in principal but returned to each Section for their discussion.

The Secretary General is to chair the Awards Committee which is to be composed of two other members appointed by the President.

Representatives were encouraged by Dr. **KENWARD** to gather and ship books to the Philippines, India, South America and Mexico. He reported that many books are awaiting shipment in the U.S.A.

President **HEIN** appointed **ALLEN**, **GONZALES** and **LANKHOF** as observers to the FDI meeting in Helsinki, Finland in 1984.

### NOMINATING COMMITTEE REPORT — ELECTIONS

Fellow **ACUNA** read the report of the Nominating Committee: President — **WILLIAM J. SPENCE** of Canada; President elect — **PRIMO E. GONZALES** of the Philippines; Vice President — **JAMES H. RIDLEN** of Western Springs, IL; Treasurer — **DANIEL C. KAMAS** of Houston, TX; Editor — **WILLIAM E. HAWKINS**, Phoenix, AZ; Secretary General — **FRANKLIN M. KENWARD**, Miami, FL.

**LOFLIN** moved and **LANKHOF** seconded that these be elected and motion passed unanimously that they serve starting January 1, 1985 and complete their term December 31, 1985.

President **HEIN** presented the gavel to President-elect **SPENCE**. The meeting adjourned.



## Introducing William J. Spence

The next President of the International College of Dentists, **WILLIAM J. "BILL" SPENCE**, comes from Canada with a long, impressive history of service to the College and organized dentistry.

**BILL** was born in Toronto, Ontario, Canada, where he received his early education, which included switching from high school to a course of study of art in the Fine Arts at the Ontario College of Art. The results of this training are evidenced by the beautiful paintings adorning the walls of his home and office.

In 1941 he enlisted in the Royal Canadian Air Force in which he served in Europe as a pilot, reaching the rank of Flight Lieutenant before retirement in 1945. During his war service he was influenced by his army dentist to look into a post-war career in dentistry as a worthy outlet for his artistic talents and skills. And so it was on to the University of Toronto School of Dentistry from 1946 to 1951. This was followed by acceptance into Northwestern University, Chicago, for post graduate studies in Orthodontics. During this period he worked with a cleft palate treatment team as an area of special interest. His M.S.D. in Orthodontics was granted in 1953, and his entry into private practice in Toronto took place the same year.

His interest in, and experience gained in cleft palate treatment at Northwestern brought him an invitation from Toronto's famous Hospital for Sick Children to work in their recently inaugurated cleft palate program on a volunteer basis. Work here included research on the prevalence of this type of problem and also the teaching of

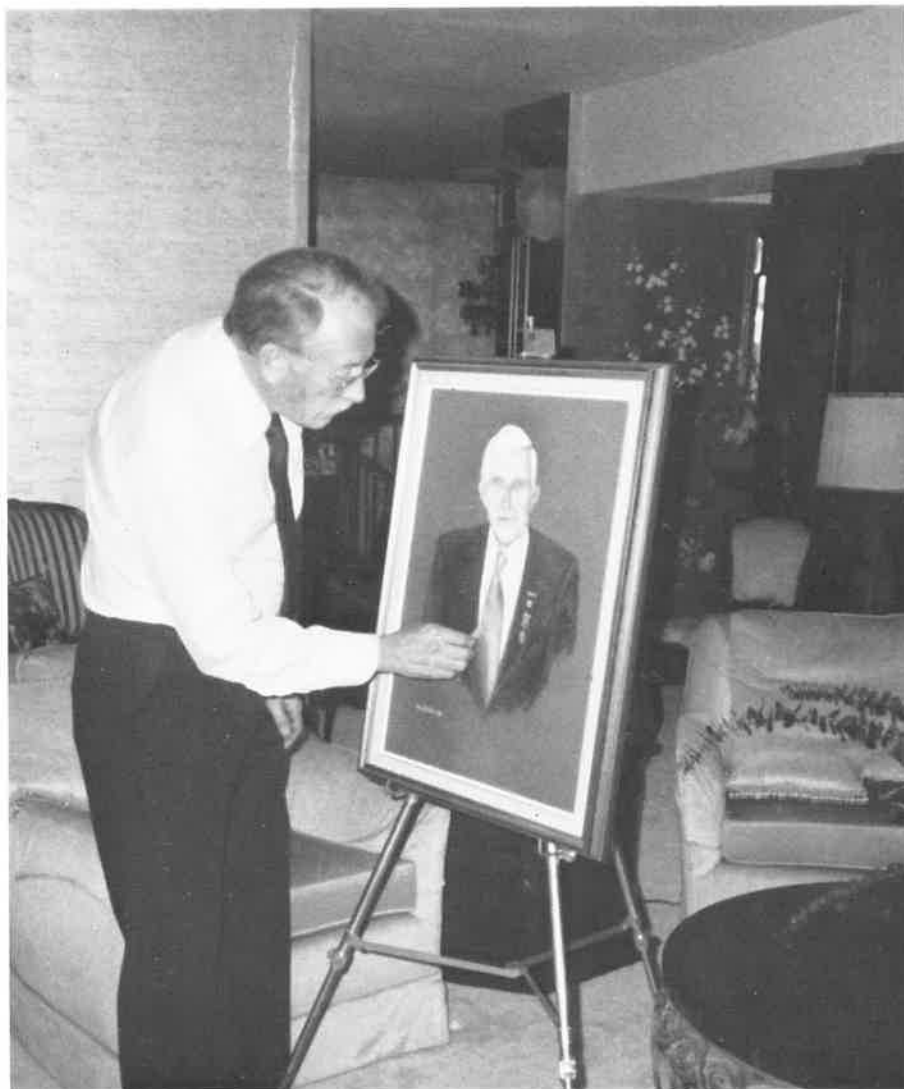

graduate students at the hospital. He also served for a time as Director of the Cleft Palate Institute, and acted as Consultant in Orthodontics on the Faculty of Dentistry, University of Toronto.

In 1961 he became President of the Toronto Orthodontic Study Club.

Along the way **BILL** became interested in dental affairs outside the office and pitched in to help out in organizational work. An interest in insurance for dentists led to his election to the Board of the Canadian Dental Service Plans Incorporated and subsequent attainment of the position of Chairman of the Board. His good works in the Ontario Dental Association led to the presidency of that organization and similarly he went on to the presidency of the Canadian Dental Association.

This was also the year in which he took on the position of Registrar of Section 2 of the International College of Dentists, which position he continues to hold. He has also served as an Executive Councilman of the International College of Dentists from Canada since 1978. Somewhere in all this activity and involvement, time is found for an active orthodontic practice in which he is most ably assisted by his lovely and capable wife **MARGARET**.

In community affairs, **BILL** is an active member of Rotary and of the local Granite Club. He also continues to do professional quality painting and gardening while enjoying something less than professional quality curling and golfing. We know that he brings to the position of President of The International College of Dentists truly professional abilities and qualities which will ensure a successful and productive term of office.

**BILL** was the first President-elect outside of the U.S.A. to be installed as President of the College in his home Section. He will however not assume the Chair of President until January 1985, then serving through December. **BILL** is the fourth Canadian Fellow to become a President of the College.

**W**hile travelling by plane to the Annual meeting of the Canadian Section of the International College of Dentists, held in Vancouver, I found myself with a severe case of butterflies in the stomach. The last time I had such a feeling was at the commencement of my final exams in dental school.

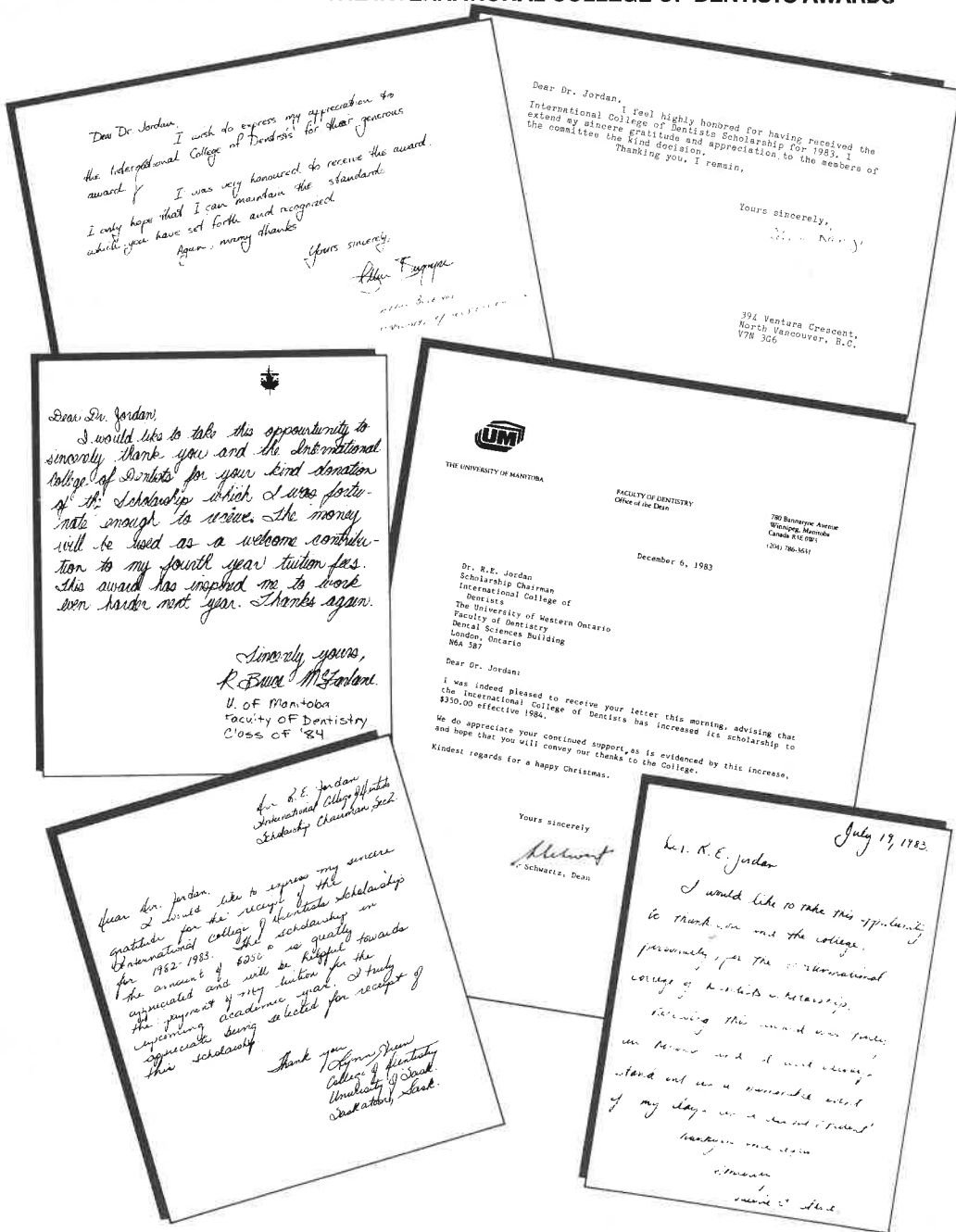

## Board of Regents Meeting, U.S.A. Section

September 29, 1983

It was moved by Regent **KERRIGAN** that the minutes of the 1982 Board Meeting and those of the Executive Committee be accepted as corrected and distributed by mail. Motion passed.

### PRESIDENT'S REPORT

President **HOPKINS** presented his report and stated that he attended 10 separate meetings and functions in 32 days during the year, speaking on College activities. The First Continuing Education Conference took place during his tenure of office. He stated that a comparative look at the projects of other organizations shows how well the U.S.A. Section of the I.C.D. is managed.

### REGISTRAR'S REPORT

The Registrar presented his report and commented that he had travelled extensively throughout the year with approximately 115 days out of the office. His travels included leading a tour of 36 Fellows and spouses to the People's Republic of China and Japan where lectures were presented to dental groups. He also travelled to Germany and Russia and made various visitations in the United States. He told of his experiences in Russia during the 747 crisis and mentioned plans for a trip to South Africa in January. He informed the Board that "Operation Outreach" should be expanded as India, South America, Mexico and the Philippines have requested books, and that the Continuing Education courses should be increased. He recommended a mini-convention be held in July of 1984 and urged the Regents to invite the President of the Section to attend District meetings. He stated that College membership was now 6,048 with 3,889 of those in the U.S.A. Section.

### EDITOR'S REPORT

The Editor reported that the Newsletter was sent to over 6,000 members and that it was funded entirely by the College. He mentioned that to contain cost and bulk, some news must be condensed. The deadline for the 1984 Newsletter is April 15, 1984. The deadline for the U.S.A. Section Letterette is October 31, 1984. He stated that the Journalism Awards were held in Scottsdale, Arizona on April 10, 1983, in conjunction with the A.D.A. Conference on Journalism.

### HONORARY AWARDS COMMITTEE

The Honorary Awards Committee reported that the Convocation Speaker, Dr. **STANLEY McCAFFREY**, President of the University of the Pacific, and Mr. **MASAHIRO KUWATA** of Tokyo, Japan would receive Honorary Fellowship on October 1, and that Fellow **EARL POUND**, of Westlake Village, California, would become a Master in the College.

**CONTINUING EDUCATION**

Continuing Education Chairman **HAWKINS** congratulated Fellows **SELFRIDGE**, **NEWTON** and **LEO S. SHANLEY** on their efforts on behalf of the first Continuing Education Conference held in St. Louis, Missouri, June 24-25, 1983. **HAWKINS** recommended the next conference which will be held in Bethesda, Maryland in April be set up earlier to give members enough lead time.

Fellow **SELFRIDGE** stated the \$1,500 that was given to WUSDM for co-sponsoring the conference would be used for a program to counsel new seniors as to the future in organized dentistry, a program WUSDM will expand to cover other dental schools in Mid-west. Fellow **HAWKINS** moved that this be a project for the Continuing Education Committee. Motion passed.

**INTERNATIONAL RELATIONS**

Fellow **DONALD ERICKSON**, Past President of the College, spoke for the Reverse Flow Scholars Committee. Fellow **CHARLES C. HSIA** of the People's Republic of China had indicated an interest in lecturing in the U.S. Fellow **ERICKSON** said A.D.A. would cooperate with I.C.D. in bringing Fellow **HSIA** to this country with the thought in mind of featuring him at the Atlanta meeting as speaker on "Thirty Years of Dentistry in the People's Republic of China". Fellow **ERICKSON** felt he could also speak in Minnesota and suggested that **WILFRED SPRINGER** could help sponsor him in Rochester where Fellow **HSIA** had studied. Registrar **KENWARD** said **HSIA** is a delightful person and **HERBERT** recommended consideration of him as Convocation speaker for Atlanta meeting.

**HOPKINS** recommended that the ICD contribute to this project. Regent **SAPP** suggested that guidelines be distributed to let host sections know what is expected in hosting **HSIA**. Motion passed.

**P.G. BROCHURE**

A brochure or booklet to be distributed to foreign dental schools and Dental Associations showing where courses are offered to foreign dental graduates in U.S. Schools is to be produced by the Central Office for distribution at the Executive Council meeting in April so that those Councilmen from abroad can arrange for distribution in dental schools in their area. \$500 had been provided for this project in the 1983 Budget.

The computer will be programmed to print out numbers only for evaluation. Percentage of members compared to A.D.A. membership can be identified. The Veteran's Administration personnel should have status as armed forces. A meeting of this committee is recommended for 1984 to determine all criteria for future use so computer can be so programmed. One of the University of the Pacific, School of Dentistry's most illustrious graduates, **HERBERT YEE** was acclaimed as "A Man For All Seasons" when he was named to the University of the Pacific Board of Regents in 1972. To list the varied activities and accomplishments is a daunting undertaking.

He has practiced in Sacramento for 35 years and is a member of Omicron Kappa Upsilon. **HERB** served the dental school as President of the Alumni Association, and as Chairman of the Annual Fund Drive. For eight years he served on

and Past President of the Sacramento County American Cancer Society. He is a 30 year charter member and Past President of Capitol Lions Club and went on to be District Governor of Lions International. **HERB** was an advisor to the Board of Education and Chairman of the Board in the Chinese United Methodist Church, founded in 1866. He is on the Board of the Camellia Festival and the Advisory Board of the California State Railroad Museum.

**HERB** and **INEZ** have been married for 39 years. Their meeting at Stanford University resulted in a union that produced four sons and seven grandchildren. **HERB** enjoys black bass fishing, swimming, antique cars, and shares a love of golfing with **INEZ**. Of their four sons, three are dentists and one is an M.D. **ROBERT**, **DOUGLAS**, and **WESLEY** were inducted as Fellows in 1983 in Anaheim. Their son **ALAN** is a pulmonary internist professor at Loma Linda Medical School.

**HERB'S** great-grandfather was the first of his family to leave Toishan, China in 1850 for the Sacramento Valley to practice medicine. During the Gold Rush in the Mother Lode area of Fiddletown in 1851, he set up Dr. Yee's Herb Store, which can be seen today as a museum. His seven grandchildren are sixth generation Californians, and carry one of the oldest pioneer names of the Sacramento Valley — "**YEE**". **HERB** is the only Asian member to be in the Sacramento Pioneer Association, whose criteria states that the family arrived in Sacramento before 1850. As a prominent longtime resident of Sacramento, **HERB** harbors great community loyalty and pride. He maintains constant ties with the Chinese community, having served as President of the Chinese Benevolent Association, and President of the Yee Family Association. He currently is the Grand President of the Yee Family Association of America, with 30,000 members.

California requires that a citizen be appointed to serve as "Acting Secretary of State" in the event the Secretary of State is unavailable to serve as a result of war or disaster. **HERB YEE** accepted the appointment on June 15, 1983, and the State Senate approved the appointment on July 1, 1983.

**HERB YEE** first entered banking in 1962 as a director of the Bank of Sacramento, which was later purchased by Security Pacific Bank. He then became a director of the National Bank of Agriculture and American National Bank. Currently **HERB**

is Chairman of the Board of Sacramento Valley Bank. He is active in many business endeavors.

Finally, the greatest joy outside of his family and dental practice is the creation of a University of the Pacific Dental Scholarship Fund for deserving dental students. An initial endowment of \$50,000.00 has now grown to \$80,000.00, which annually provides five deserving students \$7,500.00 toward their education.


**HERB YEE** went back to Toishan, China, where he was born, and built an ele-

mentary school which he dedicated in September of 1981. Today 400 students attend the school with 17 teachers. He has returned to China five times to help in education and dentistry.

Truly "A Man For All Seasons", he smiles easily and speaks gently, but never loses sight of his objectives, even in conversation. Possessing both this easy charm and that incredible ability to translate proposals into practice, **HERB YEE** clearly enjoys the work that might have occupied four other men through their lifetimes.

**A Message from Sadakatsu Sato**

**I**t was my utmost pleasure to be able to celebrate the Silver Jubilee of the Japan Section of I.C.D.

We are celebrating the Silver Jubilee of the founding of the I.C.D. Japan Section. We would like to express our sincere appreciation to Fellow **ERNESTO ACUNA E.**, Past President; Fellow **FRANKLIN M. KENWARD**, Secretary-General of the International College of Dentists, Past-Presidents and Regents of the Sections in other countries for sending us cordial greetings on this occasion.

The International College of Dentists was founded in the United States of America in 1930. In April, 1957, Fellow **WILLIAM R. ALSTADT**, who was then President of the American Dental Association, visited Japan. Availing themselves of this opportunity, six Japanese dental leaders, including Fellow **RYUTARO YAMANOUCHI** and Fellow **SEIICHI MATSUMIYA**, gathered together and had a discussion with Fellow **ALSTADT** on the necessity of organizing dental leaders to rouse the enthusiasm for international exchange of knowledge and cooperation and improve friendship among dentists throughout the world. Before World War II, there was only one FICD in Japan, Fellow **TSURUKICHI OKUMURA**. Frequently he spoke about the College and expressed his wish of establishing a branch in Japan. Thus, the six eminent leaders of dental education agreed to carry out their predecessor's will and spread the movement throughout Japan. Twenty-five years have passed since this memorable meeting. The formal recognition as an autonomous section of the I.C.D., however, was bestowed in 1969 after the visit of Fellows **W. R. ALSTADT** and **H. O. WESTERDAHL** to observe our organization setup and management by Fellow **SEIJI KAWABE** and other members.

In the early stage, Japan Section was small in membership and the country's international relationships were not fully recovered. It was the time when we were beset with difficulties. Fortunately, Fellow **YAMANOUCHI** was able to maintain mutual understanding between the headquarters and Section through regular correspondence and improve international friendship and cooperation between Fellows of other Sections.

Also, Fellow **MINORU HORIUCHI**, a detached board member, who is living in Boston, has made a great contribution to the development of the Japan Section.

Furthermore, Japan Section owes its brilliant development to the enthusiasm and dedication of the past-presidents and officers to their duties and the cooperation of each Fellow in Japan.

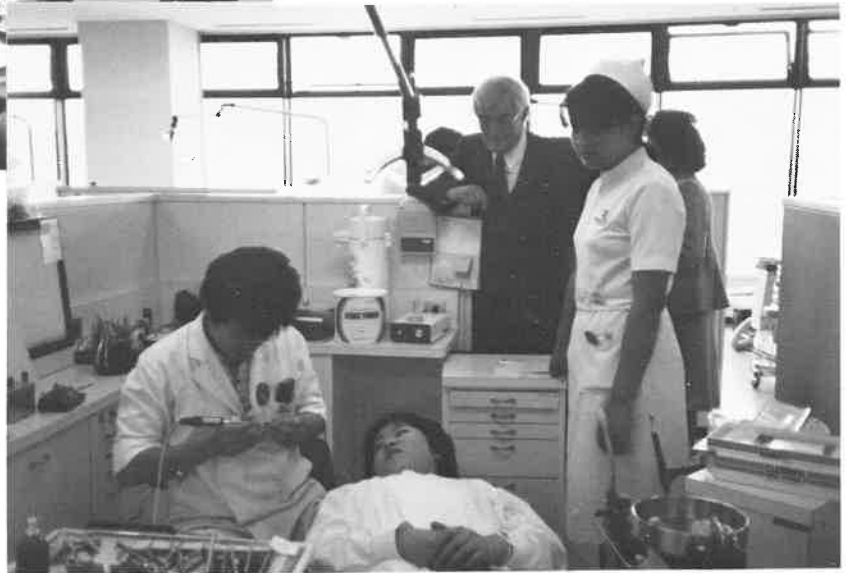

***A Message from K. J. G. Sutherland***

**SOME PERSONAL REFLECTIONS  
ON THE COLLEGE**

One of the many important objectives of the College is "To cultivate and foster cordial relations amongst those engaged in the profession of dentistry and other health professions" and to this end, Fellows of the Australasian Section have been quite active in the twelve months following publication of the last Newsletter.

As was pointed out in the President's Message of a recent local Newsletter, this Section covers an enormous area which extends well beyond the Continent of Australia to the shore of New Zealand, New Guinea and Fiji — an area greater than the mainland of the United States.

Currently there are approximately 170 Fellows in the Australasian Section and because this relatively small number is spread over such a vast area, for economic reasons official meetings of the Board of Regents are held only once a year and those of Fellows in the Section only once every three years in conjunction with the triennial meetings of Australian Dental Congresses.

In these circumstances therefore, apart from the honour accompanying an invitation to Fellowship in the College and the consequent entitlement for the Fellow to use the letters F.I.C.D. after his name, association with this renowned, world-wide dental organization can have little meaning and the sense of "belonging" runs a real risk of becoming considerably diluted, if like friendship, it is not constantly nourished.

In recognition of this, steps have been taken recently to activate the College on the home scene and Regents representing the larger districts in terms of numbers have been asked to arrange "informal" meetings of Fellows to be held at least annually in five of the capital cities of Australia and in Auckland, New Zealand.

Thanks to **A. GORDON ROWELL**, a most vigorous former President, both of the Australasian Section and the College itself, the State of New South Wales in Australia, has been active in this regard for some considerable time, but regrettably the same cannot be said of the other States — due no doubt to the relatively

few Fellows in them until comparatively recent times.

Following the tradition set by New South Wales, I have recommended that these district meetings take the form of dinners to which wives are invited together with a guest speaker who need not necessarily be a dentist, but who profitably could be a member of another health profession, thus helping to fulfill this important College objective.

It is very gratifying to report that the challenge has been actively taken up and since October, meetings have been held in Perth, Adelaide, Melbourne and Brisbane with myself as President attending each one. Furthermore, the New Zealand Fellows are planning a meeting in conjunction with the New Zealand Dental Association Biennial Scientific Meeting to be held in Auckland in August this year, which again I shall have the pleasure of attending.

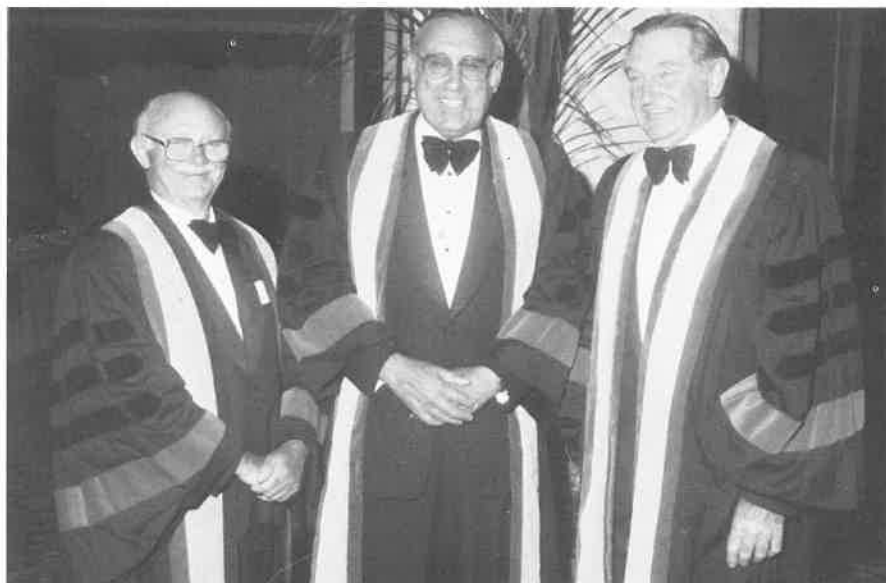
Whilst these meetings are essentially of a social nature, sight is not lost of the importance of periodically holding Scientific meetings in addition. Again however, small numbers in each of the districts pose a problem and together with the ever-increasing number of

Scientific meeting held annually this sometimes causes even some of the most dedicated members of the profession to sigh "Oh, not another meeting!"

One method of overcoming this difficulty is to endeavor to arrange for the larger organizations to invite members of the smaller ones to their Scientific meetings. With mutual consent and with some diplomacy, neither body need lose its identity and a much more lively and fruitful meeting can follow because of its enhanced size and a greater admixture of interests. This principle of course has its best application to small districts where membership of the various organizations is correspondingly reduced.

This suggestion has been successfully implemented recently in Western Australia where arrangements have been made for Western Australia Fellows of the International College of Dentists to be invited to attend the forthcoming Annual Scientific meeting being organized by the Regional Committee of the Royal Australasian College of Dental Surgeons. There are only 36 members of the latter, but with the addition of Fellows of the International College of

Dentists who are not also Fellows of the Royal Australasian College of Dental Surgeons the number is enhanced by 10 - certainly by only 25%, but a quarter of a loaf of bread is better than no bread at all - especially when it is to everyone's benefit.

Whilst in no way denegrating the importance of a regular scientific exchange of knowledge, in a rapidly changing world with its vicissitudes and constant pressures on individuals to encompass an ever-enlarging parameter of activities, sight can easily be lost of a much more fundamental quality - that of the significance of Fellowship within the College.

After all, we are all Fellows of an International Dental Organization, but it is easy for the real meaning of Fellowship to be lost, and never was this more strongly brought home to me than at the recent Perth meeting of the Section. Following an excellent dinner and an interesting sound film of a recent trip to China, letters and comments received after the meeting highlighted more than anything - not so much the quality of the meal or the fascination of modern China as captured on the film - but the pleasure experienced by Fellows and their wives meeting with each other in such convivial circumstances. By nature and by profession, dentists tend to be islands and occasions such as these afford them an opportunity of breaking away from their office confines and joining their colleagues with whom they have so much in common.

In another contest I am reminded of a clergyman friend, who because of his calling in life might have been expected to recite a complicated Latin Grace before commencing his family meal, but who instead uses the following simple words, "For food and good Fellowship, Lord we thank you".

And this is exactly what our College dinners in Australasia have been all about; for what is good food without good fellowship and indeed what is the world? And if all the professional associations, businesses, political, sporting, social and other organizations down to single individuals in all nations both great and small could meet each other in this true spirit of Fellowship, then, "The common sense of most would hold a fretful 'world' in awe, And the kindly earth would slumber, lapt in universal law".

After graduating B.D.S. at Sydney University in 1934 he obtained his D.D.S. at Northwestern University in 1936 (Syd) 1947, F.D.S.R.C.S. (Eng) 1968, F.R.A.C.D.S. 1965, F.A.C.D. 1965, F.I.C.D. 1962.

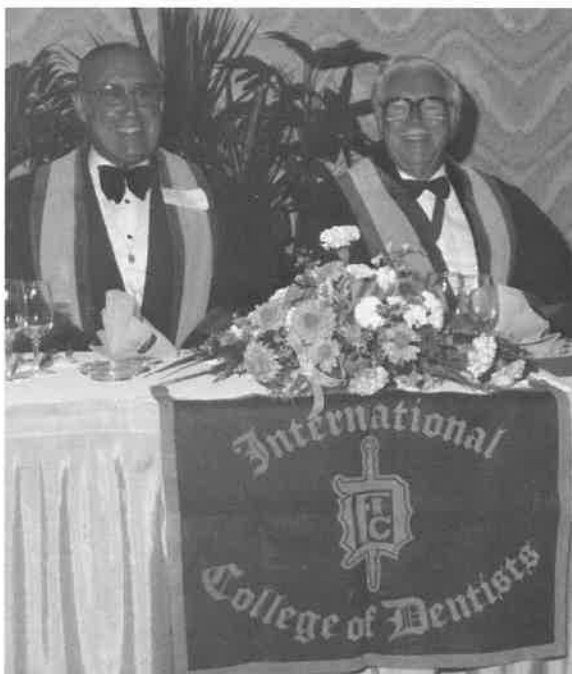
Space is insufficient to detail all of **GOR-**

**PICD DENTAL HEALTH  
FOUNDATION**

*The community service arm of the ICD Philippine Section . . . a private sector's partnership with government in its vigorous campaign to improve the quality of life of its people through good dental health.*

Establishment of the Foundation came upon the realization that government efforts alone will prove futile in resolving the burgeoning dental health problems amid a population explosion and declining dentist to population ratio. Involvement of the private sector becomes imperative, in fact, inevitable.

The response from ICD Philippine Section was organization of this community service group which will put into action a commitment to meet the challenge of an escalating dental problem - dental caries and periodontal disease. It was organized in 1974 as the B.B. Erana Memorial Foundation to honor the late **BIENVENIDO B. ERANA**, ICD's distinguished Fellow, Master, ICD Philippine Section President for several terms, President of the ICD - At Large, Vice-President of the Federation Dentaire Internationale, and President of the Asian-Pacific Dental Federation. In 1978, it was renamed the PICD Dental Health Foundation to reflect the late **TOTI ERANA'S** depth and breadth of vision in organized dentistry.

In order to immediately put into effect the aims of the B.B. Erana Memorial Foundation, a fund campaign was launched and raised sufficient funds to support two standing projects, the B.B.

Erana Achievement Award to recognize conspicuous community service by dentists; and the B.B. Erana Scholarship Award to help develop an orientation toward preventive dentistry in dental practice.

ICD Philippine Section, through the invigorated PICD Dental Health Foundation, Inc. now turns outward into its bigger public, 20 million Filipino children by embarking on an ambitious undertaking, "Project Smile." Initial activities under this project are "Smile Puppet Show" and the "Self-Applied Fluoride (SAF) Program."

Major cooperators in "Project Smile" are the Philippine Refining Company, Institute of Public Health of the University of the Philippines System, and the National Media Production Center. ICD Philippine Section, through this Newsletter, wishes to extend the heartfelt thanks of the Foundation's Board of Trustees, joined by the officers and Fellows, and most importantly, the millions of Filipino children who will reap the rewards of an investment in good dental health made possible by the generosity of our esteemed contributors and supports of the then B.B. Erana Memorial Foundation.

**Report from Pakistan**

A Symposium on Role of Preventive Dentistry was held the 6th of January, 1984 at Lahore Hilton, under the auspices of International College of Dentists and Pakistan Dental Association, presided over by Dr. **KHAIRAT MOHAMMED IBNE-RASA**, Vice-Chancellor, University of Punjab. Brig. **MANZOOR MALIK**, Secretary Health, Govt. of Punjab, and Federal Minister for Health & Social Welfare, Dr. **NASIR-UD-DINKHAN JOGEZAI** were honored guests.

Regent **M. A. SOOFI**, for Section 24, Pakistan, Afghanistan and Bangladesh, urged the need of the introduction of Preventive Dentistry in Pakistan. He said that almost 95% of population, both in the rural and urban areas, are suffering from periodontal diseases and other disorders. Therefore, a preventive network may be used to save the population from the dental diseases. He said that a two year course for dental hygienists may be developed in order to provide more dental health workers for the rural areas and for dental clinics working under the control of Punjab Government.

He urged the Post-graduate training of the Dentists in Preventive Dentistry and requested the College of Physicians and Surgeons of Pakistan Authorities for introduction of FCPS diploma course in preventive dentistry. Fellow **SOOFI**, in his capacity as the President of Pakistan Dental Association also urged the University of Punjab to allow the dental graduates to join the M. Phil Community Medicine (Community Dentistry) at College of Community Medicine, Lahore and requested to Government for Diploma Course in Public Dentistry. Fellow **SOOFI** also demanded equal status and complete integration of the dental profession to the medical profession and asked the Government that there should be a post of Deputy Director of Dental Health Services at the Provincial and Federal level to aid dentists in rendering services in the public interest. He said that the reserved places for the children of Medical Doctors in the Medical Colleges may be equally given to the children of dentists.

Brig. **MANZOOR MALIK**, Secretary of Health, Government of Punjab, assured

the Dentists all the possible assistance and help and equal opportunities and status. He said the government is taking keen interest in public dentistry and has created a full fledged post of Professor in the Dental Department at the College of Community Medicine. A two year course for Dental Hygienists has been started at the same College, and there are 98 sanctioned posts for Dental Surgeons at various clinics. Tehsil Headquarter Hospitals in the Punjab and the Government is planning to create a post of Deputy Director. He said that the Government shall examine the proposed 5 year course of BDS instead of 4 years.

Dr. **NASIR-UD-DIN KHAN JOGEZAI**, Federal Minister for Health and Social Welfare, Government of Pakistan, said that the Government is taking keen interest in the dental science in the

country and the next 5th year plan will have given dentistry more importance. He said the Government has already introduced the ordinance for practice of medicine and dentistry by qualified persons, thereby giving equal status for the professions.

Dr. **KHAIRAT MUHAMMED IBNE-RASA**, Vice Chancellor of Punjab University also appreciated the efforts of the International College of Dentists for the promotion and cause of the Dentistry. He also stressed the need of Preventive Dentistry in Pakistan and public health education. He assured that the University shall provide all possible help to the Dentists for Post-graduate study.

The dinner and symposium was attended by the Fellows of International College of Dentists, Dental Surgeons of various Districts, Tehsil, and members of the medical profession.

**Thailand News**

Chulalongkorn University School of Dentistry is the oldest University in Thailand. The School of Dentistry began as an undergraduate program in 1940. The D.D.S. program is six years in length, consisting of 230 credits with 80 dental students in each class.

Postgraduate students in Endodontics, Periodontics, Prosthetics, Surgery, etc., require 12 months to obtain a certificate.

For a Masters degree, the only program available at the present time is in Orthodontics which started in 1979. This program requires two to five years and there are three to five participants in each group. If there are any deficiencies in the Clinic, research, or any class work, the participant must spend additional time to meet the requirements of the Graduate School.

This is a brief overview of the dental training in Thailand as of 1984.

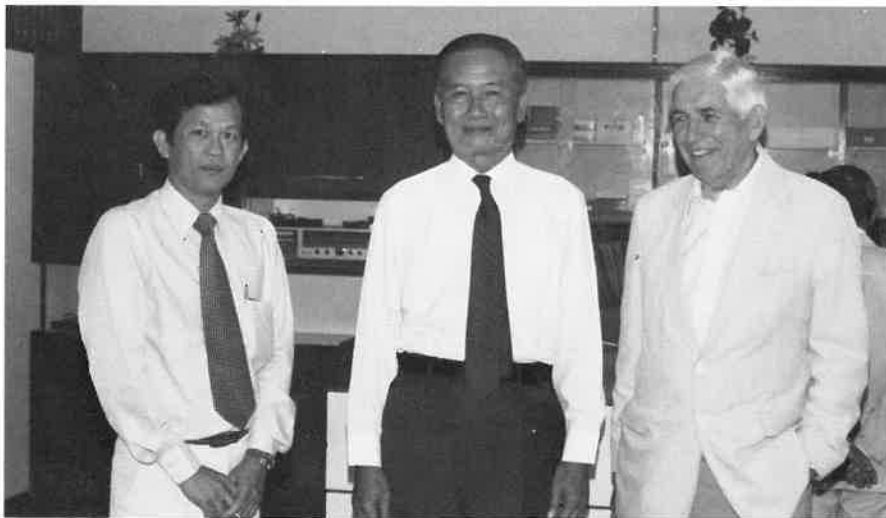
