We **strongly** encourage you to secure your hotel reservation in our **ICD group block** at the Sheraton New Orleans Hotel through the ADA Housing Bureau Experient, as soon as possible. - Click on Registration.
- Planning to register more than one person? Additional registrants option is on the Registration Summary page at the end of the process.
- AVOID clicking the Back button during the registration process. Doing so requires you to start the process over from the beginning.
- Type our Group Code: ICDNOLA (all caps) in the Group Code box, then click "Apply Group Code".
- Click on "Register Now." Under Registration Categories, choose appropriate category.
- "Fill in required information in 1) Dentist Lookup, then click on "Find Me". Verify/fill out your Profile including the question(s) below your email address, then click "Next". Verify Address Confirmation, then click "Next".
- Click RADA US ADA Member or Housing only, Click Here to accept, then click "Next".

- In Room Search, "Select" our hotel at top of list, Sheraton New Orleans (500 Canal St), and choose arrival and departure dates. If the block fills, you will see "Sold Out", but if rooms are still available for attendees outside the block, you will be able to select a room at our hotel in the alpha listing.
