The Board of Regents met in Las Vegas this past October. I am very excited to tell you about a project that was approved at this meeting. It is called the **Fisher House Project**. It is part of the ICD-USA Section's Humanitarian Outreach. The project is slated to be rolled out January 2012. Fisher House is a place where families of wounded soldiers are housed to be near their loved one as he or she is recovering from their injuries or illnesses. The ICD is partnering with the Fisher House directors to offer **pro bono emergency** dental care to anyone in the families who find themselves in need during their stay at the Fisher House. Our district will play a very large role in this project because District 4 is home to five Fisher Houses, one in Delaware, one in Washington, DC and three in the state of Maryland. The Deputy Regents of these areas will be asking for ICD Fellows to volunteer their services for this worthwhile project in the next few months. Volunteer today....make a difference!

In keeping with our international focus the Board of Regents also approved the **International Collaborative Initiative.** There are three components of this Initiative: (1) The International Student Exchange (NJ and MD are currently participating in this program), (2) the Global Student Health Associations, which are clubs for students interested in international volunteer activities, and (3) the newly formed ADA Humanitarian Liaison project which hopes to encourage and promote international volunteer projects for ICD Fellows. Committees have been formed and are working diligently to expand these projects. Funding of these projects remains a strong emphasis for our contributions to the ICD-USA Section Foundation.

District 4 congratulates Dr. Michael Kenney (MD) as he assumes the position of ICD-USA Section President in January 2012. Mike served with distinction as District 4 Regent from 2006-2010. We are very proud of him, and we wish Mike well as he begins this endeavor.

Navy establishes Joint 3D Medical Applications Center (3D MAC)

As a result of the Base realignment and Closure (BRAC), the 3D Medical Applications Center (3D MAC) was established as part of the Radiology Department on the Walter Reed National Military Medical Center, Bethesda (WRNMMC-B) complex. 3D MAC provides a wide variety of advanced digital technology services to Army, Navy, Air Force, and Veterans Administration medical facilities as well as other federal agencies for anatomical models, virtual surgical planning, custom implants, and research. Although presently services are requested directly and are limited, a world wide website is expected to be available to access education on the use of Advanced digital technologies, and to order services sometime in the spring 2012.

3D MAC is a state-of-the-art facility for virtual planning and rapid prototyping, providing services in Steriolithography, 3D printing, and additive manufacturing of Titanium in support of anatomical models, surgical guides, and custom craniofacial and orthopedic implants in support of Wounded Warrior Care. The Chief of Service is CAPT Gerald Grant, USN, a Maxillofacial Prosthodontist, who directs the vision, mission, and daily activity of the team of biomedical engineers, industrial engineers, and CT technicians. He also leads an ambitious research team in craniofacial imaging, virtual surgical techniques, and custom implant fabrication. This research is primarily on capture of craniofacial images for the DoD, but has partnerships with the FBI for forensic identification, John's Hopkins Medical Center for facial transplants, as well as material studies in titanium and silicon with both domestic and foreign Universities.

3DMAC along with the Naval Postgraduate Dental School's Maxillofacial Prosthetics Officer and technician training programs, work together to produce the cranial implants from both PMMA and Titanium that is used in the reconstruction of our Wounded Warriors. In addition, maxillofacial prosthetic Officer and technicians will begin to work along with the engineers of the 3D MAC in the use of virtual modeling software to provide the files needed to produce anatomical models and surgical guides.


