Core Values Statement Adopted

The following statement of core values was adopted by the Board of Regents at the annual meeting of the USA Section of the ICD this past October in San Antonio:

CORE VALUES AND GUIDING PRINCIPLES REGARDING RESPECT FOR THE INDIVIDUAL

The USA Section of the International College of Dentists (“ICD-USA”) believes in treating all individuals with dignity and respect, regardless of race, color, gender, age, marital status, genetic information, national origin, religion, sexual orientation, disability, or any other classification protected by law that is applicable to the ICD-USA. Diversity in backgrounds, experiences and perspectives enriches our lives and enhances the quality of our fellowship.

In keeping with our philosophy that “Together we can accomplish more than we could as individuals,” our commitment is to foster a culture among our Fellows that

is not only free of harassment and discrimination – as outlined in the organization’s Employment Policy & Procedure Handbook applicable to the ICD-USA’s employment practices – but also supports and encourages inclusiveness, so that all of our Fellows recognize that they are respected and valued.

We expect all of our Fellows – including those who serve in leadership positions, such as the Board of Regents or Vice Regents, Executive Committee, and College Committees – to strictly adhere to these core values and guiding principles at all times, including when:

- * *Nominating and selecting new Fellows;*
- * *Making employment-related decisions for the ICD-USA;*
- * *Communicating with other ICD Fellows, whether verbally, in writing, or electronically;*
- * *Communicating as an ICD-USA representative with parties outside ICD-USA; and*
- * *Otherwise acting as a representative of ICD-USA.*

Failure to adhere to these principles may be grounds for disciplinary action pursuant to Article XVI of the By-Laws.

CONTINUING EDUCATION CONFERENCE TO BE IN BALTIMORE

THE 26TH ICD CONTINUING EDUCATION CONFERENCE WILL BE HELD IN BALTIMORE, MARYLAND ON APRIL 19-20, 2009 FOLLOWING THE BOARD OF REGENTS MEETING.

The conference will be at the Marriott Waterfront Hotel, which is adjacent to the Inner Harbor and many fine restaurants and attractions. A welcoming cocktail party and registration will be held on Saturday, April 18.

A most timely lecture series with outstanding clinicians is scheduled for Sunday and Monday mornings. Dr. Robert Ord, the Chair of Oral and Maxillofacial Surgery at the University of Maryland and a distinguished cancer surgeon, will address “*Changing Demographics of Oral Cancer and Oral Screening in the Dental Office.*” Dr. Robert Taft, Dean of the Naval Postgraduate Dental School, and Dr. Gerald Grant will lecture on “*Maxillofacial Prosthetic Support for the Wounded Warrior; Past, Present, and Future.*”

On Monday, Dr. Christian Stohler, Dean of the University of Maryland Dental School, will give a presentation on “*Dentistry and Dental Education - The Best Is Yet to Come.*” Dr. Michael Belenky will present on the “*International Student Exchange: Global Pathway to the Future.*” Dr. Belenky is the Chair of Global Dentistry at the University of Maryland.

Dr. Harold Crosley will lecture on “*The 25 Most Prescribed Medications and their Dental Implications.*” Dr. Crosley is both a dentist and a pharmacologist, who lectures extensively throughout the US and abroad.

The Fellows, spouses, and guests will visit the National Dental Museum on Sunday afternoon. This will be followed by a tour of the very new and state-of-the-art dental school at the University of Maryland. A reception and dinner will follow at the beautiful atrium of the dental school. Monday afternoon will be free so that everyone can enjoy the many opportunities available in the Inner Harbor area and the surrounding city.

The Post Trip will be from Tuesday, April 21

to Friday, April 24 and will be headquartered at the very exquisite Gaylord National Resort on the Potomac. This is a magnificent and most interesting property accessible to Old Town Alexandria via water taxi and upscale shopping and restaurants.

On Tuesday, April 21 there will be a tour of Washington, DC and its many memorials. Lunch will be at the historic Hillwood Estates and Gardens, the home of the late Marjorie Merriweather Post. There will be time to tour the grounds, mansion and art galleries.

On Wednesday, April 22 we will have a VIP tour of the US Naval Academy and Annapolis. On Thursday, April 23 we will complete our tour of Washington with a visit to the Newseum and other attractions. The Newseum was opened in 2008 and is very popular. The Post Trip will conclude on Friday with transportation provided to BWI and back to Baltimore.


Did You Know?

College Lessens Tie to Section

From the beginning there has been a very close relationship between the USA Section and the ICD College-at-Large. The Secretary General of the College and the Registrar of the USA Section has always been the same person. And, because of this, the physical facility, or Central Office, of the Section has also been the Central Office of the College. That is the way it is now. Retired Brigadier General Robert E. Brady serves as both the Section Registrar and the College Secretary General.

But all that is about to change. At the November, 2007 College-at-Large meeting, the officers and international councilors agreed to loosen the ties that have closely bound the

Section and College. The Secretary General and the USA Section Registrar will no longer be the same person. The College also wishes to have its own office space, preferably close to the Section office for mutual support.

Dr. Brady is scheduled to retire from his position on December 31, 2009. He will be replaced by two people. Retired Rear Admiral Carol I Turner of Vienna, Virginia has agreed to serve the Section as our new Registrar. The College plans to replace the Secretary General position with a full-time Central Office Administrator and a part-time Secretary General. They are now seeking qualified applicants for these positions.
