I have the utmost confidence that the Foundation will continue to grow and flourish under the energetic, innovative leadership of Dr. Kenney. Mike has an outstanding Board to work with, and I foresee only positive things in the future.

In conclusion, the USA Section of the ICD is a dynamic and progressive entity. Buoyed by our core values of **Integrity, Leadership, and Service**, I am confident that we will continue to ascend in harmony with the goals and objectives we have established.

Once again we thank you for all you do for the International College of Dentists, the profession, and humanity.

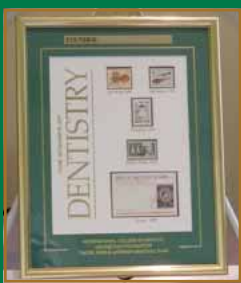

- Obturation: State of the art, centrally condensed gutta-percha technologies vs. single-cone techniques.



SPEAKER: Diwakar Kinra, DDS, MS, FICD

Dr. Diwakar Kinra received his dental degree from the University of Michigan School of Dentistry in 1999. In 2002 he obtained his masters degree in endodontics at the University of Detroit-Mercy School of Dentistry. In 2004, after the completion of his postgraduate degree, he immediately returned home to begin his solo private practice limited to endodontics in Flint, Michigan.

Dr. Kinra is an Adjunct Professor of Graduate Endodontics and Graduate Periodontics at the University of Detroit-Mercy School of Dentistry. He is a member of the AAE, MAE, ADA, MDA and GDDS dental societies. He also serves as the committee chair for the ADA: Committee on the New Dentist.

Dr. Kinra has spoken on clinical endodontics and practice management since 2005. He has spoken at over 20 universities domestically and internationally. His clinical lectures focus on Cleaning, Shaping, and Packing of the root canal system.

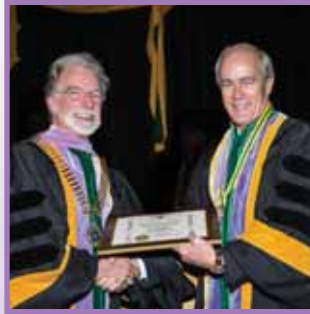

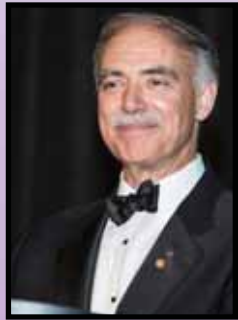

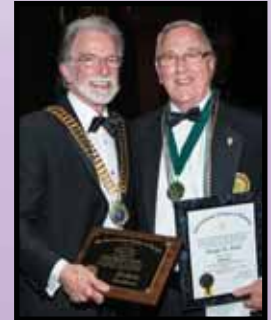
